- Notice is hereby given that the following applications have been made in respect of the goods advertised in the Schedule to this 1 notice. Any person wishing to lodge an objection must do so in writing, to the Ministry of Commerce, PO Box 1473, Wellington, Fax (04) 473-8949 indicated by the reference number, before 5th April 1993. All submissions must include:
 - the Tariff Industry Assistance (Advertisement) Notice number;
 - the Tariff item; and
 - Reference number.

All submissions from local manufacturers must include:

- the range of alternative goods made locally;
- the grounds on which objection is made (including reasons why the local product is a suitable alternative); present and potential output;
- details of factory cost in terms of materials, labour, overheads, including the proportion of domestic and imported content.
 All submissions objecting to a request for the withdrawal of a concession must include:
 - reasons why the local product on which protection is sought is not a suitable alternative;
- full technical details of the goods against which tariff protection is sought.
- Where further information is required in order to make a submission an objector should contact the applicant in writing and refer a copy of the enquiry to the Ministry of Commerce quoting the details in paragraph 1 above 5
- Any submission not supported by the information required in the paragraphs above will be considered invalid.

I, Vincent Anthony Manks, Executive Officer, Ministry of Commerce, acting pursuant to section 8 of the Tariff Act 1988 under delegated authority hereby:
