## Authorities and Other Agencies of State

### New Zealand Wool Board

#### Wool Industry Act 1977

#### Export Certification

##### Preamble

This direction on "Export Certification" is made by the New Zealand Wool Board (the "Board") pursuant to its authority contained in section 21 (1) of the Wool Industry Act 1977 (the "Act").

Notice of this direction is being given as required by section 21 (5) of the Act. The direction may be amended from time to time and any such amendments will be published in the *New Zealand Gazette* or as otherwise provided for by section 21 of the Act.

##### Objective

The objective of this direction is to ensure that all wool exported from New Zealand has available certified or certifiable test results (as specified below) covering the tests herein detailed.

##### Scope

The Board hereby directs that from 1 September 1993, all export wool consignments must have available certified or certifiable results covering the following tests.

- Scoured Wool. Scoured wool must have available certified results covering International Wool Textile Organisation (IWTO) 19, 28 and 33. This is the standard scoured wool package covering wool base, yield, vegetable matter, fibre diameter and condition, and also includes as additional information colour (IWTO (E)-14) and residual grease.
- Greasy Wool. Greasy wool must have available certified or certifiable test results covering IWTO 19 and 28 covering wool base, yield, vegetable matter, fibre diameter and as additional information colour (IWTO (E)-14).
- Slipe Wool. Slipe wool must have available certified results covering IWTO 19 and 28 covering wool base, yield, vegetable matter, fibre diameter and as additional information colour (IWTO (E)-14).

##### Compliance Option

- The measurement of fibre diameter by projection microscope (IWTO-8) will be acceptable as an alternative to mean fibre diameter by airflow (IWTO-28) for scoured, greasy and slipe wool.
- The measurement of colour to NZS 8707 will be acceptable as an alternative to IWTO (E)-14.

##### Exemptions

The following will be exempt from this direction.

- Individual Bill of Lading consignments less than 1,000 kg actual.
- Wool that is black or predominantly black or coloured due to natural melanin pigmentation.

##### Enforcement

- From 1 September 1993, and pursuant to section 23 (2) of the Act, it will be a condition of every export licence already granted by the Board that all wool consignments exported from New Zealand must have been tested and have available certified or certifiable results in accordance with this direction. It will also be a condition of export licences granted by the Board in the future, pursuant to section 22 (2) (b) of the Act. In addition, the Board will require each licensed wool exporter to sign a declaration along the following lines which will be incorporated into the document entitled "Declaration by Licensed Wool Exporter",

"All wool covered by this entry has available a test certificate(s) and/or certifiable results for the tests specified by the New Zealand Wool Board pursuant to section 21 of the Wool Industry Act 1977 and published by notice in the *Gazette* from time to time".

##### Audit Option

##### Either

- A. The "Declaration by Licensed Wool Exporter" document will also require the relevant test certificate numbers to be provided on the document or on an accompanying page. If the test certificate numbers are not available at the time the Export Entry and Export Declaration is submitted to the Customs Department, the licensed wool exporter will forward the Test Certificate numbers, referencing the Export Entry Number and date, direct to the Distribution and Transport Section of the New Zealand Wool Board, within 14 days of the lodgement of the Customs Entry;

or

- B. The Board requires each licensed wool exporter to complete an annual "Statutory Declaration", in a form prescribed by the Board, confirming that the test certificates or certifiable results relating to all wool covered by export entries for the next 12 months will be made available to the Board or the Board's nominated representative when required for compliance audit purposes. The original "Statutory Declaration" shall be forwarded to the Board within 7 days of signing and no later than 30 September 1993 and thereafter no later than 1 August each year.

## Transit New Zealand

### Transit New Zealand Act 1989

#### Bylaw Regulating Roadside Vendors on State Highways

Pursuant to section 61 (3) of the Transit New Zealand Act 1989, Transit New Zealand hereby makes the following bylaw.

#### Bylaw

**1. Title and commencement**—This bylaw may be cited as the Transit New Zealand (Roadside Vendors) Bylaw 1993/2 and shall come into force on the 14th day of August 1993.

**2. Interpretation**—In this bylaw, unless the context otherwise requires,—

“Carriageway” means the sealed part of the State highway;

“Hours of darkness” means:

(a) Any period of time between half an hour before sunset on one day and half an hour after sunrise on the next day; or

(b) Any other time when there is not sufficient daylight to render clearly visible a person or vehicle at a distance of 250 m:

“Licenced roadside vendor” means a person who offers or exposes for sale or distribution any goods or services whatsoever by means of a mobile shop and who holds a current licence in the form set out in the First Schedule to this bylaw:

“Mobile shop” means:

(a) Any motor vehicle; or

(b) Any motor vehicle and connected trailer that is capable of moving under its own power from the area of operation at all times during operation, and used for the purpose of offering or exposing for sale or distribution any goods or services whatsoever:

“State highway” includes a motorway:

“Transit” means the Transit New Zealand Authority established under section 4 of the Transit New Zealand Act 1989:

“Vehicle” has the same meaning as in section 2 of the Transport Act 1962.

**3. Application**—(1) Subject to subclause (2) of this clause, this bylaw applies in respect of State highways throughout New Zealand.

(2) This bylaw does not apply in any area where a 50 km/h vehicle speed limit applies unless the local authority responsible for that area resolves to adopt this bylaw as its bylaw for application to that area and Transit has delegated responsibility for that area under section 62 of the Transit New Zealand Act 1989.

(3) Where this bylaw applies to a 50 km/h vehicle speed limit area pursuant to subclause (2) of this clause, all references to Transit shall be deemed to be a reference to the local authority which has adopted this bylaw in respect of that area.

**4. Roadside vendors prohibited unless licenced**—No person other than a licenced roadside vendor may offer or expose for sale or distribution on any State highway any goods or services whatsoever.

**5. Licencing of roadside vendors**—(1) Any person who wishes to operate a mobile shop on any State highway may apply for, and Transit may grant, a licence to operate as a licenced roadside vendor.

(2) In deciding whether to grant a licence under subclause (1) of this clause, Transit shall consider whether the operation of the mobile shop—

(a) Is likely to detrimentally affect, in a material way, public safety; and

(b) Is likely to detrimentally affect, in a material way, the efficiency of that part of the State highway on which the mobile shop is located.

(3) In considering whether to grant a licence under subclause (1) of this clause, Transit may in its discretion consider any report submitted in that regard by the Police, any relevant territorial authority, or any employee of Transit.

(4) Where Transit is considering refusing approval, it shall give the applicant an opportunity to—

(a) Place facts relevant to the matters listed in subclause (2) of this clause before Transit for consideration; and

(b) Comment on any report received under subclause (3) of this clause in respect of the application.

(5) Transit shall record its decisions in writing, and where a licence is not granted it shall give reasons to the applicant.

(6) Every licence issued under this bylaw shall be in the form set out in the First Schedule of this bylaw, or such other form as Transit may prescribe from time to time.

**6. Licence Fee**—(1) The applicant shall pay a licence fee to Transit for each licence issued by Transit to the applicant of—

(a) \$475 where the term of the licence is greater than 6 months; or

(b) \$325 where the term of the licence is 6 months or less.

(2) Where an applicant has previously held a licence within the previous 6 months of the application and the details set out in Schedule A of that licence are or will be the same as the details (except in respect of the term of the licence) set out in Schedule A of the licence to be issued to the applicant,—

(a) A licence fee of \$300 shall be payable where the licence fee is for a term greater than 6 months:

(b) A licence fee of \$200 shall be payable where the licence is for a term of 6 months or less.

(3) All amounts specified in this clause include goods and services tax.

**7. Term of licence**—(1) No licence shall be issued for a term of more than 12 months.

(2) Unless otherwise specified in the licence issued under this bylaw, the licence shall remain valid until—

(a) The licensee has committed a breach of this bylaw or any condition imposed on him or her under the licence issued under this bylaw; or

(b) The licence is terminated under clause 8 of this bylaw,—

and, in each case, Transit has notified the licensee that the licence is therefore no longer valid or—

(c) The expiry of the term of the licence.

**8. Conditions of licence**—Transit may terminate any licence issued under this bylaw, or amend, add to, or delete conditions, including any Additional Conditions (as defined in the licence), under the licence for reasons consistent with the matters listed in clause 5(2) of this bylaw. The licensee shall not be entitled to any compensation should Transit exercise its powers under this clause.

**9. Breach of bylaw**—(1) Every person committing any breach of this bylaw or any condition imposed on him or her under a licence issued under this bylaw shall be liable upon conviction to a fine not exceeding \$500.

(2) If any person breaches clause 4 of this bylaw, or if any licenced roadside vendor breaches any condition under a licence issued under this bylaw—

(a) The person shall immediately cease operations and move his or her operation from the State highway:

(b) Transit or its authorised agent or representative, or, in the event of an emergency or where the mobile shop or other operation is detrimentally affecting road safety in a material way, a police officer, may take all necessary steps to remove the mobile stop or other operation from the State highway:

(c) In the case of a continuing breach, Transit may seek an injunction under section 109 of the Transit New Zealand Act 1989 restraining the further continuance of the breach.

(3) The licence of the person committing any breach of this bylaw or any condition under a licence issued under this bylaw is automatically revoked.

(4) Nothing in this bylaw prevents Transit or a police officer giving a person who breaches this bylaw or any condition under a licence issued under this bylaw a warning under the Trespass Act 1980 to leave or to stay off that part of the State highway on which the mobile shop or other operation is located.

**10. Adoption of bylaw**—This bylaw was made by resolution passed at a meeting of Transit held in Wellington on the 30th day of June 1993.

#### *Report of Chairman for the Year Ended 31 March 1993*

This is the fifth annual report of the Trust Bank Wellington Community Trust.

*Personnel:* Two new trustees were appointed by the Minister of Finance; Ms Barbara Stones of Whitby and Mr W. A. Brien of Wellington. Regrettably Mr T. J. McGuinness died in December. He was a valuable member and the month before he

died he was one of trust's delegates to the annual meeting of the Association of Philanthropic Trusts. He will be missed and our sympathy was extended to Mrs McGuinness.

*Objective:* The trust remains committed to providing beneficial support for cultural, charitable, philanthropic and recreational organisations and groups in the Wellington community.

*Grants:* The trust operates under predetermined guidelines for the distribution of grants to community organisations and groups. For the 1992 year 374 applications were received seeking over \$1,800,000. This was considerably less than the \$5 million sought last year, but still went well beyond the trusts resources.

After careful consideration grants totalling \$303,465 were made to 262 local groups and organisations. The average grant was about \$1,158. The grants represent roughly 84 percent of the dividends received from Trust Bank New Zealand for the year ending 31 March 1993.

Last year the trust granted \$50,000 to the Capital Discovery Place, a "hands on" science museum principally for children. This was additional to a grant of \$30,000 in 1990 for the fitting out of the building. In my last report I said that these two grants, which for 1991 absorbed the whole allocation for kindergartens, schools, playcentres, etc., were the last to be made to the Capital Discovery Place, but in the end the trust relented and gave \$10,000 to subsidise school children's transport and a further \$10,000 for a dinosaur exhibit.

Notable grants were \$4,000 to the United Nations Association for the running of two model UN General Assemblies by secondary school children and \$4,000 to VSA for its activities. \$3,000 each was awarded to the Alzheimers Disease Society and the Arthritis Foundation for their work. Only in exceptional circumstances do grants to any organisation exceed \$4,000.

It is obvious that the community trust could usefully make much larger grants if funds permitted. For example, a number of excellent sponsorship opportunities to help community activities had to be foregone for lack of funds. In the meantime the trust has to be wary of commitments involving regular annual or periodic payments. The trust hopes that the Trust Bank Group will continue to make expanding profits as it has done for the year last completed.

As the trust's income increases over time, the trust and Trust Bank Wellington expect wider opportunities for financial assistance to community groups and organisations in our region.

*Investments:* The trust's main investments still remain in shares of Trust Bank New Zealand Limited. The trust's income is derived from the dividend paid by Trust Bank New Zealand Limited on these shares.

*Appreciation:* I record my appreciation to the trustees and Trust Bank Wellington for their continued commitment and support to our objectives.

This report reflects our fourth year of activities and I am convinced that this community trust will continue to play an increasing role in the future development of the cultural, educational, recreational, health and welfare needs of the Wellington community.
