# Notice of Reassessment of Anti-Dumping Duty on Automotive Oil Filters From the U.S.A.

Pursuant to section 14 (3A) of the Dumping and Countervailing Duties Act 1988 (as inserted by subsection 10(2) of the Dumping and Countervailing Duties Amendment Act 1990), the Minister of Commerce gives the following notice:

### Notice

1. Title and commencement—(1) This notice may be cited as the Final Determination and Imposition of Anti-Dumping Duty: Automotive Oil Filters from the U.S.A.: Amendment No. 1.

(2) This notice shall be read with and be part of the notice dated 27 November 1992\* and entitled "Final Determination and Imposition of Anti-Dumping Duty: Automotive Oil Filters from the U.S.A."\* (hereinafter referred to as the principal notice).

(3) This notice shall take effect on the day after the date on which it is published in the New Zealand Gazette.

2. Anti-dumping duty amended—The principal notice is hereby amended by revoking the Second Schedule and substituting the Second and Third Schedules set out in the Schedule to this notice.

Explanatory Note: This note is not part of the notice, but is intended to explain the reason for the amendment.

The original determination envisaged that for suppliers other than those investigated and for other filters from the investigated suppliers, normal values (value for duty equivalents) would be established as a basis for duty.

This was indicated by the invitation in the explanatory note to the principal notice for suppliers to lodge requests, backed by the necessary supporting evidence, for the establishment of these values.

Since the original determination, Normal Value (Value for Duty Equivalent) amounts have been established for eight additional suppliers and further oil filters have been added to the Schedules relating to the suppliers investigated.

The Normal Value (Value for Duty Equivalent) is the sum of the Normal Value established by the Secretary of Commerce with any necessary adjustments made in accordance with section 4(1)(a) of the Act in order to establish the Export Price.

The Customs Department will hold a list of the Normal Value (Value for Duty Equivalent) amounts for importation purposes for oil filters which the Secretary of Commerce has established from individual suppliers, details of the weighted average dumping margins for those suppliers and

of the weighted average dumping margin to be applied to those suppliers not investigated or for whom no Normal Value (Value for Duty Equivalent) amount has been established.

Where a Normal Value (Value for Duty Equivalent) has not been established by the Secretary for a specific oil filter, a supplier may lodge a request, backed by the necessary supporting evidence, that a normal value be established for that specific oil filter.

Normal Value (Value for Duty Equivalent) amounts established by the Secretary following such requests will be advised to the suppliers concerned and to the Customs Department. go5182

  - "Services" has the meaning given to it by section 2 of the Act:

Words importing the singular include the plural and words importing the plural include the singular.

**3. Direction**—(1) If any question or dispute arises as to whether or not—

(a) Any person satisfies the essential eligibility criteria for receipt of a service set out from time to time in a funding agreement (being at the date on which this direction will come into force the criteria set out in the Schedule to this direction); or

(b) Any other criteria, or any term or condition, set out in a funding agreement and relating to receipt of a service, is or are satisfied,

(2) No payment shall be made by a regional health authority in respect of the receipt of a service by a person who was not within New Zealand at the time of that receipt, unless such payment is authorised by the funding agreement of that regional health authority.

**4.** Amendment, revocation and term of direction—(1) The Minister may from time to time, by notice under section 25 of the Act, amend or revoke this direction.

(2) This direction (together with such amendments, if any, as are made to it under subclause (1) of this clause) shall remain in force until it is revoked.

- (b) who intends to remain in New Zealand for a period of time that (together with any period of time that person has already been in New Zealand) equals or exceeds two years; or

5. An individual who has refugee status in New Zealand; or

6. A student receiving funding under the Ministry of Foreign Affairs and Trade Official Development Assistance Programme or the partner or child up to the age of 18 years of any such student; or

7. A participant in the Ministry of Education's Foreign Language Teaching Assistantship Scheme; or
