- (3) The SCH 3 catch must have been taken while fishing for SPO 3 using the method Setnet.
- (4) The principal notice is hereby amended by including GUR 3 as a bycatch species in relation to the target species RCO 3 in quota management area 3.
- (5) The ratio of the amount of GUR 3 quota which may be accepted by way of lease or sublease in relation to the amount of RCO 3 catch for which the offer is made shall be 2.52.
- (6) The GUR 3 catch must have been taken while fishing for RCO 3 using the method Bottom trawl.
- (7) Any offers that relate to this notice must be for fishing

that has occurred in the months of August, or September 1994 respectively.

Radiocommunications Act 1989

Statement of Government Policy and Directions to Secretary of Commerce

To the Secretary of Commerce.

Pursuant to section 112 of the Radiocommunications Act 1989 ("the Act"), I hereby give you notice that it is part of the general policy of the Government, in relation to your functions, duties and powers under section 111 of the Act and your functions, duties and powers under the Radiocommunications (Radio) Regulations 1993—

- (a) That the coverage of the television services known as TV1, TV2 and TV3 should be maintained and should be extended to communities that currently do not receive the service; and
- (b) That subject to paragraph (a) the implementation of new television broadcasting services should be facilitated; and
- (c) That television services undertaken otherwise than for profit should be facilitated in the UHF range of frequencies; and
- (d) That television and sound radio broadcasting services that have as their primary objective the promotion of Maori language and culture should be facilitated; and
- (e) That licensing of New Zealand originated short wave sound radio broadcasting should be consistent with the foreign policy of the Government of New Zealand; and
- (f) That adequate provision should be made for licensing, in common bands where practicable, of apparatus used by Government departments or Crown agencies where such use is primarily for non-commercial public safety and security operations relating to protection of life and property; and
- (g) That there should be competition in telecommunications markets, and that the granting of radio apparatus licences should promote such competition.

Pursuant to the above policies I hereby direct you as follows:

- 1. VHF television broadcasting—(1) You may grant new radio apparatus licences for VHF television broadcasting services in the ranges of frequencies 44.00 MHz to 51.00 MHz, 54.00 MHz to 68.00 MHz and 174.00 MHz to 230.00 MHz.
- (2) Notwithstanding subclause (1) of this clause, where a radio apparatus licence is used for television broadcasting services other than for the transmission of the services

known as TV1, TV2 or TV3, that licence may be revoked under regulation 17 of the Radiocommunications (Radio) Regulations 1993 if that is necessary to maintain and extend the coverage of the services known as TV1, TV2 or TV3

- 2. UHF television broadcasting—You shall not grant new radio apparatus licences for UHF television broadcasting services in the range of frequencies 582 MHz to 646 MHz except where the granting of such licences is necessary for the purpose of—
 - (a) Maintaining the services provided by existing licensees in relation to those frequencies; or
 - (b) The implementation of new television broadcasting services, the primary objective of which is the promotion of Maori language and culture, where transmissions of such services are licensed for no more than 12 months. Such licences may be renewed for subsequent periods not exceeding 12 months, until a record of management rights is recorded under the Act in respect of the frequency to which the licence relates; or
 - (c) The implementation of new television broadcasting services undertaken otherwise than for profit, where transmissions of such services are licensed for no more than 12 months. Such licences may be renewed for subsequent periods not exceeding 12 months, until a record of management rights is recorded under the Act in respect of the frequency to which the licence relates; or
 - (d) Establishing translators for the service known as TV3 at Paeroa Range, Porirua and Towai.
- 3. Sound radio broadcasting—You shall not grant new radio apparatus licences for—
 - (a) Sound radio broadcasting services in the range of frequencies 88.2 MHz to 88.8 MHz except where the granting of such licences is necessary for the purpose of the implementation of new sound radio broadcasting services, the primary objective of which is the promotion of Maori language and culture, and where transmissions of such services are licensed for no more than 12 months. Such licences may be renewed for subsequent periods not exceeding 12 months, until a record of management rights is recorded under the Act in respect of the frequency to which the licence relates; or
 - (b) New Zealand originated short wave sound radio broadcasting, in frequency bands below 30 MHz allocated for broadcasting in the International Radio Regulations, where such services are inconsistent with the foreign policies of the Government of New Zealand.
- 4. Telecommunications—(1) You shall make adequate provision for licensing, in common bands where practicable, of apparatus used by Government departments or Crown agencies where such use is primarily for non commercial public safety and security operations relating to protection of life and property, and you may decline to grant licences in such bands where in your opinion the intended usage is not compatible with this policy; and
- (2) You shall not grant, for two-frequency land mobile operation in the ranges of frequencies 472 MHz to 476 MHz and 478 MHz to 482 MHz, new radio apparatus licences for channels with bandwidths in excess of 12.5 kHz.
- 5. Application of this notice—You shall comply with the directions set out above in relation to all applications for radio apparatus licences, including applications made before the date of this notice but not dealt with before that date.

6. Revocation of previous notices—The statements of Government policy set out in the Schedule to this notice are hereby revoked.

Dear Professor Axford

On 17 August 1993, pursuant to section 8A (1) of the Foundation for Research, Science and Technology Act 1990, I directed the Foundation for Research, Science and Technology to allocate funds under the two Ministerial Schemes entitled:

"The New Zealand Science and Technology Teacher Fellowships"

"New Zealand Science and Technology Post-Doctoral Fellowships".

Details of the Schemes were published in the New Zealand Gazette on 26 August 1993 (referred to as "the 1993 notice"). These Schemes shall continue in full force and effect in respect of funds allocated to them in the 1993/1994 financial year as was specified in the 1993 notice.

Pursuant to section 8A (2) of the Act, I now amend the directions given in the 1993 notice to apply to schemes funded in 1994/1995 and subsequent years as follows:

The New Zealand Science and Technology Teacher Fellowships:

The Scheme will be amended as follows:

The fourth paragraph of the section headed "Introduction - the Nature of the Scheme" shall be deleted and a new fourth paragraph substituted as follows:

"It is essential that spin-off benefits to students, colleagues and the wider community be maximised. Proposals submitted by applicants must address this aim, and sufficient resources must be allocated to ensure that this aspect of the programme can be effectively achieved. After completing their tenure, recipients of the fellowships are to submit a report which will assist in evaluation of the benefits of the scheme. Examples of benefits expected for schools and students, enterprises and the wider community are:"

This scheme shall continue in all other respects as in the 1993 notice with the addition of the words:

"The funding allocation for 1994/1995 is \$425,000."

The New Zealand Science and Technology Post-Doctoral Fellowships:

This Scheme shall be amended as follows:

Under the section entitled "Mechanisms of Support" the first objective shall be deleted and the following first objective substituted:

"• providing support for New Zealand post-doctoral researchers to undertake approved research programmes in New Zealand research institutions or in a business enterprise setting."

Under the section "Targeting of Support", the second paragraph will be deleted and the following second paragraph substituted:

"Fellows under this scheme will be selected on the basis of their academic record, and the scientific excellence of the proposed research. Fellowships will not be specifically targeted at any discipline area, and will be tenable at Crown Research Institutes, universities, Research Associations, polytechnics, business enterprises and private sector research facilities etc, provided the organisation has the capability and the capacity for intellectual and logistical support of the Fellow."

The Scheme shall continue in all other respects as in the 1993 notice with the addition of the words:

"The funding allocation for 1994/1995 is \$1,960,000. This will provide for approximately 30 fellowships during 1994/1995."

New Ministerial Schemes:

Pursuant to section 8A of the Foundation for Research, Science and Technology Act 1990, I direct the Foundation for Research, Science and Technology to allocate funds under the following Ministerial Schemes: "The New Zealand Graduates in Industry Fellowships Scheme" (Graduates in Industry) and "Non-Specific Output Funding" (NSOF).

The specific nature, objectives, criteria and funding levels applying to these Schemes are outlined in Annex A in respect of the Graduates in Industry Scheme and in Annex B in respect of the Non-Specific Output Funding Scheme.

Annex A The New Zealand Graduates in Industry Fellowships

Introduction—The Nature of the Scheme

This scheme will provide funds for well-performed graduates in science, technology and engineering to undertake project-based Masters, PhD or other post-graduate research, with the projects performed in New Zealand industry.

The Objectives of the Scheme

- upgrade scientific and technological skills and competencies in New Zealand companies;
- increase the number of postgraduate scientists, technologists and engineers working in professional roles in New Zealand industry;
- improve linkages between firms and universities;
- create a stronger interest among school leavers for courses in S&T and among graduates for careers in New Zealand industry.

Mechanisms of Support

The objectives of the scheme will be achieved by providing support for postgraduate researchers in science, engineering or technology who are conducting a major part of their research project in industry.

Targeting of Support

This scheme is aimed at science, technology and engineering graduates who have demonstrated potential to be innovative professionals in industry. This potential may be evident through demonstrated practical achievements, and not only by narrowly academic criteria.

Researchers will be awarded funding for a period normally of one to four years. Joint applications will normally identify the researcher, the academic supervisor, and the mentor in the company, and include their statements of commitment to the project.

The scheme will provide financial support for the researcher and will contribute to other costs associated with the project. Funding levels are to be determined by the Foundation for Research, Science and Technology, on the advice of an advisory committee, on a case by case basis. In making its decisions, the Foundation will optimise the number of awards in accordance with the objectives of the scheme.

Administration and Selection

The projects will be administered by the Foundation for Research, Science and Technology, using the mechanism of an advisory committee chaired by a member of the Foundation, and comprising science and engineering researchers and industrialists who have substantial experience supervising joint research projects of the kind supported by this scheme.

Funding

The scheme will allocate the following funding:

This will provide for 20-40 researchers in 1994/95, and at least this number annually after that.

Monitoring

The scheme will be monitored by the Ministry of Research, Science and Technology.

Annex B Non-Specific Output Funding (NSOF)

Objectives

NSOF is granted directly to Crown Research Institutes (CRIs) for public good science and technology programmes which do not have to conform to the Government's priority statement for public good science and technology. NSOF is likely to be used for:

- exploring new ideas which are not sufficiently well formed to enable a programme proposal to be made to the Foundation for Research Science and Technology ();
- maintaining programmes which are important to the CRI but are not of sufficient priority to gain funding from the Foundation.

Criteria

NSOF must be used for providing public good science and technology outputs. The test is whether the work would be fundable by the Foundation, i.e. within the scope of the Public Good Science Fund (PGSF) if it met relevance and quality criteria.

NSOF must be applied to outputs, although not necessarily in the year in which the funding is granted.

Administration

The Foundation will pay the NSOF to each CRI as a single contractual arrangement.

Level of Funding

Funding is made available to each CRI at the rate of 10% of the funds allocated from the contestable portion of the PGSF to each CRI in the previous year.

Period of Funding

The Scheme shall continue in operation until further notice.

Reporting

Progress and other reports on work funded by NSOF are to be made to the Foundation in a comparable way (i.e. timing and content) to reports required for work funded through the contestable part of the PGSF.

A summary of the level and application of NSOF is to be provided each year by each CRI to the Minister for CRIs.

A report on work funded by NSOF is to be included in the reports required to be provided by the Foundation pursuant to the Foundation for Research Science and Technology Act 1990.

Monitoring

This Scheme will be monitored by the Ministry of Research, Science and Technology.
