Every question arising before the said board shall be determined by resolution carried by a majority of the members of the board present, and voting on the question and such resolution shall be entered in a minute book to be kept by the board and shall not be questioned in any Court of law or equity.
- ii. The members of the board shall from time to time appoint one of their number to be chairman of the board, and may make their own rules and regulations for the conduct of their meetings and business, and may fix and determine the number of members who shall form a quorum and generally may regulate the manner of conveying their meetings and all other matters whatsoever connected with the direction of the business of the trust fund.
- iii. Until otherwise determined, the quorum of such board shall be two.
- iv. In case of any equality of votes on any question the chairman of the board shall have an ordinary and a casting vote."

Both the Canterbury Hospital Board and The Ellesmere County Council no longer exist, having been replaced by other structures, and therefore the superintendent of that board and the chairman of that council are positions which have both become defunct. Upon those grounds, a scheme has been prepared and has been approved by the Attorney-General of New Zealand, which prescribes or varies the mode of administering that charitable trust.

An order will be sought from the High Court to approve a scheme as follows:

"A. The member of the Robert McClelland Trust Board described in sub-paragraph 6 (d) of the said will as the superintendent from time to time of the North Canterbury Hospital Board, shall henceforth be the medical advisor who, in the opinion of the other two members of the Robert McClelland Trust Board, is the chief medical advisor of the health authority, enterprise or other controlling body which is from time to time in charge of the Christchurch Public Hospital or its successor in function. In the event of there being further or other restructuring of health services in Canterbury which has a consequence of there being no successor in title to such chief medical advisor or hospital, then such member may be appointed by the other two members of the Robert McClelland Trust Board, such replacement member being a person who shall in their opinion be as close as possible to the description of the original appointee as nominated by Mr McClelland in sub-paragraph 6(d) of the said will, that is the

superintendent from time to time of the North Canterbury Hospital Board. In the event of there being no member of the Robert McClelland Trust Board apart from the Public Trustee who is in existence or there being no such member apart from the Public Trustee able or willing to appoint a member of the said board, then the Public Trustee shall have sole power to appoint a replacement member of the board under this clause A.

B. The member of the Robert McClelland Trust Board described in sub-paragraph 6 (d) of the said will as the chairman for the time being of The Ellesmere County Council, shall henceforth be the mayor of The Selwyn District Council or the successor in title to the mayor. In the event of there being further or other restructuring within or of The Selwyn District which have the consequences of there being no successor in title to such mayor, then such member as may be nominated by the other two members of the Robert McClelland Trust Board, such replacement member being a person who shall in their opinion be as close as possible to the description of the original appointee as nominated by Mr McClelland in sub-paragraph 6 (d) of the said will, that is, the chairman for the time being of The Ellesmere County Council. In the event of there being no member of the Robert McClelland Trust Board apart from the Public Trustee who is in existence or there being no such member apart from the Public Trustee able or willing to appoint a member of the said board, then the Public Trustee shall have sole power to appoint a replacement member of the board under this clause B.

C. That "institution" or "institutions" referred to in sub-paragraph 6 (a) of the said will be redefined by deleting the words "hospital board" as they appear just prior to reference to the terms "institution" and "institutions" therein and substituting for the words "hospital board", the words "health authorities, enterprises, hospitals."

The application by the Public Trustee for approval of the said scheme will be heard in the High Court at Christchurch at 10 a.m. on Wednesday, 26 October 1994.

A copy of the said scheme has been deposited, and may be inspected at the Registry of the High Court at Christchurch or at the offices of the Public Trust Office, 152-156 Oxford Terrace, Christchurch.

Summary of Bills Presented

This section contains a précis of all bills presented to the House this week. Not all bills presented are introduced. The introduction of a bill requires the agreement of the House.

Long Term Care of the Elderly Committee

Long term care of the elderly in public and private hospitals has been subject to an assets test since 1 July 1993.

This bill establishes a multiparty committee to report on the funding and provision of long stay care of the elderly. Membership would be drawn from all parties represented in Parliament. (*Hon Clive Mathewson/Referred to Social Services Committee*)

Continuance of Napier Hospital

Provides for the continued running by Crown Health Hawkes Bay of Napier Hospital. The bill directs Crown Health Hawkes Bay to provide for the following services:

- Full maternity services, including antenatal, birthing and gynaecological services.
- A complete accident and emergency department.
- Day surgical services, including anaesthesia services.
- Full radiology services.

(*Geoff Braybrooke/Introduction interrupted*)

Air Facilitation (Domestic Passengers and Cargo)

Amends the Customs Act 1966 and the Immigration Act 1987. It is a companion measure to the Air Facilitation Act 1993 and provides for checks under the Customs Act 1966 and the Immigration Act 1987 to be made on domestic passengers flying between two Customs airports in New Zealand on international flights. Such checks prevent passengers using international flights to evade customs and immigration restrictions.

Provides for Customs checks on domestic cargo carried between Customs airports in New Zealand on international flights. This is to prevent persons using the carriage of domestic cargo on an international flight as a device to enable the importation into New Zealand of goods that cannot lawfully be brought into the country. (*Hon Maurice Williamson/Referred to Transport Committee*)

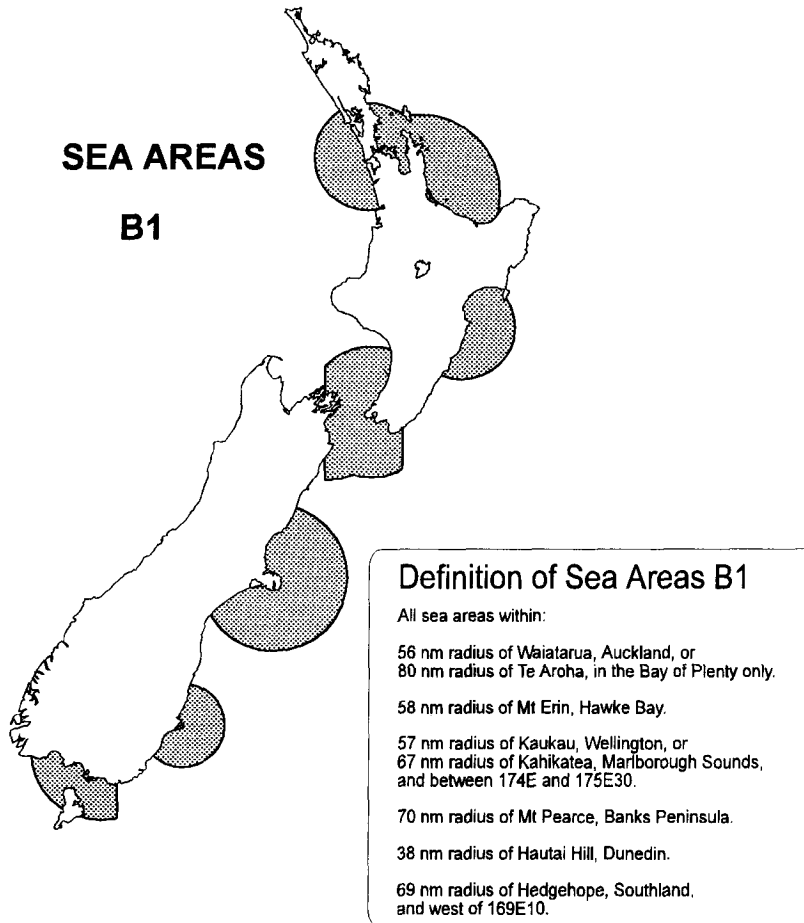

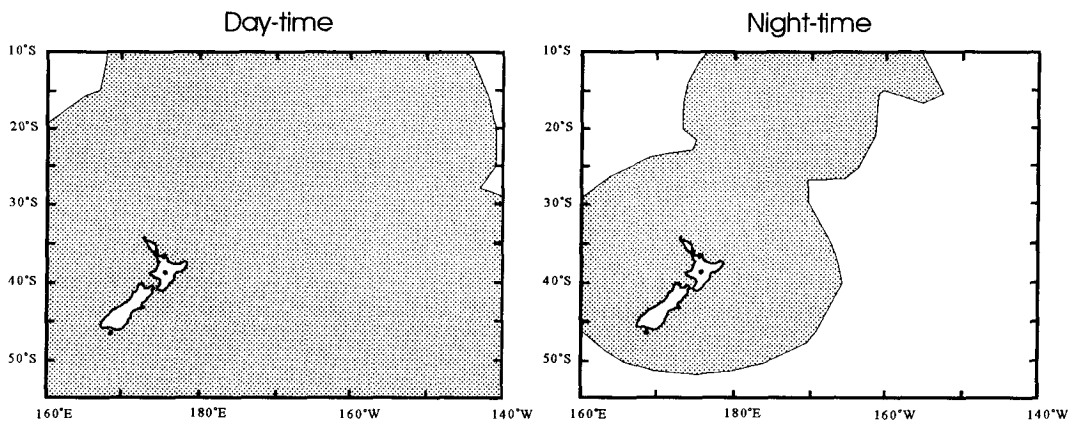

(6) One person appointed, in writing, by The Manawatu-Whanganui Regional Council.

6. The period between the 1st day of October in any one year and the 30th day of September in the following year (both days inclusive) is hereby declared to be a restricted fire season in the district.

District Anglers (Northland Fish and Game Region) Notice 1994

Pursuant to section 26R (3) of the Conservation Act 1987 the Northland Fish and Game Council hereby gives the following District Anglers Notice.

Notice

1. Title and commencement—This notice may be cited as the District Anglers (Northland Fish and Game Region) Notice 1994 and shall come into force on the 1st day of October 1994.

2. Interpretation—Words and expressions in this notice which are defined in the Conservation Act 1987 or the Freshwater Fisheries Regulations 1983 shall have the meaning so defined.

3. Open Season—(1) There shall be an open season for fishing for sports fish from the 1st day of October in any year to the 30th day of September in the following year (both days inclusive).

(2) No licence holder shall fish for, take or attempt to take, any sports fish except during an open season.

4. Authorised tackle—(1) No licence holder shall fish for,

take or attempt to take, any sports fish except by using a rod and running line.

(2) Notwithstanding subclause (1) of this clause—

(a) When playing a sportsfish, a landing net may be used to secure or land any such fish;

(b) For keeping sports fish alive, a keep net of not more than 1.8 metres in length may be used in the water from which that fish was taken;

(c) For taking small indigenous fish for bait angling, a bait net not more than 1.8 metres in length may be used.

(3) No licence holder shall, in fishing for, taking, or attempting to take, sports fish, have under their control more than one assembled rod and running line.

(4) No licence holder shall fish for sports fish unless within 15 metres of the rod being used and has the rod under his or her own visual observation.

(5) No licence holder when fishing for sports fish shall use:-

(a) More than 2 lures or baits;

(b) Any lead or weight (other than hooks as permitted elsewhere in this notice) attached below or so as to hang below any lure or bait;

(c) Any artificial fly or lure having more than one hook or having a multiple hook;

(d) Any bait or lure treated with any medicinal or chemical preparation other than;

(i) In the case of artificial fly, oil used solely to give buoyancy to such flies and

(ii) In the case of natural baits, a formalin or other preservative preparation;

(e) Any wire, either plain or twisted, or any gimp trace or cast of a greater thickness than 0.82 mm;

(f) Any wire or gimp trace or cast of a greater length than 1.8 metres.

(g) In conjunction with any spoonbait or artificial minnow, any lead or weight affixed to the trace or line at a distance of less than 38 cm above the lure;

(h) Any unsportsmanlike device or method.

5. Prohibition on unauthorised fishing tackle, etc.—No licence holder shall when fishing for sports fish use or be in possession of, or be in control of, or convey or cause to be conveyed to the vicinity of any place where that licence holder is fishing or proposes to fish, any paravane, any stroke-hauling or foulhooking gear, or any spear, any narcotic or poisonous substance or liquid injurious to fish.

6. Use of nets—No licence holder shall use or cause to be used for any purpose a net of any description except as provided for in clause 4 of this notice except:

(a) A whitebait net;

(b) Subject to a permit or authority issued under the Conservation Act 1987, any net used for the purposes of scientific investigations or data collection.

Provided that it shall be a defence for any licence holder charged with a breach of this clause if that licence holder proves that he or she was netting for indigenous fish in accordance with the provisions of any regulations or notices in force in that behalf.

7. Prohibition of possession or control of spear gun—(1) No licence holder shall, when taking or attempting to take or when in possession of, any sports fish, be in possession of or be in control of, any spear gun or any pointed missile (other than a bullet) which is propelled by means of any mechanical or explosive device.

(2) Where any licence holder is charged with an offence under subclause (1) of this clause, it shall be a defence to

the charge if the defendant proves that the speargun or pointed missile in the defendant's possession or under the defendant's control was not used in the taking of the sports fish.

(3) In this clause the term "explosive" has the same meaning as in the Explosives Act 1957.

8. Authorised lures and baits—No licence holder shall fish for sports fish with any bait or lure other than artificial or natural fly, insect, worm, crustacea, minnow, fish (excluding fish ova or any portion of a fish or any shellfish (mollusca)) or uncoloured bread dough.

9. Daily limit bag—No licence holder shall on any one day kill or be in possession of more than 10 trout.

10. Minimum size to be taken—(1) No licence holder shall be in possession of any trout which does not exceed 30 cm in length.

(2) Every licence holder taking trout which does not exceed the specified length shall immediately return it with as little injury as possible into the water from which it was taken.

11. Revocation—The notice published in the supplement to the *Gazette*, No. 151, of Friday, 31 August 1990, on page 3202 titled District Anglers (Northland Fish and Game Region) Notice 1990, and Amendment No. 1, are hereby revoked.

2. Interpretation—Words and expressions in this notice which are defined in the Conservation Act 1987, or the Freshwater Fisheries Regulations 1983, shall have the meaning so defined.

3. Open season—(1) Sports fish may only be taken from waters during the open season provided for those waters.

(2) In all waters except those listed below the open season shall be from the 1st day of October in any year to the 30th day of April in the following year (both days inclusive).

(3) In the waters known as:

- (a) Lake Rotomanu;
- (b) Lake Mangamahoe, excluding the Waiwhakaihō inlet;
- (c) Opunake Lake;
- (d) Ohakune Lake;
- (e) Lake Rotokuru;
- (f) Virginia Lake;
- (g) Lake Namunamu;

the open season shall be from the 1st day of October in any year to the 30th day of September in the following year (both days inclusive).

(4) In the waters known as:

- (a) Manganuiateao River and its tributaries;
- (b) Retaruke River and its tributaries;
- (c) Tokiahuru River and its tributaries;

(d) Mangawhero River and its tributaries upstream from Kakatahi;

(e) Raetihi Hydro Dam;

the open season shall be from the 1st day of October in any year to the 30th day of June in the following year (both days inclusive).

(5) In the waters known as:

- (a) Lake Rotorangi from the dam face to the Mangamingi ramp;
- (b) Lake Ratapiko, except the inlet race;
- (c) Waitara River downstream from the Manganui River confluence;
- (d) Waiwhakaihō River downstream from the end of Rimu Street extension;
- (e) Huatoki Stream downstream from Brois Street bridge;
- (f) Stony (Hangatahua) River, Waiaua River, Mangahume Stream, Kaipokonui Stream, Waingongoro River, all downstream from the State Highway No. 45 bridges;
- (g) Whanganui River (excluding tributaries) downstream from the boundary;
- (h) All waters south of a line from Patea to the Wanganui-Manganuiateao River confluence, to Kakatahi, and through Colliers Junction to the boundary; the open season shall be from the 1st day of October in any year to the 30th day of April in the following year (both days inclusive), then from the 10th day of June of the following year to the 30th day of September of that same year (both days inclusive).

(6) In the waters known as:

- (a) Lake Wiritōa;
- (b) Lake Pauri;

the open season shall be from the 1st day of October in any year to the 12th day of April in the following year (both days inclusive), then from the 1st day of August of that following year to the 30th day of September of that same year (both days inclusive).

4. Authorised Tackle—(1) No licence holder shall fish for, take or attempt to take, any sports fish except by using a rod and running line.

(2) Notwithstanding subclause (1) of this clause, when landing a sports fish, a hand-held landing net may be used to secure or land any such fish.

(3) No licence holder shall, in fishing for sports fish, have in his control, more than one assembled rod which shall be within 15 metres and under visual observation at all times.

(4) No licence holder shall use:

- (a) More than 2 lures or hooks;
- (b) Any double or treble pointed hook, or any multiple hook assembly;
- (c) Any gaff or landing hook;
- (d) Any hook having a gape greater than 13 mm, measured from the point of the hook to the nearest point of the shank;
- (e) Any hand-line, stroke-hauling gear, spear gun, paravane, firearm, explosive, spear, net (excluding landing net), trap or any other unsportsmanlike device or gear;
- (f) Any electric fishing gear, except for the purposes of scientific investigations or data collection;
- (g) Any poison or medicinal or chemical compound other than a preparation used solely to float or sink a fly or line.

5. Baits and lures—(1) No licence holder shall take sports fish unless he or she uses authorised baits and lures.

(2) Authorised baits and lures are:

- (a) Natural and artificial: fly, insect, worm, and crustacea (excluding Koura);
- (b) Artificial minnow;
- (c) Fish, but not any portion of fish, ova, or shellfish, providing that shellfish may be used in any artificial minnow.

(3) Only artificial fly shall be used at Lake Mangamahoe (including the Waiwhakiho inlet) and Raetihi Hydro Dam.

(4) Only artificial fly and artificial minnow shall be used in fisheries experimental waters outlined in clause 7 (1) (b).

(5) There shall be no restriction on the bait used by licence holders fishing for perch in any pond or dam on privately owned land.

6. Minimum size to be taken—(1) No licence holder shall take, kill, or have in his or her possession any trout or salmon of a length measured from the tip of the nose to the notch of the tail which is:

- (a) Less than 33 cm, in all waters west of a line from Waverley to Makahu to Onaero, and east of a line from the Whanganui and Ohura River confluence, to the Retaruke River confluence, to the Manganuiateao River confluence, to Kakatahi and through Colliers Junction to the boundary.
- (b) Less than 20 cm in all other waters.

(2) Every licence holder taking a sports fish which does not exceed the specified minimum length shall return it to the water immediately with the least possible injury.

7. Daily limit bag—(1) No licence holder shall on any one day have in his or her possession:

- (a) More than two (2) sports fish taken and killed from waters being Lakes Virginia, Pauri, Wiritoa, Namunamu and Raetihi Hydro Dam and Dobbs Dam; and all waters west of a line from Waverley, to Makahu, to Onaero, but excluding the Waingongoro River downstream of Eltham Road.
- (b) Any sports fish taken from a fisheries experimental water being:
 - (i) Mangaoraka Stream from the bridge at Te Arei Road West upstream to the bridge at Corbett Road;
 - (ii) Kaiu Stream upstream of the bridge at Alfred Road;
 - (iii) Stony River from the bridge at State Highway 45 upstream to the bridge at Mangatete Road;

In these waters sports fish shall be immediately released back into the water from which they were taken with as little injury as possible.

(c) More than four (4) sports fish in all other waters.

(2) Where a licence holder has taken or killed the prescribed limit of sports fish in one day he or she shall forthwith cease fishing for the remainder of that day.

(3) There shall be no limit on the number of perch taken or killed by a licence holder.

8. Virginia Lake (Wanganui)—Despite other rules in this notice, special rules apply to the waters of Virginia Lake. The rules are:

- (a) Only junior licence holders may take fish;
- (b) Only two (2) trout per day may be taken.
- (c) No fly casting;
- (d) No fishing from the paved area in front (western end) of the lake.

9. Revocation—The notice published in the supplement to the *Gazette*, No. 129 of 29 August 1991, on page 2787

titled District Anglers (Taranaki Fish and Game Region) Notice 1991, and Amendments No. 1 and No. 2 are hereby revoked.

3. Open season—(1) Subject to subclause (2) of this clause and to clause 4 of this notice, there shall be an open season for fishing for sports fish from the 1st day of October in any year to the 30th day of April in the following year (both days inclusive).

(2) There shall be an open season for fishing for sports fish from the 1st day of October in any year to the 30th day of September in the following year (both days inclusive) in the following waters (not including tributaries);

- (a) Aorere River downstream from the road bridge at Rockville;
- (b) Awatere River;
- (c) Buller River downstream from the confluence with the Mangles River;
- (d) Clarence River downstream from Glen Alton bridge;
- (e) Cobb Reservoir;
- (f) Conway River;
- (g) Lake Argyle and the Branch Power canal below the

lake downstream to its confluence with the Wairau River;

- (h) Lyell Creek (Kaikoura) downstream from State Highway No. 1;
- (i) Maitai River below the Nile Street bridge;
- (j) Matakaitaki River downstream from the State Highway No. 6 bridge;
- (k) Middle Creek downstream from State Highway No. 1;
- (l) Motueka River downstream from the road bridge at Ngatimoti;
- (m) Oaro River;
- (n) Opawa River downstream from State Highway No. 1 bridge;
- (o) Pelorus River downstream from its confluence with the Rai River;
- (p) Queen Charlotte Sound in an area of 500 metres radius from the mouth of all inflowing streams;
- (q) Takaka River downstream from its confluence with the Waingaro River;
- (r) Taylor River downstream from the New Renwick Road bridge;
- (s) Waimea or Wairoa Rivers downstream from the confluence with the Lee River;
- (t) Wairau River (including the Diversion) downstream from the Wash Bridge.

(3) A licence holder shall not fish for, or take or attempt to take, any sports fish except during an open season.

4. Closed Season—(1) There shall be a closed season for fishing for sports fish—

- (i) In the Brook Stream located in Nelson City from the 1st day of October in any year to the 30th day of September in the following year (both days inclusive).
- (ii) In respect of the taking of quinnat salmon (*Oncorhynchus tshawytscha*) in those waters of the Wairau River lying upstream of the Wash Bridge from the 1st day of October in any year until the 30th day of September in the following year (both days inclusive).

5. Authorised Tackle—(1) A licence holder shall not fish for or take any sports fish except by using a rod and running line, except that when playing a sports fish, a landing net may be used to secure or land any such fish.

(2) A licence holder shall not use in fishing for, taking or attempting to take sports fish, or have under their control, more than one assembled rod and running line at any one time.

(3) A licence holder shall not fish for sports fish unless they are within 15 metres of the rod being used and have the rod under their own visual observation.

(4) A licence holder in fishing for sports fish shall not fish from any boat or any floating device, in those parts of Lake Rotoiti and Lake Rotoroa within a radius of 100 m from the centre of the meeting lines of those rivers and streams listed:

Lake Rotoiti—

- (a) Travers River;
- (b) Coldwater Stream;
- (c) Black Valley Stream;
- (d) Buller River;

Lake Rotoroa—

- (a) Sabine River;
- (b) D'Urville River;
- (c) Gowan River.

6. Authorised lures and baits—(1) A licence holder shall not fish for sports fish with any artificial or natural bait or lure other than fly, insect, worm, crustacea, minnow or fish (excluding fish ova, any portion of a fish or any shellfish (Mollusca)) or coloured bread dough.

(2) A licence holder in fishing for sports fish shall not use any lure or bait other than artificial minnow or artificial fly in the following waters and all their tributaries;

- (a) Acheron River;
- (b) Clarence River above Glen Alton bridge but excluding Lake Tennyson;
- (c) Cobb River upstream of its confluence with the Cobb Reservoir;
- (d) D'Urville River;
- (e) Goulter River;
- (f) Maitai River (except the holders of junior licence);
- (g) Mangles River;
- (h) Motupiko River;
- (i) Opouri River upstream from and including the Ronga River;
- (j) Owen River;
- (k) Pearse River;
- (l) Riwaka River;
- (m) Sabine River;
- (n) Spring Creek;
- (o) Travers River;
- (p) Wairau River above the Wash Bridge;
- (q) Whakapuaka River.

7. Prohibition on unauthorised fishing equipment, etc.—(1) A licence holder shall not, when fishing for sports fish, use or be in the possession of, or be in control of, or convey or cause to be conveyed to the vicinity of any place where the licence holder is fishing or proposes to fish, any paravane, any stoke hauling or foul hooking gear, or any spear or gaff, any narcotic or poisonous substances or liquid injurious to fish.

(2) A licence holder shall not, when taking or attempting to take or when in possession of, any sports fish, be in possession of or be in control of, any spear gun or pointed missile (other than a bullet) which is propelled by means of any mechanical or explosive device.

(3) In this clause the term "explosive" has the same meaning as in the Explosives Act 1957.

8. Use of nets—Subject to clause 5 (1) of this Notice, a licence holder shall not use or cause to be used for taking sports fish a net of any description.

9. Daily limit bag—(1) A licence holder shall not on any day kill or be in possession of more than one (1) sports fish from the following waters (including tributaries);

- (a) Riwaka River.
- (2) A licence holder shall not on any day kill or be in possession of more than two (2) sports fish from the following waters (including tributaries);
 - (a) Coastal rivers and their tributaries meeting the sea between and including the Awatere and Conway Rivers, but excluding Lake Tennyson;
 - (b) Cobb River above the Cobb Reservoir;
 - (c) D'Urville River;
 - (d) Kaituna River (Havelock);
 - (e) Motupiko River;
 - (f) Opouri River;
 - (g) Owen River;
 - (h) Pearse River;

- (i) Pelorus River tributaries and the mainstream above State Highway No. 6;
- (j) Rahu River;
- (k) Sabine River;
- (l) Travers River;
- (m) Wairau River upstream of the Wash Bridge;
- (n) Wairau River tributaries;
- (o) Warwick River;
- (p) Woolley River.

(3) With respect to all other waters a licence holder shall not on any day kill or be in possession of more than four (4) sports fish of which not more than two (2) may be salmon.

(4) A licence holder who on any day, has already taken a limit bag from those waters specified in subclauses (1) and (2) of this clause, shall not, continue to fish in any of those waters, on that day.

(5) A licence holder who on any one day, has taken four (4) sports fish from the waters referred to in subclause (3) of this clause, shall not continue to fish on that day.

10. Minimum size to be taken—(1) There shall be no minimum size for sports fish, except as provided for in subclause (2) of this clause.

(2) A licence holder shall not have in their possession any sports fish which does not exceed 25 cm in length from the following waters—

- (i) Buller River, in the area from and including the outlet of Lake Rotoiti, which comprises of a radius of 100 m from the centre of the meeting lines with the Buller River, to the first bridge across the Buller River on State Highway No. 63.

11. This Notice shall apply to all fresh water watercourses, ponds, lakes and rivers of all sizes and descriptions within the Nelson/Marlborough Fish and Game Region and the words "water" and "waters" shall have a corresponding meaning.

12. Revocation—The notice published in the supplement to the *Gazette*, 151 on Friday, 31 August 1990, on pages 3211–3213, titled District Anglers (Nelson-Marlborough Fish & Game Region) Notice 1990 and amendments 1, 2, and 3 are hereby revoked.

District Anglers (North Canterbury Fish and Game Region) Notice 1994

Pursuant to section 26R (3) of the Conservation Act 1987, the North Canterbury Fish and Game Council hereby gives the following District Anglers Notice.

Notice

1. Title and commencement—This notice may be cited as the District Anglers (North Canterbury Fish and Game Region) Notice 1994 and shall come into force on the 1st day of October 1994.

2. Interpretation—(1) Words and expressions in this notice which are defined in the Conservation Act 1987, or the Freshwater Fisheries Regulations 1983, shall have the meaning so defined.

(2) In this notice the term "high country waters" means Lakes Lilian, Coleridge, Selfe, Evelyn, Grace, Henrietta, Ida, Little Ida, Catherine (also known as Monck), Georgina, Spectacles, Red Lakes, Lyndon Tarn, Lyndon, Rubicon, Pearson, Grasmere, Sarah, Hawdon, Marymere, Vagabonds Inn Tarn, Blackwater, Letitia, Minchin, Sheppard, Taylor, Katrine, Sumner, Mason, and Guyon, and all waters

flowing into those lakes; and includes all other lakes and tarns laying west and north of a line joining—

- (a) The white posts on the south bank in general line with the Lake Coleridge powerhouse intake pipes on the north bank, on the Rakaia River; and
- (b) The white posts at Woodstock on the Waimakariri River; and
- (c) The junction of the Hurunui River with the South Branch; and
- (d) The junction of the Waiau and Hope Rivers.

(3) "Taking" means fishing and "takes" and "to take" have a corresponding meaning.

(4) "Sportsfish" means every species of freshwater fish that the Governor-General may declare by order in Council to be sportsfish, and includes all trout, salmon, brook trout, mackinaw, splake, perch and tench, and any hybrids and their young.

3. Open season—(1) Subject to subclause (2) and (3) of this clause and to clause 4 of this notice, there shall be an open season for fishing for sports fish from the 1st day of October in any year to the 30th day of April in the following year (both days inclusive).

(2) In addition to (1) hereof there shall be an open season for fishing for sports fish from the first Saturday after Queen's Birthday Weekend to the 31st day of August in the same year (both days inclusive) in the following waters:

- (a) The Waiau River downstream from its junction with the Hope River;
- (b) The Hurunui River downstream from its junction with the South Branch;
- (c) The Ashley River downstream from the State Highway No. 1 bridge;
- (d) The Waimakariri River downstream from the white posts at Woodstock;
- (e) The Selwyn River downstream from where the South Springston Road meets the river at the upstream end of the Upper Selwyn Huts;
- (f) Lake Forsyth, and the Wairewa and Okuti Rivers downstream from the road bridge over each river on the Little River-Te Oka Bay road;
- (g) Lakes Taylor, Sumner, Coleridge, Lyndon, and Selfe, except within 200 m of any stream flowing into those lakes;
- (h) The Rakaia River downstream from the bridge on the main South Road.
- (i) At sea off the Tentburn Hatchery outside 100 metres from the hatchery outfall.

(3) Avon and Heathcote Rivers: In addition to clause 3 (1) hereof there shall be an open season for fishing for sports fish from the 1st day of October in any year to the 30th day of September in the following year (both days inclusive) in the Heathcote River and the Avon River, except as provided in clause 4 (1) (d), clause 4 (1) (e) and clause 4 (3) of this notice.

(4) No licence holder shall fish for, take or attempt to take, any sports fish except during an open season.

4. Closed season—(1) Notwithstanding clause 3 hereof, there shall be a closed season for fishing for sports fish—

- (a) From the 1st day of October 1994 and ending on Friday, the 4th day of November 1994 (both days inclusive) in any high country waters;
- (b) From midnight on Friday, the 4th day of November 1994 until midnight on the 30th day of November 1994 (both days inclusive) in any natural or artificial stream and tributary flowing into any high country lake.

- (c) From the 1st day of March to the 30th day of April in the same year (both days inclusive) in the Rakaia River and its tributaries above the Lake Coleridge powerhouse, that point more particularly shown by white posts on the south bank in general line with the powerhouse intake pipes on the north bank; provided that this subclause shall not apply to any lakes draining in to the Rakaia River above the point specified;
- (d) From the 1st day of April to the 30th day of April in any stream and tributary flowing into any high country lake whether artificial or natural;
- (e) From the 1st day of October in any year to the 30th day of September in the following year (both days inclusive) in Taylor's Drain from its source to its junction with the Wairarapa Stream; in the Avon River from the Armagh Street bridge at Hagley Park to the Barbadoes Street bridge; and in the Avon River and its tributaries entering it above the Armagh Street bridge for senior (adult) licence holders only; and in Lake Marion in the Lake Sumner Forest Park.
- (f) From the 1st day of May in any year to the 30th day of September in the same year (both days inclusive) in the Avon River and its tributaries above the Barbadoes Street bridge to the source; and in the Heathcote River and its tributaries above the Malcolm Avenue bridge to the source.
- (g) From the 1st day of February to the last day of February in the same year (both days inclusive) in the Glenariffe Stream upstream from the points marked and signposted, which are located 160 metres downstream from the hatchery release race outfall, to the Road Bridge above the hatchery.
- (2) Notwithstanding clause 3 hereof, there shall be a closed season for fishing for quinnat salmon from the 1st day of March to the 30th day of April in the same year (both days inclusive) in the following waters:
- (a) The Hurunui River above the junction of the South Branch of that river, or any tributary of that part of that river, including Lake Sumner;
- (b) The Waiau River above the junction of that river with the Hope River, or any tributary of the Waiau River;
- (c) The Waimakariri River above the white posts at Woodstock, or any tributary of that part of that river or the Kowai River and its tributaries including Hacketts Creek.
- (3) Notwithstanding clause 3 hereof, there shall be a closed season for fishing for quinnat salmon from the 1st day of March to the 30th day of September in the same year (both days inclusive) in the Avon, and Heathcote, rivers.
- 5. Authorised tackle**—(1) No licence holder shall fish for, take or attempt to take, any sports fish except by using a rod and running line.
- (2) Notwithstanding subclause (1) of this clause,
- (a) When playing a sports fish, a landing net or gaff may be used to secure or land any such fish;
- (b) For keeping sports fish alive, a keep net of not more than 1.8 metres in length may be used in the water from which that fish was taken.
- (3) No licence holder shall have, in fishing for, taking or attempting to take, sports fish, or have under his or her control, more than one assembled rod and running line.
- (4) No licence holder shall fish for sports fish unless within 15 metres of the rod being used and has the rod under visual observation.
- (5) No licence holder when fishing for sports fish shall use:
- (a) More than 2 lures or baits;
- (b) Any lead or weight attached below or so as to hang below any lure or bait;
- (c) In any water in which only artificial fly fishing is permitted, any additional lead or weight other than the necessary weight of line, cast and fly;
- (d) Any artificial fly having more than one hook or having a multiple hook;
- (e) Any bait or lure treated with any medicinal or chemical preparation other than;
- (i) In the case of artificial fly substances used solely to give buoyancy to such flies; and
- (ii) In the case of natural baits, a formalin or other preservative preparation;
- (f) Any wire, either plain or twisted, or any gimp trace or cast of a greater thickness than 0.82 mm;
- (g) Any wire or gimp trace or cast of a greater length than 1.8 metres.
- (h) On or in conjunction with any fly, spoonbait, minnow, or other lure any double or treble hook or other fixed multiple assembly of hooks any one hook of which has a greater distance than 13 mm between the point and the nearest part of the shank of the hook;
- (i) In conjunction with any spoonbait or artificial minnow, any lead or weight affixed to the trace or line at a distance of less than 38 cm above the lure;
- (j) Any unsportsmanlike device or method.
- (6) Notwithstanding subclause (5) of this clause, no licence holder in fishing for sports fish shall—
- (a) Use any natural lure or bait in any high country waters;
- (b) Fish from any boat being mechanically propelled in any lakes except in lakes Ellesmere, Forsyth, Coleridge, and Sumner at a distance of at least 200 m from any person fishing from the shore;
- (c) Fish from any boat or flotation device in any high country waters except Lakes Coleridge, Georgina, Lyndon, Pearsons, Taylor, Katrine, and Sumner, in which lakes any boat that is not being mechanically propelled may be used;
- (d) Use any lure or bait other than artificial fly in Lakes Ida, Little Ida, Catherine (also known as Monck), Sarah, Marymere, or Sheppard;
- (e) During the period commencing on the 1st day of January and ending with the 30th day of April in any year (both days inclusive), use in the Rakaia River more than one lure or bait when any weight is attached.
- (7) Notwithstanding subclauses (5) and (6) of this clause, any licence holder who, when using a line with weight attached other than the normal weight of the lure, bait, or fly, hooks a fish other than through the head (defined as those portions of a vertical line immediately behind the operculum of the gills to the snout) shall immediately return the fish alive with as little injury as possible into the waters from which it was taken.
- 6. Prohibition on Unauthorised Fishing Tackle, etc.**—Subject to subclause 5 (2) of this Notice no licence holder shall, when fishing for sports fish, use or be in possession of, or be in control of, or convey or cause to be conveyed to the vicinity of any place where that licence holder is fishing or proposes to fish, any paravane, any stroke-hauling or foulhooking gear, or any spear, or any gaff.
- 7. Use of nets**—Subject to clause 5 (2) of this notice, no licence holder shall use or cause to be used for taking sports fish a net of any description:
- Provided that it shall be a defence for any licence holder

charged with a breach of this clause if that licence holder proves that he or she was netting for indigenous fish in accordance with the provisions of any regulations or notices in force in that behalf.

8. Prohibition on possession or control of spear gun—(1) No licence holder shall, when taking or attempting to take or when in possession of, any sports fish, be in possession of or be in control of, any spear gun or any pointed missile (other than a bullet) which is propelled by means of any mechanical or explosive device.

(2) Where any licence holder is charged with an offence under subclause (1) of this clause, it shall be a defence to the charge if the defendant proves that the speargun or pointed missile in the defendant's possession or under the defendant's control was not used in the taking of the sports fish.

(3) In this clause the term "explosive" has the same meaning as in the Explosives Act 1957.

9. Authorised lures and baits—No licence holder shall fish for sports fish with any bait or lure other than artificial or natural fly, insect, worm, crustacea, minnow, fish (excluding fish ova or any portion of a fish or any shellfish (mollusca)).

10. Daily limit bag—(1) No licence holder shall on any one day take, kill or have in possession more than 6 sports fish.

(2) Notwithstanding subclause (1) of this clause, no licence holder shall on any one day take or have in his possession more than:

- (a) 6 sports fish taken from Lake Coleridge of which no more than 4 shall be trout;
- (b) 2 quinnat salmon taken from any other water;
- (c) 4 trout taken from any other water.
- (d) 1 splake from Lake Letitia.

(3) No licence holder shall continue to fish for sports fish on any day on which he has already killed 6 sports fish.

(4) It shall be permissible to make up the difference between a lesser limit bag prescribed in one place and a higher limit bag prescribed in another place.

(5) Notwithstanding subclauses (1), (2) and (4) of this clause, no licence holder shall on any one day take and kill or have sports fish in their possession, from:

- (a) Lake Marymere (a special catch and release zone); all sports fish caught in this water must be immediately released with as little injury as possible back into the waters from which they were taken.

11. Minimum size to be taken—(1) No licence holder shall take or have in his possession any trout or salmon which does not exceed 25 cm in length.

(2) Every licence holder taking a trout or salmon which does not exceed the specified length, or who wishes to release the fish for whatever reason, shall immediately return it with as little injury as possible into the water from which it was taken.

12. Revocation—The notice published in the supplement to the *Gazette*, 1990, No. 151, pages 3213–3215 titled District Anglers (North Canterbury Fish and Game Region) Notice 1990, and Amendments No. 1, No. 2, No. 3 and No. 4, are hereby revoked.

District Anglers (Central South Island Fish and Game Region) Notice 1992 Amendment No.2

Pursuant to section 26R (3) of the Conservation Act 1987, the Central South Island Fish and Game Council amends the District Anglers (Central South Island Fish and Game Region) Notice 1992, supplement to the *New Zealand Gazette*, 1992, No. 136, pages 2915–2918.

Notice

1. Title and commencement—(1) This notice may be cited as the District Anglers (Central South Island Fish and Game Region) Notice 1992, Amendment No. 2 and shall be read together with and deemed part of the District Anglers (Central South Island Fish and Game Region) Notice 1992 (hereinafter referred to as the "principal notice").

(2) This amending notice shall come into force on the 1st day of October 1994.

2. Interpretation—(1) Clause 2 (1) of the principal notice is amended by deleting the word "Fishing" and its definition and substituting with the following

"Fishing—

(a) Means the catching, taking, or harvesting of freshwater fish; and

(b) Includes—

(i) Any other activity that may reasonably be expected to result in the catching, taking, or harvesting of freshwater fish;

(ii) Any attempt to catch, take, or harvest freshwater fish;

(iii) Any operation in support of, or in preparation for, any activity described in this definition."

(2) Clause (1) of the principal notice is amended by deleting the word "taking" and its definition and substituting with the following "Taking- in relation to any fish means fishing and 'takes' and 'to take' have a corresponding meaning."

3. Closed Season—(1) Clause 4 (1) (b) of the principal notice is amended by inserting the following words "or in tributaries to Lakes Pukaki and Tekapo" after "said lakes, tarns, and rivers".

4. Authorised Tackle—(1) Clause 5 (7) of the principal notice is renumbered 5 (7) (a)

(2) Clause 5 (7) of the principal notice is amended by adding the following paragraph:

"(b) No licence holder shall continue to fish on any day after having foul hooked three sportfish, even though any such sportfish have been returned immediately in accordance with the previous clause 5 (7) (a)."

5. Authorised Lures and Baits—(1) Clause 9 (2) (b) of the principal notice is amended by deleting the word "Otamatapaio" and substituting "Otematapaio".

6. Daily Bag Limit—(1) Clause 10 (1) of the principal notice is amended by deleting the word "take".

(2) Clause 10 (2) of the principal notice is amended by deleting the word "take" and substituting "kill".

(3) Clause 10 (3) of the principal notice is amended by inserting the words "or she" between the words "he" and "has".

(4) Clause 10 (3) of the principal notice is amended by deleting the words "taken or".

7. Minimum Size to be Taken—(1) Clause 11 (1) of the principal notice is amended by deleting the words "take or have in his or her possession" and substituting "be in possession of".

3. Open Season—(1) Subject to the provisions of this Notice, fishing for sports fish is permitted 24 hours per day in the season and specified waters as listed in this clause. All other waters in the Clutha River catchment upstream from the Clyde Dam NOT specified elsewhere in clause 3.

(2) No person shall fish for, take or attempt to take, any sports fish except during an open season.

4. Closed Season—(1) Fishing for sports fish is not permitted at any time in the following specified waters:

Bullock Creek From Lake Wanaka to source:

Careys Creek, within 100 metres of any part of the outer boundaries of Bartlett's salmon farm diversion structure:

Horne Creek, from Lake Wakatipu to source:

Lake Wanaka, within 150 metres of any part of the launch wharf at the township of Wanaka:

Lake Wanaka, within 100 metres of any part of the wharf at the Wanaka Marina:

Lake Wakatipu, within the waters of Queenstown Bay bounded by a straight line drawn from the outermost point of the Tourist Park to the point where the south bank of One Mile Creek meets Lake Wakatipu:

Lake Wakatipu, within 100 metres of any part of the wharf in Black Bay (commonly known as the Walter Peak Jetty):

Mill Creek (which flows into Lake Hayes), from the Speargrass Flat Road bridge to the source:

Roxburgh Dam upstream of the posts marked "Fishing prohibited above this point" placed on each side of the Clutha River at the spillway from the Roxburgh power-house:

Waipori No. 3 Dam on the Waipori River adjacent to Waipori township:

All waters in which sports fish are held in captivity for

display, hatching, or other purposes, or within a distance of 100 metres from any part of the outer boundaries of such waters.

5. Authorised Tackle—(1) Fishing for sports fish is not permitted except by using one rod and running line, provided that when playing a sports fish, a landing net or gaff may be used to secure or land any such fish.

(2) No person shall, when fishing for sports fish, use or be in control of, more than one assembled rod and running line at any one time.

(3) No person shall fish for sports fish unless within 15 metres of the rod being used, and with the rod under that person's visual observation.

6. Restriction on Lures, Baits and Areas—(1) Subject to subclause (2), (3), (4), (5) and (6) of this clause, authorised lures and baits are any natural or artificial: fly, worm, crustacean, frog, mouse, insect, minnow or fish (excluding fish ova or any portion of a fish or any shellfish mollusc, provided that the shell of any mollusc may be used in the preparation of an artificial minnow).

(2) No person when fishing for sports fish shall use—

(a) More than 2 lures or baits;

(b) Any bait or lure treated with any chemical preparation other than;

(i) In the case of artificial fly, preparations used solely to give buoyancy to such flies: and;

(ii) In the case of natural baits, a formalin or other preservative preparation:

(c) On or in conjunction with any fly, minnow, or other lure, any single, double, or treble hook, any one hook of which has a greater distance than 13 mm between the point and the nearest part of the shank of the hook.

(d) In any waters in which only artificial fly is permitted, any wooden or plastic bubble with or without water, or weight other than the necessary weight of line to cast any artificial fly.

(3) No person when fishing for sports fish shall use any lure or bait other than natural or artificial fly in the following waters:

(a) Deans Bank, meaning that portion of the Clutha River lying downstream between a point indicated by a Black and Yellow landmark post approximately 600 metres from the outlet of Lake Wanaka, and a point indicated by a Black and Yellow landmark post, approximately 600 metres above the bridge at Albert Town.

(b) All rivers and streams flowing into Lake Wakatipu, except the Dart River and the Rees River and their tributaries.

(c) Nevis River.

(4) Subject to subclause (5), no person when fishing for sports fish shall use any lure or bait other than artificial fly or lure in the following waters:

(a) Clutha River catchment upstream from Lake Dunstan;

(b) Ross Creek Reservoir;

(c) Rossville Reservoir;

(d) Sullivans Dam;

(e) Southern Reservoir;

(5) Notwithstanding the above all methods are permissible in the following waters:

(a) Clutha River, from Luggate Bridge to Lake Dunstan;

(b) Lake Hayes and all streams flowing into or out of; Lake Hawea;

(d) Lake Johnson;

(e) Kawarau River;

(6) All methods are permissible in all other waters within the region other than (3) & (4).

7. Prohibition on Unauthorised Fishing Tackle, etc.—No person shall, when fishing for sports fish, use or be in possession or control of, or convey or cause to be conveyed to the vicinity of any place where that person is fishing or proposes to fish, any stroke-hauling or foul-hooking gear, or any spear.

8. Restrictions on Use of Boats—(1) No person shall fish from a boat on Lake Kirkpatrick.

(2) Subject to subclause (3) of this clause, no person shall troll from a mechanically propelled boat within 100 metres of any person fishing from the shore.

(3) No person in fishing for sports fish shall troll from any boat in any river or stream except the Taieri River downstream from Henley Ferry bridge, and the Clutha River downstream from Balclutha.

9. Daily Limit Bag—(1) Except in the case of perch for which there is no daily limit, no person shall on any one day take and kill or be in possession of more than the prescribed daily limit from the following specified waters:

Specified waters

(a) Lochy River special catch and release zone (being that portion of the river from its source to its confluence with the Longburn), Routeburn River; Daily Limit: Nil. Sports fish caught within these waters must be immediately released into the water from which it has been taken.

(b) Rivers and tributaries flowing into any of the lakes Hawea; Wanaka; and Wakatipu (but excluding the special catch and release zones); Nevis River; Ross Creek Reservoir; Rossville Reservoir; Southern Reservoir; Sullivans Dam; and Von Lake: Daily Limit: No more than one sports fish per day.

(c) Blakelys Dam; Coalpit Dam; Diamond Lake; Fraser River (Upper); Hoffmans Dam; Lake Johnson; Lake Kirkpatrick; Mathias Dam; Pomahaka River upstream from Park Hill Bridge; Reid Lake; Rutherfords Dam; and Tomahawk Lagoon: Daily Limit: No more than three sports fish per day.

(d) Elsewhere in Otago Region other than 9 (a), (b), (c) and (d), and down stream of the Roxburgh Dam and all coastal rivers. Daily limit: No more than two salmon.

(2) Subject to the restrictions set out in 9 (1) above, no person shall on any one day take or kill or be in possession of more than six sports fish per day.

10. Minimum Size to be Taken—(1) No person shall take or be in possession of any trout or salmon which does not exceed in length;

(a) In the case of any trout taken from the Water of Leith, Teviot River, Lake McKellar and Lake Sylvan, 20 cm.

(b) In the case of salmon taken from the Water of Leith, 45 cm.

(c) In the case of trout or salmon taken from any other water, 25 cm.

(d) In the case of perch, no size limit.

(2) Every person taking a trout or salmon which does not exceed the specified length shall immediately return it with as little injury as possible into the water from which it was taken.

11. Revocation—The notice published in the supplement to the *Gazette*, No. 129, of Thursday, 29 August 1992, on pages 2790–2792 titled District Anglers (Otago Fish and Game Region) Notice 1991, and amendments No. 1, No. 2 and No. 3 are revoked as from midnight 30 September 1994.

(d) the Waimatuku River and all its tributaries;

(e) the Aparima River and its tributaries downstream of the Hamilton Burn Confluence; the Hamilton Burn downstream of the Otautau-Mossburn highway;

(f) all waters draining to the sea between and including the Pourakino River and the Waimeamea River;

(g) the lower Waiau River and its tributaries (including the Holly Burn) except for the Wairaki River above the West Arm - Tiwai transmission lines; the Borland Burn and the Monowai River;

(h) The Mararoa River between the Key Bridge and Mararoa Weir.

(2) No licence holder when fishing for sports fish shall have in his or her possession or in his or her control any lure or bait other than artificial bait in all other waters of the region.

(3) Subject to clause 10 (4) no licence holder when fishing for sports fish shall have in his or her possession or under his or her control any lure or bait other than an artificial fly in the Upukerora and Eglinton Rivers and their tributaries.

(4) Junior or child free licence holders may fish in the Upukerora River downstream of the SH94 Bridge with any artificial bait.

3. Daily limit bag—(1) Clause 11 (2) (f) of the principal notice is revoked and replaced with the following:

(f) the Borland River; and the Monowai River.

4. Minimum size to be taken—(1) Clause 12 of the principal notice is revoked.
