## Summary of Bills Presented

### *Social Security Amendment*

Amends the Social Security Act 1964. The purpose of the bill is to make clear that, with certain exceptions, income-related insurance payments received by applicants for benefits are to be treated as income for the purposes of that Act.

The principal exceptions are:

- (a) Debt insurance payments, being payments made under contracts of insurance or by reason of a person's membership of a society, organisation, or body made for the purpose of repaying and used to repay existing debt:
- (b) Health or disability insurance payments, being payments made under contracts of insurance or by reason of membership of societies, organisations, or bodies that provide for the payment or reimbursement of health or disability care costs and that are used to meet those costs. ## New Zealand Game Industry Board

### Game Industry Board Regulations 1985

#### Game Industry Levy

Pursuant to regulation 17 (3) of the Game Industry Board Regulations 1985, notice is given that the Game Industry Board hereby fixed the rates of game industry levy (which levy rates are exclusive of goods and services tax imposed by the Goods and Services Tax Act 1985) as follows:

- (a) On each deer, other than fallow, slaughtered in deer slaughtering premises, 27 cents per kilogram hot clean carcass weight after removal of condemned parts;
- (b) On each fallow deer slaughtered in deer slaughtering premises, 21 cents per kilogram hot clean carcass weight after removal of condemned parts;
- (c) On each killed game deer carcass received at a game packing house, zero cents per kilogram cold clean carcass weight after removal of condemned parts;
- (d) On each piece of antler from fallow deer received at a game packing house for processing or packing \$1.30 per kilogram green weight; and
- (e) On each piece of antler from deer other than fallow deer received at a game packing house for processing or packing \$3.30 per kilogram green weight.

No levy will be payable when the velvet grade value, as defined by the Industry Agreed Grading Standards, is less than or equal to \$15/kg (G.S.T. exclusive).

An Animal Health levy will be collected by DSP's and velvet processors and is incorporated into the levy structure as outlined above. The levy will be broken down as follows:

GIB levy	• venison (fallow)	18 cents per kg
	• venison (other)	24 cents per kg
	• velvet (fallow)	\$1.00 per kg
	• velvet (other)	\$3.00 per kg
Animal Health levy	• venison	3 cents per kg
	• velvet	30 cents per kg

Companies will not be required to collect levies on Tb reactors but will be required to report the number of reactor deer slaughtered to the GIB in their monthly returns. The levy will be waived for those Tb reactors which are identified with an official MAF reactor tag and where they arrive at the DSP accompanied by an official MAF permit to move.

No levy shall be payable in respect of any one farmed deer carcass or piece of antler more than once.

These rates of levy will come into effect from and inclusive of the 1st day of October 1994 and apply during the 1994-95 season and subsequently until such time as new levy rates are fixed and come into force.

Pursuant to regulations 17A (1) notice is given that the Game Industry Board hereby fixes the rate of additional levy payable in respect of failure to pay, or late payment of, amounts of Board levy payable on or after the 1st day of October 1994 at 10 percent of the amount of levy unpaid.

This additional levy for failure to pay or late payment may

be applied by the Board at a rate of 10 percent on the outstanding balance following expiration of the period within which payment is required to be received by the Board, and shall be payable by the proprietor of the deer slaughtering premises or game packing house concerned.

### Trustees Report for the Year Ended 31 March 1994

The trustees have pleasure in presenting the sixth annual report of the trust. The trustees' duties, which have not changed since last year, include managing the assets of the trust and applying funds for charitable, cultural, philanthropic, recreational and other purposes, being purposes beneficial to the community generally, within the Otago provincial district.

The reason for some donations being unpaid at balance date is either, because certain conditions upon which the donation becomes payable are not yet fulfilled by the donee, or payment is to be spread over future years. By entering into arrangements to pay some donees over a period of years, the trust has been able to assist some larger projects in a more practical way. While payment of future years donation instalments is not legally binding upon the trust, undertakings of this nature are closely monitored by the trustees relative to the trust's projected income.

A full list of donations made during the year can be obtained from the secretary.

#### National Disaster Relief Fund

Our trust operates in conjunction with all other trust bank community trusts towards the maintenance of a national disaster relief fund. During the year a donation was made towards the Kaikoura Relief Fund of which our trust's share was \$1,350.

#### Review of Financial Results

##### (i) Shares in Trust Bank New Zealand Limited

The financial year has been dominated by the decision of trustees to sell part of the trust's shareholding in Trust Bank New Zealand Limited. Whereas the trust formerly owned 13.5 percent of the issued capital of the bank, that has now reduced to 5.4 percent.

For some years trustees have considered that it has not been prudent to continue to effectively have all of the trust's assets in a single investment. Opportunities for diversification have been limited, however the decision taken last year to increase the bank's capital base opened the door for community trusts, as part of that exercise, to sell some of their shares.

As a consequence, the trust in March 1994 realised \$62 million from the sale of 30 million shares in the bank which, at balance date was on short term deposit. Trustees have retained professional advisers, with whom they are currently working in order to determine how these funds should be re-invested in the longer term to the best advantage of the trust and its beneficiaries.

The shares retained by the trust, together with those shares retained by other community trusts, except South Canterbury, have been dealt with in accordance with the terms of a deed of trust entered into in December 1993. That deed provides for the collective shareholding of the community trusts, except South Canterbury, to be substantially held by Community Trust Nominees Limited and managed by Community Trusts Investments Limited as agents. This deed and the articles of association of Community Trusts Investments Limited provide a detailed code governing share transactions by community trusts. The procedures are intended to ensure that the strategic value of the collective shareholding of the community trusts is preserved and that material transactions in parcels of shares either between community trusts, or with third parties are conducted in an orderly manner. The deed also prescribes procedures designed to ensure that community trusts have influence in relation to the appointment of directors to the board of Trust Bank New Zealand Limited. The intent is to ensure that there continues to be an appropriate level of experience, skills and other attributes present on the board of Trust Bank New Zealand Limited.

##### (ii) Financial Performance

The income of the trust rose significantly during the year, both as a result of increased dividends from the bank as well as increased interest income arising from the proceeds from the sale of shares. The work required as part of the process involved in selling off part of the trust's shareholding in the bank has led to increases in administration costs and professional fees. Overall the achievements made during the year have been extremely pleasing and trustees consider the affairs of the trust to be in an excellent position.

#### Acknowledgments

During the year, the trust lost the services of one of its trustees, Mr Stephen Alexander of Dunedin. His contribution was extremely valuable and sincerely appreciated by all trustees. Mr Richard McKnight was appointed as trustee by the Associate Minister of Finance in May 1993.

The financial statements of the trust follow this report.

The general accounting policies adopted in the preparation of these financial statements are:

- the measurement base adopted is the historical cost basis.
- reliance has been placed on the fact that the trust is a going concern.
- revenues earned and expenses incurred are matched using accrual accounting, except that dividends received are accounted for on a receipts basis.

*Particular Accounting Policies*

The following are the particular accounting policies which have a material effect on the measurement of results and the financial position:

- (a) Dividend income from Trust Bank New Zealand Limited is included in the income and expenditure account when it is received.
- (b) Donations made are included in the income and expenditure account when paid.
- (c) Investments, which comprise shares held in Trust Bank New Zealand Limited are stated at cost.

*Changes in Accounting Policies*

There have been no changes in accounting policies. All policies have been applied on bases consistent with those used in previous years.

**2. Dividends**

Fully imputed dividends received from Trust Bank New Zealand Limited comprised:

- (a) 1993 final dividend of \$1,136,295 plus imputation credits received 2 July 1993.
- (b) 1994 interim dividend of \$810,000 plus imputation credits received 3 December 1993.

**3. Investment in Trust Bank New Zealand Limited**

During the year the trust sold 55 percent of its shareholding in Trust Bank New Zealand Limited. This was achieved in conjunction with a public offering of shares by Trust Bank New Zealand Limited to raise additional equity capital.
