Now, therefore, I, Dame Catherine Anne Tizard, the Governor-General of New Zealand, and as such the Governor of the Ross Dependency, hereby appoint

Warren George Herrick

to be an officer of the Government of the Dependency during the period beginning with the 1st day of October 1994 and ending with the close of the 15th day of October 1995 or such earlier date as he shall leave the Dependency:

And I hereby confer on the said Warren George Herrick while he holds office all the powers and authorities that may be exercised in New Zealand by a Justice of the Peace, and also the powers and authorities that may be so exercised by a Coroner:

The said Warren George Herrick to exercise his functions at such places within the Dependency as may be directed by the officer for the time being appointed as an officer of the Government of the Dependency in whom is vested the general executive and administrative authority in preserving Her Majesty's rights and sovereignty and the laws and regulations in force in the Dependency.
