- (c) Ballot papers shall, not later than the 1st day of April 1996, be posted to or lodged with the Returning Officer appointed for the purpose of the election by the Minister:
- (d) The Secretary of the Aupouri Maori Trust Board shall, not later than the 17th day of April 1996, forward to the Chief Executive of the Ministry of Maori Development the names of the persons elected as members to represent the Ngataki division of the beneficiaries of the Board:
- (e) Subject to paragraphs (a) to (d) of this clause, the provisions of the Maori Trust Boards Act 1955 shall apply to and in respect of the election.
