*Decoy limit:* No limit.

#### Special Conditions

1. No person shall use or cause to be used for the purposes of hunting or killing game, any fixed stand, pontoon, hide,

unmoored camouflage boat or maimai on the Wairau Lagoons, as defined in area G, except above the mean high water level.

2. Moored camouflaged boats are permitted for hunting or killing game in the Wairau Lagoons, as defined in Area G, but shall not be within 200 metres of any other hunting stand.

3. There shall be a closed season for Canada goose on the Wairau Lagoons, as defined in Area G from 30 September 1996 until 26 November 1996 inclusive.

***Declaring an Open Season for Game in Estuaries and off shore islands outside the Nelson-Marlborough Fish and Game Region for the 1996 Game Season.***
