- (c) marked in accordance with paragraphs (a), (e), (f) and (g) of section 5.5.4 of NZS 5433:1988; and
- (d) marked with the text "CLASS 6.2".

4. Where more than one primary receptacle is placed in

secondary inner packaging, the receptacles must be individually wrapped so as to prevent damage resulting from contact between those receptacles.

5. All packaged diagnostic specimens must be restrained in the vehicle to meet the requirements of section 1, chapter 3, of the *Truck Loading Code*, 1995 edition.

6. The secondary inner packaging and the outer packaging must be tested for compliance with condition 2 of this Schedule by a testing laboratory that is accredited to ISO Guide 25.

7. Where an operator knows or ought to know that any load or part of the load on the vehicle consists of goods specified in the First Schedule to this notice and is being carried under the terms of this exemption, a copy of this *New Zealand Gazette* notice must be carried, inside the driver's door of the vehicle in a readily accessible position and shall be kept together with the particulars required to be carried, pursuant to section 70F (1) (c) of the Transport Act 1962.
