  - additional rebates or exemptions were not included in the tax code during the year; and/or
  - employment was for part of the year only.
- 6. Any person or company who does not file an income tax return within the prescribed time may be prosecuted for failure to furnish a return and if convicted, may be fined as follows:
  - on the first occasion, not exceeding \$2,000 for each offence;
  - on the second occasion, not exceeding \$4,000 for each offence;
  - on every other occasion, not exceeding \$6,000 for each offence.

The cost of transport will not be deductible.
- (d) In respect of slipe wool and fellmongered wool, an amount per kilogram estimated by the Wool Board to be equivalent to 5% of the seasonally-adjusted, average price for new season's wool sold at auction (the market indicator) during the calendar month 2 months prior to the month in which the levy became payable or, if there were no auctions during that month, during the last calendar month before it in which there was an auction, adjusted to reflect an average yield for slipe wool of 85% and less the average selling charges and testing costs on auction-sold wool for the previous season, as calculated by the Wool Board.
