- (a) Every representative of the Governments of those States listed in the Appendix hereto (other than the Government of New Zealand) shall be accorded the privileges and immunities conferred by or by virtue of Part I of the Act on a diplomatic agent as specified in Articles 29 to 37 (1) inclusive of the Vienna Convention on Diplomatic Relations, set out in the First Schedule to the Act; and
- (b) All the members of the official administrative and support staff of any such representative shall be accorded the following privileges and immunities;
 - (i) Immunity from suit and legal process in respect of things done or omitted to be done by them in the course of the performance of their official duties;
 - (ii) Exemption from income tax in respect of emoluments received for services in respect of their official duties;
 - (iii) Exemption from taxes on the importation of goods for the official use in New Zealand of the government representative or designated delegate, that exemption to be subject to compliance with such conditions as the Minister of Customs may determine for the protection of the revenue.

Whereas on the 21st day of May 1993, David Brian Dougherty was convicted in the High Court at Auckland on charges of abduction and sexual violation by rape and was sentenced to concurrent terms of imprisonment of four years and seven years and nine months, respectively:

And whereas no conclusive DNA evidence was obtained by the application of conventional DNA analysis in relation to the identity of the offender for the purposes of the High Court trial:

And whereas subsequent to the High Court trial of David Brian Dougherty a new technique known as DNA amplification by polymerase chain reaction (PCR) became available in New Zealand for the analysis of genetic material that may have previously been considered as being too small in quantity for conventional DNA profiling:

And whereas, following instructions from defence and prosecution counsel, this new technique was applied by Dr Peta Stringer of the Institute of Environmental Science and Research Limited to certain forensic samples obtained during the investigations into the charges against David Brian Dougherty:

And whereas the results obtained by the use of the PCR technique indicated that genetic material found on the complainant's underpants and from swabs taken from her body (being evident as signals at the location of allele 4 which were weaker than the test control dots) was derived from a person with the same genotype as David Brian Dougherty and that there was genetic material extracted from the complainant's underpants (identified as allele 3) which could not be attributed to either David Brian Dougherty or the complainant:

And whereas an application for leave to call new evidence and an appeal against the conviction of David Brian Dougherty were made to the Court of Appeal on the basis that the presence of the genetic material extracted from the complainant's underpants (identified as allele 3) pointed to the involvement of another person in the commission of the crimes for which David Brian Dougherty had been convicted:

And whereas the only scientific evidence considered by the Court of Appeal in relation to the results obtained by the use of the PCR technique was produced by Dr Peta Stringer:

And whereas on the 2nd day of November 1994, the

Court of Appeal declined the application for leave to call new evidence and dismissed David Brian Dougherty's appeal against conviction in the High Court:

And whereas an application, dated the 27th day of March 1996, has been made by David Brian Dougherty for the exercise of the mercy of the Crown in respect of his conviction based upon the review of Dr Peta Stringer's DNA evidence presented to the Court of Appeal conducted by three independent scientists namely: Dr Stephen Jan Gutowski, Manager, Research and Development at the Victoria State Forensic Science Centre, Victoria, Australia; Dr Rebecca Reynolds, Manager, Human Identity Group, Roche Molecular Systems Incorporated, California, United States of America; and Dr Arie Geursen, Director of Resources, Genesis Research and Development Corporation, Auckland, New Zealand:

And whereas the application submits that the independent scientific review of the above-mentioned evidence establishes, among other things, that:

- (a) The DNA readings indicating David Brian Dougherty as the possible contributor to genetic material found on the complainant's underpants and on swabs taken from her body should not have been reported to the Court of Appeal because it is contrary to recognised scientific practice to report PCR test readings of such low intensity and it is likely that these readings arose as a result of factors other than the presence of human genetic material; and
- (b) The results of a number of tests which were conducted on samples taken from the complainant and her clothing and which disclosed certain DNA readings, being results that would have excluded David Brian Dougherty as the source of the DNA material found on those samples, were not reported to the Court of Appeal; and
- (c) There is no reliable genetic evidence in any of the tests conducted on the samples originating from the swabs taken from the complainant that would link David Brian Dougherty to the commission of the crimes for which he has been convicted; and
- (d) David Brian Dougherty is unequivocally excluded from having contributed the stains (identified as seminal fluid) extracted from the complainant's underpants:

And whereas Dr Peta Stringer has reassessed her original interpretation of the DNA evidence presented to the Court of Appeal and has acknowledged that any signals that were of low intensity (i.e., weaker than the control dot) should not have been considered:

And whereas Dr Peta Stringer and the three independent scientists referred to above have reached the same view that both David Brian Dougherty and the complainant are unequivocally excluded from having contributed to the DNA material (identified as allele 3) that was extracted from the complainant's underpants:

And whereas it appears that evidence is available that could lead the Court of Appeal to the conclusion that the scientific evidence presented at the appeal was unsatisfactory and that a miscarriage of justice might have occurred:

Now therefore, pursuant to section 406 (a) of the Crimes Act 1961, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby refers to the Court of Appeal for hearing and

Transit New Zealand Act 1989

Ministerial Determination for the Formation and Operation of Business Units Competing for Minor and Ancillary Works and Reporting Requirements—1996

Under section 32 (b) and 32 (c) (i) and (ii) of the Transit New Zealand Act 1989 (as amended by the Transit New Zealand Amendment Act 1995) the Minister of Transport, in consultation with the Board of Transfund New Zealand, makes the following determination.

Determination

I. Title and commencement—This determination may be cited as the Ministerial Determination for the Formation and Operation of Business Units Competing for Minor and Ancillary Works and Reporting Requirements—1996 and commences on the date that it is signed by the Minister of Transport.

2. Interpretation—(1) In this determination, unless the context otherwise requires, "the Act" means the Transit New Zealand Act 1989.

(2) Unless the context otherwise requires, terms used in this determination and defined in the Act have the same meaning as in the Act.

3. Business unit requirements—The requirements for the formation and operation of a business unit of a local authority competing for minor and ancillary works subject to competitive pricing procedures to which payments may be made under section 27 of the Act are as follows:

Formation—The business unit must be formed by resolution of the council of the local authority (the "parent local authority").

Operation—The business unit must:

- (a) Business Plan: adopt and operate in accordance with a written annual business plan which (at a minimum) must contain the following in respect of the business unit:
 - Its purpose or mission;
 - The goods and services to be provided by it;
 - Its performance targets;
 - Its management structure;
 - The content and frequency of its reporting requirements to the parent local authority;
 - Its operating budget;
 - Its accounting procedures;
- (b) Autonomy: be a separately identified unit within the overall activities of the local authority and to this end:
 - (i) Allocation and costing of goods and services employed: the cost of all goods and services allocated to, purchased by or employed in the business unit from its parent local authority or external suppliers must be fully charged to the business unit, and must be evidenced in a written agreement quantifying the goods and services and the price;
 - (ii) Independence of infrastructural asset managers: no member of the staff of the parent local authority involved in infrastructural asset management may work for, or be involved, in the business unit or its activities; provided that this shall not affect the overall supervisory responsibilities of the Chief Executive Officer of the parent local authority.
 - (iii) Accounting for business unit activities: the accounting records for the business unit must enable the surplus/deficit generated by the activities of the business unit to be measured and reported in accordance with generally accepted accounting practice to the parent local authority;
 - (iv) The fair value of capital employed to be established: the fair value of the parent local authority's investment (notional debt/equity) in the business unit must have been determined and supported by independent valuation and must be updated annually.
 - (v) Expected rate of return on local authority

investment: the council of the parent local authority must determine annually by resolution the rate of return it expects from its investment (notional debt/equity) in the business unit;

(vi) Form of agreement for goods and services provided: where the business unit supplies the parent local authority with goods or services for which payment is to be made under section 27 of the Act all the terms of conditions of such supply must be recorded in writing. Those terms and conditions must, insofar as is practicable, be:

(aa) the same as the parent local authority's standard documentation for contracts with external suppliers of similar goods or services;

(bb) conform to the request for tender.

4. Reporting requirements—The notes to the audited financial statements of a local authority prepared under

section 223E of the Local Government Act 1974, must include, in relation to payments made under sections 27 and 28 of the Act, from the local authority's land transport disbursement account, the following amounts:

- (a) total payments;
- (b) operating costs (including all overhead costs and depreciation) of the business unit to which those payments are to be made;
- (c) net surplus/deficit;
- (d) the basis for reallocations of a net surplus or the funding of a net deficit.

Broadcasting Act 1989

1996 General Election

Notices are Sought From Political Parties Seeking Qualification for Allocations of Broadcasting Time and Money Appropriated by Parliament for the Purpose of Broadcasting Election Programmes

The Broadcasting Act 1989¹ ('the Act'), describes the responsibilities of the Electoral Commission ('the Commission') to allocate to political parties which qualify under section 75 of the Act, time and money for political party election programmes.

Time may be made available free or at discounted rates by broadcasters, at the invitation of the Commission. The Act provides for the appropriation of money by Parliament for the purpose of enabling political parties which qualify to meet all or part of the costs of broadcasting election programmes during the election period.²

Section 70A (1) of the Act requires the Commission to specify, by notice in the *Gazette*, a date by which any political party that considers that it will qualify for an allocation of time under section 73 of the Act or of money under section 74A of the Act in respect of the election period that will apply for the general election to be held this year, must notify the Commission in writing that it considers itself to be so qualified.

The Commission specifies 22 July 1996 as that date.

Section 70A (3) requires each political party that considers that it will qualify for an allocation of time under section 73 of the Act or of money under section 74A of the Act to notify the Commission in writing by that date.

Section 76 (3) of the Act provides, among other things, that the failure of any political party to give such notice or to comply with any other request of the Commission shall not prevent the Commission from making any allocation of time or money or making any determination and shall not affect the validity of such allocations or determinations.

Under section 70c of the Act, every notice given to the Authority by any party shall state, among other things—

'(a) The full name of the political party; and

- (aa) The name and address of the person providing the notice and the capacity in which he or she provides the notice; and
- (ab) Where the person providing the notice is not the Secretary of the political party, the name and address of the Secretary of the political party; and
- (b) Details of any relationships that may exist between that political party and any other political parties in New Zealand which the Electoral Commission may need to take into account in allocating time or money to political parties; and
- (c) Either-

(i) That the party is registered on the Register of Political Parties; or

(ii) That the party is intending to apply for registration on the Register of Political Parties in order to be registered at least 3 months before the date in that year on which the Parliament is due to $expire;^3$ or

(d) Where the political party considers that it is eligible for an allocation of time and money under section 75 (1) (a) (ii) of this Act,—

(i) The full name of each person who has declared his or her intention of becoming a constituency candidate for that political party at the general election to be held that year; and

(ii) the electoral district for which each person to whom subparagraph (i) of this paragraph applies intends to be a constituency candidate.'

Section 75 (1) of the Act provides criteria with which the Commission is to comply when allocating time or money to a political party. In respect of the election to be held in 1996, the criteria under section 75 (1) (a) have been amended by section 23B (3) of the Broadcasting Amendment Act 1996 so that the Commission shall not allocate any time to a political party under section 73 of the Act or make under section 74A of the Act an allocation of money to any political party unless—

(i) That party was registered on the Register of Political Parties on the 5th working day after the date of commencement of the Broadcasting Amendment Act 1996; or (ii) Persons belonging to that party or group of related political parties were, on the 5th working day after the date of commencement of the Broadcasting Amendment Act 1996, deemed, by section 70D of this Act, to be constituency candidates at that general election for at least 5 seats in the House of Representatives.

The Broadcasting Amendment Act 1996 commenced on 1 July 1996.

Section 70D of the Act provides that where a political party states in its notice to the Commission pursuant to section 70C (d) of the Act that a person has declared his or her intention of becoming a constituency candidate at an election, that person shall, until noon on nomination day for that election, be deemed, for the purposes of section 75 (1) (a) (ii) of the Act, to be a candidate at that election, whether that person is nominated or not.

Explanatory Note

This note is not part of the notice but is intended to indicate its purpose.

The Broadcasting Standards Authority published a notice in the *Gazette* on 21 March 1996 pursuant to legislation in effect at that time. That notice invited political parties to give notice to the Authority that they considered they qualified (under different criteria) for allocations of time and money for election programmes.

The Broadcasting Amendment Act 1996 provides in section 23B that any notice given by the Broadcasting Standards Authority after the 1st day of March 1996 and before the date of commencement of that Act, being a notice published in the *Gazette* under section 70A of the principal Act, shall on the date of commencement of the Broadcasting Amendment Act 1996 cease to be of any legal effect.

The responsibility for the administration of the allocation of time and money to political parties for the broadcasting of election programmes has now passed to the Electoral Commission.

1. This bylaw may be cited as the Transit New Zealand (Milford Road Chains) Bylaw 1996/19.

- "Vehicle" has the same meaning as in the Transport Act 1962.

4. This bylaw shall apply to that part of State Highway No. 94 between the Lower Hollyford Road (RP 212/15.88) and Milford Sound (RP 241/16.55) being part of the State highway known as Milford Road.

5. Between the 1st day of May and 30th day of November in each year no vehicle shall be driven on the said portion of State Highway No. 94 past any sign erected on or adjacent to the highway which stipulates either:

- (i) that "chains must be carried" unless the vehicle is carrying a set of chains which can be conveniently fitted to the driving wheels of the vehicle, or
- (ii) that "chains must be fitted" unless a set of chains has been fitted to the driving wheels of the vehicle.

6. Nothing in this bylaw shall apply to any vehicle on the said State highway being used by a contractor appointed by Transit New Zealand and undertaking maintenance duties on the State highway.

Notes to the Financial Statements for the Period Ended 31 March 1996

1. Statement of Accounting Policies

Reporting Entity

- G.S.T. inclusive accounting has been adopted as the trust is not registered for G.S.T. purposes.
- Consolidation of Eastern and Central Community Trust Charities Limited, a wholly owned subsidiary, has been achieved using the purchase method of consolidation.
