Te Kura Kaupapa Maori O Maraenui

 - (iv) Kia matemateaone tetahi ki tetahi, kia ngakau mahaki te tangata, kia ngakau nui i te aroha.

To understand and to appreciate the values of love, humility, and support for one another.

(v) Kia ita te mauri o te tamaiti i roto i nga ako.

To respect the uniqueness and dignity of each child.

(vi) He whakahora papa ahuru tikanga e hokai ai te tapuwae tangata ki tona toa rangatiratanga.

To formulate policies that will help towards personal self-determination.

(vii) Kia matauria ai nga whakaaro mohio i runga i tona pumautanga, kia eke ki nga tihi teitei o te taumata.

To encourage each student to achieve to his/her full potential.

(viii) Kia marama te kite atu kua pakari nga tamariki i roto i nga ako.

To clearly identify the achievement levels of individual students.

(ix) Kia tipu nga ahuatanga tuku iho o tona pumanawa, kia u hoki tona turanga tangata whenua.

To nurture each student's ability that he/she may grow in confidence and self-esteem.

Sulphur Dioxide in Sun Dried Tomatoes (A314). The authority received an application (A314) from Fruitmark Pty Limited on 11 June 1996, to permit the addition of up to 3 g/kg sulphur dioxide to sun dried tomatoes.

The authority has made a preliminary assessment, accepted the application to amend the *Food Standards Code*, and will now make a full assessment. To assist this process, the authority invites submissions on matters relevant to the application by 4 September 1996.

Notice Pursuant to Section 19

Lipase in Baked Goods (A264). The authority has completed an inquiry into the draft variations to amend the *Food Standards Code*, prepared after full assessment of application (A264) from Novo Nordisk Bioindustrial Pty Limited and has recommended that the Australia New Zealand Food Standards Council adopt the draft variations to Standard A16—Processing Aids.

The recommendation, if approved by council, will permit the use of lipase derived from a strain of *Aspergillus oryzae* in baked goods, including bread. Additionally, lipase derived from *Rhizopus arrhizus* has been included in Standard A16, as previously lipase from this source had

been inadvertently deleted from Standard B1—Cereals, Legumes, Flours, Meals and Breads, and not included in Standard A16 during its preparation.

Ascorbic Acid in Soft Drinks and Electrolyte Drinks (A272). The authority has completed an inquiry into the draft variations to amend the *Food Standards Code*, prepared after full assessment of application (A272) from Reckitt and Coleman Products, and has recommended that the Australia New Zealand Food Standards Council adopt draft variations to Standard A7—Antioxidants, Standard O4—Soft Drinks and Soft Drink Products and Standard R9—Supplementary foods.

The recommendation, if approved by the council, will allow for the addition of ascorbic acid, erythorbic acid and their sodium salts as antioxidants to soft drinks and electrolyte drinks at a maximum level of 250mg/L.

Notice Pursuant to Sections 16, 19 and 36

Mercury in Ling Fish (A296). The authority received application (A296) from Sealord Products Limited on 14 December 1995, to allow the mean permitted mercury levels for ling (fish) to be increased to 1.0 mg/kg.

It has completed a full assessment of the application, and has prepared draft variations to Standard A12—Metals and Contaminants in Food, of the *Food Standards Code*.

The authority, pursuant to section 36 of the *Australia New Zealand Food Authority Act 1991 (the Act)*, has decided not to invite public submissions because the application raises issues of only minor significance and complexity. Therefore to omit to invite public submissions for the purposes of holding an inquiry into the draft variations will not adversely affect the interests of any person or body.

Section 63 of the Act provides that, subject to the *Administrative Appeals Tribunal Act 1975*, an application for a review of the authority's decision may be made to the Administrative Appeals Tribunal by a person or body whose interests are affected by the decision to omit holding an inquiry in relation to the application.

The authority will now recommend that the Australia New Zealand Food Standards Council adopt the draft variations.

Review of the Maximum Permitted Concentrations for Cadmium in Food (P144). The authority has prepared a proposal (P144) to review the maximum permitted concentrations for cadmium in all foods.

Notes to the Financial Statements for the Year Ended 31 March 1996

1. Statement of Accounting Policies

The ASB Bank Community Trust ("the trust") was formed on 30 May 1988 through the creation of a trust deed in compliance with the Trustee Banks Restructuring Act 1988. Under the terms of the trust deed the trust was settled with 60 million \$1 fully paid ordinary shares in ASB Bank Limited representing 100 percent of the issued capital. As at 31 March 1988 the net tangible asset backing of those 60 million shares was \$147,655,000. In 1989 45 million shares were sold to the Commonwealth Bank of Australia for \$252,000,000 which was then donated to the ASB Charitable Trust.

The measurement basis adopted is that of historical cost adjusted for the revaluation of certain assets. Reliance is placed on the fact that the trust is a going concern. The financial statements have been prepared in accordance with the requirements of the Financial Reporting Act 1993.

Bank

Bank is stated as the balance in the bank account rather than the balance as per the cash book.

Statement of Cash Flows

Cash comprises cash at bank and call deposits but excludes charitable purposes reserve fund cash.

Dividends

Dividends are recognised as income when they are received by the trust. They are recorded net of any imputation tax credits.

Donations

Donations are accounted for as they are distributed or committed to be distributed to eligible organisations as approved by the trustees.

Expenses

Some expenses are shared jointly with the ASB Charitable Trust. Whilst each trust bears its own specific costs, the joint expenses are allocated between each trust on the basis of the number of applications processed by each.

Investments

Investments in shares are valued at the net tangible asset backing as disclosed in the latest published accounts. Any revaluation difference is transferred to an investment revaluation reserve.

Other investments are stated at market value. Any gains or losses are recognised in income and expenditure for the period.

Financial Instruments

All assets and liabilities of the trust are financial instruments and are recognised in the balance sheet. All financial instruments are recorded at market value or fair value.

The quantitative disclosures required by FRS 31 disclosure of information about financial instruments, have been included throughout the financial statements where material.

Reserves

The investment revaluation reserve reflects the increase in the net tangible asset value of the shareholding in ASB Bank Limited less that portion attributable to the charitable purposes reserve fund.

The charitable purposes reserve fund represents funds appropriated by ASB Charitable Trust to enable the trust to participate in the issue of new equity by ASB Bank Limited. In order to maintain the non taxable status of this reserve, the trust is

required to segregate these funds appropriated from ASB Charitable Trust and the income attributable thereto. There are also certain restrictions on the distribution of income from this fund.

Transfers to other reserves from the unallocated surplus are made at the discretion of the trustees.

Taxation

Taxation includes both current and deferred tax. Deferred tax is calculated using the comprehensive liability method.

Comparatives

Certain comparatives have been restated for disclosure purposes.

There have been no material changes in accounting policies during the period.

Notes to the Financial Statements for the Year Ended 31 March 1996

1. Statement of Accounting Policies

The ASB Charitable Trust ("the trust") was formed on 31 May 1989 through the creation of a trust deed by the ASB Bank Community Trust and a donation of \$252,000,000.

The measurement basis adopted is that of historical cost adjusted for the revaluation of certain assets. Reliance is placed on the fact that the trust is a going concern. The financial statements have been prepared in accordance with the requirements of the Financial Reporting Act 1993.

Bank

Bank is stated as the balance in the bank account rather than the balance as per the cash book.

Statement of Cash Flows

Cash comprises cash at bank and call deposits but does not include cash or deposits held by the fund managers.

Depreciation

Depreciation is provided over the useful life of the assets. Buildings are depreciated on a straight line basis. Vehicle, office equipment and furniture are depreciated on a diminishing value basis. The rates used are those recommended by the Inland Revenue Department.

Dividends

Dividends are recognised as income when they are received by the trust and exclude imputation tax credits.

Donations

Donations are accounted for as they are distributed or committed to be distributed to eligible organisations as approved by the trustees.

Expenses

Some expenses are shared jointly with the ASB Bank Community Trust. Whilst each trust bears its own specific costs, the joint expenses are allocated between the trusts on the basis of the number of applications processed by each.

Fixed Assets

Fixed assets are valued at cost less accumulated depreciation.

Investment Properties

These are valued at market value. Movements in the valuation of investment properties are recorded in the statement of income and expenditure. No provision for depreciation is made on these properties.

Foreign Currencies

All amounts denominated in foreign currencies are converted to New Zealand dollars at balance date and all realised and unrealised gains and losses are recognised in income and expenditure for the period.

Investments

Investments are stated at market value. Any gains or losses are recognised in income and expenditure for the period.

Investment transactions are recorded by the fund managers on a settlement date basis. Unsettled transactions are disclosed in the notes as commitments.

Financial Instruments

All assets and liabilities of the trust with the exception of fixed assets are financial instruments and are recognised in the balance sheet. All financial instruments are recorded at market value or fair value.

The trust uses financial instruments with off balance sheet risk to reduce exposure to fluctuations in foreign currency exchange rates. Forward exchange contracts are entered into to hedge foreign currency transactions. These are converted to the New Zealand dollar rate at balance date with all realised and unrealised gains and losses being recognised in the income and expenditure statement.

The quantitative disclosures required by FRS 31 disclosure of information about financial instruments, have been included throughout the financial statements where material.

Reserves

Transfers to the capital maintenance reserve are based on the annual movement in the consumer price index.

Transfers to all other reserves from the unallocated surplus are made at the discretion of the trustees.

Taxation

The trust has been accorded tax exempt status in New Zealand and Australia but is liable to taxation on investment income in some other overseas countries. Tax on overseas income is accounted for as a reduction of that income.

Comparatives

Certain comparatives have been restated for disclosure purposes.

Changes in Accounting Policies

There have been no material changes in accounting policies during the period.

1. Statement of Accounting Policies

Basis of Reporting
