Anglers Notice for Fish and Game Regions

Conservation Act 1987

Freshwater Fisheries Regulations 1983

Pursuant to section 26R (3) of the Conservation Act 1987 the Minister of Conservation approves the following Anglers Notice, subject to the First, and Second, Schedules of this Notice, for the following Fish and Game Regions;

Fish and Game Region

Northland Auckland/Waikato Hawke's Bay Wellington Nelson/Marlborough North Canterbury West Coast Central South Island Southland

Notice

This Notice shall come into force on the 1st day of October 1996.

FIRST SCHEDULE

1. Interpretation

Words and expressions in this notice which are defined in the Conservation Act 1987 or the Freshwater Fisheries Regulations 1983, shall be so defined.

- "Artificial fly" means any lure of feather, fur, wool or other material of any kind customarily used in the making of artificial flies, but does not include any lure in the tying of which lead or other weight has been incorporated unless the hook used in that lure does not exceed 14 mm in length (being the horizontal straight line distance from the rear of the eye, exclusive of the eye, to the rear of the bend) and the gape (being the distance from the point of the hook to the underside of the nearest part of the hook shank above the point) of the hook does not exceed 6 mm.
- "Artificial minnow" includes spoonbait, any feather lure in the tying of which lead or other weight has been incorporated to facilitate the casting or sinking of the lure, and any lure which incorporates a spinning device or a device to impart a wobbling or irregular motion to the lure.
- "Bait", or "natural bait" means any lure that is neither an artificial fly nor artificial minnow.
- "Boat" includes any launch or other vessel; and also includes any canoe, punt, float tube or raft, and any aircraft or hovercraft on the surface of the water.
- "Fishing" and "fish" in this Notice means;
 - (a) The catching, taking, or harvesting of freshwater fish; and
 - (b) Includes—
 - (i) Any other activity that may reasonably be expected to result in the catching, taking, or harvesting of freshwater fish:
 - (ii) Any attempt to catch, take or harvest freshwater fish:
 - (iii) Any operation in support of, or in preparation for, any activity described in this definition.
- "Taking" means "fishing", and "takes" and "to take" have a corresponding meaning.
- "Foulhook" means to take a fish with a hook or hooks otherwise than from within the mouth.
- "Lure" means any artificial or natural fly and any artificial minnow.

- "Size" and/or "length" is the measurement from the tip of the snout to the tip of the tail.
- "Sports fish" means those freshwater fish described in the First Schedule of the Freshwater Fisheries Regulations 1983, namely;

Brown Trout
Rainbow trout
American brook trout or char
Lake trout or char
Atlantic salmon
Quinnat or chinook salmon
Sockeye salmon
Perch
Tench

Rudd (Auckland/Waikato Fish & Game region only).

"All year" means a 12 month period commencing on 1 October and concluding on 30 September of the following year, both days inclusive.

2. Authorised Tackle

- 2.1 No licence holder shall fish for sports fish except by using a rod and running line.
- 2.2 Nets:
- 2.2.1 When playing a sports fish a landing net may be used to secure or land that fish.
- 2.2.2 For keeping non-salmonid sports fish alive a keep net may be used in the water from which the fish was caught.
- 2.2.3 For taking indigenous fish for bait angling. A bait net may be used.
- 2.2.4 It shall be a defence for any licence holder charged with a breach of this clause if that licence holder proves that he or she was netting for indigenous fish in accordance with the provisions of any regulation or notices in force in that behalf.
- 2.3 No licence holder shall fish for sports fish, or have under his or her control, more than one assembled rod and running line.
- 2.4 No licence holder shall fish for sports fish unless within 15 metres of the rod being used and is able to see the rod.
- 2.5 No licence holder when fishing for sports fish shall use:
- 2.5.1 More than 2 lures or baits.
- 2.5.2 Any lead or weight (other than hooks as permitted elsewhere in this notice) attached below or as to hang below any lure or bait.
- 2.5.3 Any bait or lure treated with any medicinal or chemical preparation other than oil used solely to give buoyancy to an artificial fly.
- 2.5.4 Any hook which has a gape greater than 14 mm between the point and the nearest part of the shank.
- 2.5.5 Any wire line.
- 2.5.6 The above restrictions of clause 2.5 shall not apply to licence holders fishing in the following Fish and Game Regions;

Wellington Nelson/Marlborough West Coast Central South Island

2.6 Hooks:

2.6.1 No lure or bait having more than one hook or having a multiple hook, or any fixed assembly of hooks, can be used in these Fish & Game regions:

Northland Auckland/Waikato Hawke's Bay

2.6.2 In all other Fish & Game regions, notwithstanding the foregoing clauses, any combination of hooks may be used.

3. Prohibition on Unauthorised Fishing Tackle, etc

The following items are prohibited when fishing for sports fish:

- 3.1 any paravane
- 3.2 any stroke hauling or foulhooking gear
- 3.3 any spear
- 3.4 any narcotic, poisonous substance or liquid injurious to

4. Prohibition of Possession or Control of Spear Gun

- 4.1 No licence holder, when fishing for sports fish, shall be in possession, or be in control, of any spear gun or any pointed missile (other than a bullet) which is propelled by means of any mechanical or explosive device.
- 4.2 Where any licence holder is charged with an offence under subclause 4.1 it shall be a defence to the charge if the defendant proves that the speargun or pointed missile in the defendant's possession or under the defendants control was not used in fishing for sports fish.
- 4.3 In this notice "explosive:" has the same meaning as in the Explosives Act 1957.

5. Foul Hooking of Fish

- 5.1 No licence holder shall attempt to foul hook any sports fish.
- 5.2 Any licence holder who lands a foul hooked sports fish shall return it immediately to the water alive with as little injury as possible.

6. Minimum Length

Every licence holder taking a sports fish which does not equal or exceed the specified minimum length shall immediately return it with as little injury as possible into the water from which it was taken.

7. Maximum Length

Every licence holder taking a sports fish which exceeds a specified maximum length shall immediately return it with as little injury as possible into the water from which it was

8. Open Season

No licence holder shall fish for, take or attempt to take, any sports fish except during an open season.

9. Authorised Lures and Baits

Authorised lures and baits are:

Artificial or natural fly

Artificial or natural insect

Artificial or natural worm

Artificial or natural crustacea

Artificial or natural minnow

Artificial or natural fish (excluding fish ova, or any portion of a fish, or shellfish [mollusca])

Uncoloured bread dough

Artificial mouse

Artificial frog

Regional restrictions on using the above, as noted in Schedule Two, will apply.

4. Coarse Fishing

4.1 Fishing Competitions—Rods

A licence holder participating in a fishing competition for perch, tench or rudd may have two assembled rods and running line provided only one of which shall be used for fishing at any one time.

4.2 A roach pole may be used to fish for and take perch, tench or rudd.

5. Fishing Restrictions

5.1 No licence holder shall fish for sports fish from any vessel not securely anchored in that part of the Waikato River between the Arapuni Dam and the upper limits of Lake Karapiro (as shown by the white marker post, situated 200 metres below the Huihuitaha Stream mouth).

6. Artificial Fly Only Waters

6.1 No licence holder when fishing for sports fish shall use any lure or bait other than artificial fly in the following waters and all their tributaries;

Wairoa River from its source to the Hunua Falls

Awakino River from its source to the Mahoenui Bridge Waipa Stream from its source to the Horahora Road Bridge (which is deemed to be the mouth)

7. Spoonbait, Artificial Minnow or Artificial Fly Only Waters

No licence holder when fishing for sports fish shall use any lure or bait other than spoonbait, artificial minnow or artificial fly in the following waters, rivers, streams and their tributaries excluding any waters specified in sections 6 and 8 of this schedule:

8.2 Any licence holder may use any bait (excluding any fish ova or any portion of a fish or any shellfish (mollusca)) in the following waters;

All lakes and ponds, excluding any waters specified in sections 7 and 8.1 of this part of this notice.

8.3 Any licence holder, fishing on any water and participating in a fishing competition for rudd, perch and tench, may with the written authority of the Manager of the Auckland/Waikato Fish and Game Council in the licence holders possession and available for production on demand, use any bait (excluding any fish ova or any portion of a fish or any shell fish (mollusca)) but not otherwise.

Provided that nothing in this section 7 shall apply with respect to any licence-holder fishing for perch in Lake Te Pohue.

ANGLERS (EASTERN FISH AND GAME REGION) NOTICE 1996

Pursuant to section 26R (3) of the Conservation Act 1987, the Minister of Conservation approves the following Anglers Notice for the Eastern Fish and Game Region

Notice

- 1. Title and commencement—This notice may be cited as the Anglers (Eastern Fish and Game Region) Notice 1996 and shall come into force on the 1st day of October 1996.
- 2. Interpretation—Words and expressions in this notice which are defined in the Conservation Act 1987, or the Freshwater Fisheries Regulations 1983, shall have the meaning as defined with additional expressions defined below:

This Anglers Notice shall apply to the Eastern Fish and Game Region, as defined by *Gazette*, No. 83, page 1861, 24 May 1990 (SO Plan 58495).

- "Boat" includes any vessel, launch, canoe, punt, float tube, raft, aircraft or hovercraft.
- "Foulhook", in relation to any fish means to take the fish with a hook otherwise than through the mouth.
- "Landmark" means a black and yellow ringed post or buoy.
- 3. Open Season—(1) Sports fish may only be taken from any waters during the open season provided for those waters.
- (2) In all waters except those listed in sub clauses 3 (3), (4) and (5) below, the open season shall be from the 1st day of October in any year to the 30th day of June in the following year (both days inclusive).
- (3) In the waters known as:
 - (a) the waters between landmarks approximately 150 metres downstream of the Lake Tarawera Outlet and the falls approximately 2500 metres downstream from the outlet;

the open season shall be from the 1st day of October in any year to the 31st day of May in the following year (both days inclusive).

- (4) In the waters known as:
 - (a) those rivers and streams flowing into Lake Rotorua (excluding those waters listed in clauses 3 (5) (u) and (v) and 4 (1) (b) and (c));
 - (b) those rivers and streams flowing into Lake Waikaremoana;

the open season shall be from 1st day of December in any year to the 30th day of June in the following year.

- (5) In the waters known as (and excluding tributaries):
 - (a) Lake Maraetai, Whakamaru, Atiamuri, Ohakuri, Aratiatia up to Huka Falls;
 - (b) the Tiniroto and Putere Lakes;
 - (c) Lake Rotorua except those waters which lead into the Ohau Channel and which are inwardly bounded by landmarks;
 - (d) lakes Okareka, Rotoehu, Rerewhakaaitu, Okaro, Ngahewa, Ngapouri, Rotomahana, Tikitapu;
 - (e) Lake Rotoma except the following areas:
 - (i) the waters between landmarks situated at Anaputa Point to the boat ramp at Matahi Lagoon and extending from that shoreline for a distance of 100 metres into Lake Rotoma;
 - (ii) the waters situated between the landmarks situated at the location known commonly as Manawahe Bay and extending from the shoreline for a distance of 100 metres into Lake Rotoma;

- (f) that part of Lake Tarawera abutting the western shoreline between landmarks at either end of the beach known as the Te Wairoa landing and extending from that shoreline for a distance of 100 metres into Lake Tarawera;
- (g) that part of Lake Rotoiti abutting the southern shoreline between landmarks situated at Ruato and Hinehopu extending from that shoreline for a distance of 100 metres into Lake Rotoiti;
- (h) that part of Lake Okataina abutting the northern shoreline between landmarks situated at Te Koutu Point and west of the Okataina lodge and extending from that shoreline for a distance of 100 metres into Lake Okataina:
- (i) the Kaituna River downstream of the Lake Rotoiti flow control structure;
- (j) the Tarawera River downstream from the Tarawera Falls:
- (k) the Whakatane River downstream of its confluence with the Owaka Stream;
- (1) the Waimana River downstream of the Reid Road bridge;
- (m) the Wairoa River downstream of the Te Reinga Falls;
- (n) the Waikaretaheke River below the Piripaua powerhouse;
- (o) Lake McLaren and the Ruahihi Canal;
- (p) the Wairoa River below Lake McLaren;
- (q) Lakes Matahina, Flaxy, Aniwhenua, and the Aniwhenua, Flaxy, and Wheao canals, including the Wheao River downstream of the powerhouse;
- (r) the Rangitaiki River downstream of its confluence with the Otamatea Stream (excluding that section of the river 80 metres downstream of the Aniwhenua Barrage as specified in clause 4 (1) (e);
- (s) Lake Waikaremoana;
- (t) Lake Waikareiti
- (u) the Ngongotaha, Waiteti, Hamurana and Awahou streams below the main-road bridges;
- (v) the Utuhina Stream below the Lake Road bridge;
- (w) the Waiau River downstream of its confluence with the Waikaretaheke River;
- (x) the Waioeka River below it's confluence with Cruen Creek (Aro Aro Bridge);

the open season shall be from the 1st Day of October in any one year to the 30th of September in the following year.

- **4. Closed season** —(1) In the waters known as:
 - (a) all streams that flow into Lake Tarawera and that portion of the Tarawera River enclosed by landmarks and extending approximately 150 metres downstream from landmarks at the river mouth to landmarks within the river, otherwise known as the Tarawera Outlet trout spawning sanctuary;
 - (b) the Utuhina Stream above the Pukehangi Road bridge and all tributaries of this stream;
 - (c) the following streams and their tributaries which flow into Lake Rotorua:
 - (i) the Waiowhiro, Waiohewa, Waingaehe, Waimata and Waikuta streams;
 - (ii) the Hamurana stream above the main-road bridge;
 - (iii) the Awahou Stream above the main-road bridge;
 - (d) all springs, streams, and their tributaries which flow into or from the following lakes:

- (i) lakes Rotoma, Rotoehu, Rotomahana, Rerewhakaaitu, Rotokakahi, Okareka and Okataina;
- (ii) Lake Rotoiti, except the Ohau Channel and the Kaituna River;
- (e) the Rangitaiki River for a distance of 80 metres below the Aniwhenua Barrage;
- (f) all waters in which trout are held in captivity for display, rearing, or other purposes, or from within a distance of 80 metres from such waters or other such distances as defined by landmarks;

the closed season shall be from the 1st day of October in any one year to the 30th of September in the following year.

- 5. Fishing prohibited between 12 midnight and 5 a.m.—No licence holder shall fish for, take or attempt to take, any sports fish between 12 midnight and 5 a.m.
- **6. Authorised Tackle**—(1) No licence holder shall fish for, take or attempt to take, any sports fish except by using a single rod and running line.
- (2) Notwithstanding subclause (1) of this clause, when landing a sportsfish, a hand-held landing net may be used to secure or land any such fish.
- (3) No licence holder shall use:
 - (a) more than 2 separate lures or hooks;
 - (b) any double or treble pointed hook or any multiple hook assembly;
 - (c) any gaff or landing hook;
 - (d) any hook having a gape greater than 14 mm, measured from the point of the hook to the nearest point of the shank;
 - (e) any hand-line, stroke hauling gear, spear gun, paravane, firearm, explosive, spear, net (excluding landing net as outlined in subclause 2 of this clause); trap or any unsportsmanlike device or gear;
 - (f) any electric fishing gear, except for the purposes of duly authorised scientific investigations or data collection;
 - (g) any poison or medicinal or chemical compound other than a preparation used solely to float or sink a fly or line;
 - (h) any preparation to attract fish;
 - (i) any metal cored line or downrigger;
- (4) Notwithstanding subclause 6 (3) (i) any metal cored line may be used in the waters of Lake Rotoma or those parts of Lake Okataina or Lake Tarawera which lie outside of a radius 300 metres from the centre of the mouth or mouths of every stream, spring or river flowing into or out of either of these lakes, or that part of Lake Tarawera which lies outside a line, the ends of which are shown by landmarks on the shore, and which is 200 metres from, and parallel to, the shores of Kariri Point and Rangiuru Bay.
- (5) No licence holder shall foulhook or attempt to foulhook any trout.
- 7. Daily Bag limit—(1) No licence holders shall on any one day kill or have in his or her possession:
 - (a) more than two trout from the Ruakituri river and tributaries above the Waitangi Falls, and the Horomanga river and tributaries;
 - (b) any male trout from within a radius of 200 metres from the centre of the mouth of the Te Wairoa Stream, Lake Tarawera;
 - (c) more than two trout from Lake Aniwhenua;
 - (e) more than two brown trout in a daily bag limit of eight trout from Lake Waikaremoana;
 - (f) more than eight trout in all other waters.

- (2) Any licence holder taking a male trout within 200 m radius of the mouth of the Te Wairoa Stream shall return it to the water immediately.
- 8. Minimum and maximum sizes to be taken—(1) No licence holder shall take, kill, or have in his or her possession any trout of a length measured from the tip of the nose to the tip of the tail which is:
 - (a) less than 35 cm if taken from:
 - (i) lakes Rotorua, Okataina, Rotoma, Rotoehu, Okareka, Rotomahana, Rerewhakaaitu, Tikitapu, Ngapouri, Ngahewa, Waikaremoana, Waikareiti, Whakamarino, Kaitawa or their tributaries;
 - (ii) Lake Rotoiti, the Ohau Channel and the Kaituna River above the flow control structure;
 - (iii) Lake Tarawera including that section of the Tarawera River between the downstream end of the trout spawning sanctuary at the Tarawera Outlet (clause 4 (1) (a)) and the falls approximately 2500 metres downstream from the Outlet;
 - (b) less than 30 cm if taken from all other waters not specified in sub clause 8(1)(a);
 - (c) more than 60 cm if taken from the Ruakituri River and tributaries above Waitangi Falls.
- (2) Every licence holder taking a sportsfish which is less than the minimum length (as outlined in clause 8 (1) (a) and (b)) or which exceeds the specified maximum length (as outlined in clause 8 (1) (c)) shall return it to the water immediately.
- (3) Nothing in this clause shall forbid the taking of sportsfish less than 35 cm in length during "special fishing days" conducted at the Ngongotaha hatchery.
- **9. Restrictions on the use of boats**—(1) No licence holder shall take trout from a boat in the following waters:
 - (a) the Tarawera River from its outlet from Lake Tarawera to the falls situated approximately 2500 metres downstream;
 - (b) that section of the Tarawera Outlet enclosed by landmarks;
 - (c) in the designated winter shoreline fishing areas (clauses 3 (5) (f), (g), (h)) on lakes Tarawera, Rotoiti and Okataina, from the 1st day of July to the 30th day of September;
 - (d) the Ohau Channel and those sections in lakes Rotorua and Rotoiti that are within a 100 metre radius from the centre of the Ohau Channel as indicated by landmarks.
- (2) No licence holder shall take trout from any boat in:
 - (a) waters reserved for artificial fly fishing as specified in clause 10 (3), or within waters contained within a 300 metres radius around the centre of the Utuhina stream mouth, unless the boat is securely anchored with no more than two anchors;
- 10. Restriction on lures—(1) No licence holder shall take sports fish unless he or she only uses authorised lures.
- (2) Authorised lures are:
 - (a) artificial fly—weighted flies must not exceed size 8 on the "Redditch" scale;
 - (b) artificial minnow—must not exceed 40 grammes in weight;
 - (c) natural fly-fly, insect, crustacean (excluding koura);
- (3) Only artificial fly shall be used in the following waters:
 - (a) the Ohau channel;
 - (b) the Tarawera River from its outlet (excluding the trout spawning sanctuary (clause 4.a.) to the falls approximately 2500 m downstream;
 - (c) that section of Rangiuru Bay defined by landmarks;

- (d) all waters contained within a 300 metre arc around the centre of every stream, spring, or river flowing into or out of the following lakes: Rotoiti; Tarawera; Okataina; Rotoma; Rotoehu; Waikaremoana;
- (e) all waters flowing into Lake Rotorua excluding the Utuhina Stream downstream of Lake Road Bridge where artificial minnow may also be used;
- (f) all waters contained within a 300 metres are around the centre of every stream, spring, or river flowing into or out of Lake Rotorua, excluding the Utuhina stream:
- (g) the Horomanga River and tributaries;
- (h) the Hopuruahine, Aniwaniwa, Korokoro and Mokau streams and all tributaries of these streams;
- (i) the Ruakituri and Hangaroa rivers (including their tributaries) upstream from their confluence;
- (j) the Waioeka River (including tributaries) upstream from its confluence with the Opato Stream, including the Opato Stream;
- (k) Lakes Whakamarino and Kaitawa (including all inflowing streams);
- (1) the Waimapu Stream.
- (4) Artificial fly, natural fly, artificial minnow can be used in all waters not specified above (clause 10 (3)) and excluding all closed waters (clause 4).
- 11. Revocation—The notice published in the New Zealand Gazette, 1990, No. 151, pages 3205–3208, title Eastern Fish and Game Region District Anglers Notice 1990, as amended by Amendments One, Two, Three and Four, is hereby revoked.

(c) Season:

1 November to 30 April

Specified waters:

Those rivers and streams flowing into Lake Mahinerangi.

All rivers and streams flowing into Lake Dunstan NOT being waters specified in 3(b).

(d) Season:

1 November to 31 May

Specified waters:

Upper Manorburn Dam

All rivers and streams flowing into all lakes in the Clutha River catchment upstream from the Clyde Dam NOT being waters specified in 3 (c).

(e) Season:

1 October to 31 May

Specified waters:

Diamond Creek:

Lake Mahinerangi:

All other waters in the Clutha River catchment upstream from the Clyde Dam NOT specified elsewhere in clause 3.

- (2) No person shall fish for, take or attempt to take, any sports fish except during an open season.
- 4. Closed Season—(1) Fishing for sports fish is not permitted at any time in the following specified waters:

Bullock Creek, from Lake Wanaka to source:

Horne Creek, from Lake Wakatipu to source:

Lake Wanaka, within 150 metres of any part of the launch wharf at the township of Wanaka:

Lake Wanaka, within 100 metres of any part of the wharf at the Wanaka Marina:

Lake Wakatipu, within the waters of Queenstown Bay bounded by a straight line drawn from the outermost point of the Tourist Park to the point where the south bank of One Mile Creek meets Lake Wakatipu:

Lake Wakatipu, within 100 metres of any part of the wharf in Black Bay (commonly known as the Walter Peak Jetty):

Mill Creek (which flows into Lake Hayes), from the Speargrass Flat Road bridge to the source:

All waters in which sports fish are held in captivity for display, hatching, or other purposes, or within a distance of 100 metres from any part of the outer boundaries of such waters.

- 5. Authorised Tackle—(1) Fishing for sports fish is not permitted except by using one rod and running line, provided that when playing a sports fish, a landing net or gaff may be used to secure or land any such fish.
- (2) No person shall, when fishing for sports fish, use or be in control of, more than one assembled rod and running line at any one time.
- (3) No person shall fish for sports fish unless within 15 metres of the rod being used, and with the rod under that person's visual observation.
- 6. Restriction on Lures, Baits and Areas—(1) Subject to subclause (2), (3), (4), (5) and (6) of this clause, authorised lures and baits are any natural or artificial fly, worm, crustacean, frog, mouse, insect, minnow or fish (excluding fish ova or any portion of a fish or any shellfish mollusc, provided that the shell of any mollusc may be used in the preparation of an artificial minnow).
- (2) No person when fishing for sports fish shall use—
 - (a) More than 3 lures or baits:
- (b) Any bait or lure treated with any chemical preparation other than—
 - (i) In the case of artificial fly, preparations used solely to give buoyancy to such flies: and
 - (ii) In the case of natural baits, a formalin or other preservative preparation:
- (c) On or in conjunction with any fly, minnow, or other lure, any single, double, or treble hook, any one hook of which has a greater distance than 14 mm between the point and the nearest part of the shank of the hook.
- (d) In any waters in which only artificial fly is permitted, any wooden or plastic bubble with or without water, or weight other than the necessary weight of line to cast any artificial fly.
- (3) No person when fishing for sports fish shall use any lure or bait other than natural or artificial fly in the following waters:
- (a) Deans Bank, meaning that portion of the Clutha River lying downstream between a point indicated by a Black and Yellow landmark post approximately 600 metres from the outlet of Lake Wanaka, and a point indicated by a Black and Yellow landmark post, approximately 600 metres above the bridge at Albert Town.
- (b) All rivers and streams flowing into Lake Wakatipu, except the Dart River and the Rees River and their tributaries.
 - (c) Nevis River.
- (4) Subject to subclause (5), no person when fishing for sports fish shall use any lure or bait other than artificial fly or lure in the following waters:
- (a) Clutha River catchment upstream from Lake Dunstan:
 - (b) Sullivans Dam:
 - (c) Southern Reservoir:
- (5) Notwithstanding the above all methods are permissible in the following waters:
 - (a) Clutha River, from Luggate Bridge to Lake Dunstan:
 - (b) Lake Hayes and all streams flowing into or out of:

- (c) Lake Hawea:
- (d) Lake Johnson:
- (e) Kawarau River:
- (6) All methods are permissible in all other waters within the region other than (3) & (4).
- 7. Prohibition on Unauthorised Fishing Tackle, Etc.—No person shall, when fishing for sports fish, use or be in possession or control of, or convey or cause to be conveyed to the vicinity of any place where that person is fishing or proposes to fish, any stroke-hauling or foul-hooking gear, or any spear.
- 8. Restrictions on Use of Boats—(1) No person shall fish from, or tow any lure from, any mechanically propelled boat on: Lake Dispute, Lake Hayes, Lake Johnson, Moke Lake or Reid Lake.
- (2) No person shall fish from a boat on Lake Kirkpatrick.
- (3) Subject to subclause (4) of this clause, no person shall troll from a mechanically propelled boat within 100 metres of any person fishing from the shore.
- (4) No person in fishing for sports fish shall troll from any boat in any river or stream except the Taieri River downstream from Henley Ferry bridge, and the Clutha River downstream from Balclutha.
- 9. Daily Limit Bag—(1) Except in the case of perch for which there is no daily limit and trout from Lake Onslow, McKellar and Sylvan for which there is no bag limit, no person shall on any one day take and kill or be in possession of more than the prescribed daily limit from the following specified waters:

- (a) Lochy River special catch and release zone (being that portion of the river from its source to its confluence with the Longburn). Routeburn River
- Nil. Sports fish caught within these waters must be immediately released into the water from which it has been taken.
- (b) Rivers and tributaries flowing into any of the lakes Hawea; Wanaka; Wakatipu, and (but excluding the catch and release zones); Upper Fraser River: Nevis River; Southern Sullivans Reservoir; Dam; and Von Lake:
- No more than one sports fish per day

- (c) Blakelys Dam; Coalpit Dam; Diamond Lake; Hoffmans Dam; Lake Johnson: Kirkpatrick; Mathias Dam; Pomahaka River upstream from Park Hill Bridge: Reid Lake; Rutherfords Dam; and Tomahawk Upper Lagoon:
- No more than three sports fish per day

(d) Elsewhere in Otago Region other than 9 (a), (b), (c) and (d) and down stream of the Roxburgh Dam and all coastal rivers. No more than two salmon.

- (2) Subject to the restrictions set out in 9 (1) above, no person shall on any one day take or kill or be in possession of more than six sports fish per day.
- 10. Minimum Size to be Taken—(1) No person shall take or be in possession of any trout or salmon which does not exceed in length—
- (a) In the case of any trout taken from the 20 cm. Water of Leith and Teviot River,
- (b) In the case of salmon taken from the 45 cm. Water of Leith,
- (c) In the case of trout or salmon taken from 25 cm any other water,
- (e) In the case of trout for Lakes Onslow, no size limit.
 (f) In the case of perch, no size

- (2) Every person taking a trout or salmon which does not exceed the specified length shall immediately return it with as little injury as possible into the water from which it was taken. In no limit areas, all fish take must be removed from the lake margins.
- 11. Revocation—The notice published in the supplement to the *Gazette*, No. 89 of 1 September 1994, commencing on page 2700, titled District Anglers (Otago Fish and Game Region) Notice 1994, and amendment No.1 are hereby revoked.
