The reason that I have terminated the investigation is because I am satisfied under section 11 (1) (b) of the Act that, as a result of investigations carried out, there is insufficient evidence that material injury to a New Zealand industry has been or is being caused or is threatened by means of the subsidisation of the goods.

- (c) once an item of social rehabilitation has been provided for 6 months under paragraph (b) of this direction, ACC must report to the Minister for ARCI on the payments or provision in respect of that item of social rehabilitation other than as authorised by regulations. The report must be provided to the Minister within 2 months of the item of social

rehabilitation having been provided under paragraph (b) for 6 months.

Matter at Inquiry

The authority has completed an assessment of the following application and now seeks comments on the draft variation to the Food Standards Code.

Animal Protein in Canned Foods for Infants and Young Children (A281). To delete clause (7) of Standard R5—Canned Foods for Infants and Young Children. This clause imposes compositional and labelling requirements related to protein content on foods where a reference is made to a source of animal protein. There are no restrictions on protein content in canned infant foods in the New Zealand regulations.

Matter Before Council

The authority has completed an inquiry into the following application and has recommended to the council the adoption of a draft variation. The authority will now hold a further inquiry into this matter in New Zealand and will make a further recommendation to the council on the issue following this consultation.

Cadmium in Rice Crackers (A208). To enable the applicable maximum permitted concentration (MPC) of cadmium in food to take into consideration the proportion of water removed during the manufacture of food—draft variation to Standard A12—Metals and Contaminants in Food.

The New Zealand regulations specify that the permissible proportion of cadmium in any food other than shellfish is 1 mg/kg.
