- (vii) To empower members of the community so that they may share in decisions regarding the education of their children and assist in the learning process.

5. Constitution of the Board of Trustees. The Board of Trustees of Te Kura Kaupapa Maori O Te Matai shall comprise:

- (a) Five people appointed by the Minister.
- (b) The principal.
- (c) A staff representative.
- (d) Not more than four persons co-opted by the board.
