#### Early Childhood Education Charter Guildelines: Statement of Desirable Objectives and Practices

#### Introduction:

Pursuant to section 312 (2) of the Education Act 1989, as inserted by the Education Amendment Act 1990, the Minister of Education hereby specifies the following desirable objectives and practices for early childhood education.

This document is the revised Statement of Desirable Objectives and Practices, which, on 1 April 1998, will replace the Statement of Desirable Objectives and Practices *Gazetted* on 6 December 1990, No. 2131, page 4582. Under section 312 of the Education Act 1989, the Statement of Desirable Objectives and Practices (DOPs) is deemed to be a part of the charter of every chartered early childhood centre and chartered care arranger. The purpose of the DOPs is to establish national criteria for the provision of quality early childhood education and care. It is the responsibility of the management<sup>1</sup> of chartered early childhood services<sup>2</sup> to ensure that all the requirements of the DOPs are met, and it is the responsibility of the management and educators<sup>3</sup> to determine how they are met. A supporting document for the DOPs will provide examples of standards of quality which demonstrate achievement of the requirements. Management and educators should be able to demonstrate achievement of the requirements to a standard consistent with the examples of standards in the supporting document and consistent with the example of quality curriculum set out in *Te Whāriki: He Whāriki Mātauranga mō ngā Mokopuna o Aotearoa—Early Childhood Curriculum (1996).* 

#### Guiding Principles:

Management and educators of chartered early childhood services, in partnership with parents/guardians and whanau, will promote and extend the learning and development of each child attending or receiving the service, through the provision of quality early childhood education and care.

Educators will develop and implement curriculum which assists all children to grow up as competent and confident learners and communicators, healthy in mind, body and spirit, secure in their sense of belonging and in the knowledge that they make a valued contribution to society.

#### Learning and Development

1. Educators should enhance children's learning and development through:

- (a) relationships and interactions which are responsive, reciprocal, positive and encouraging;
- (b) extending children's thinking and actions through sensitive and informed guidance, interventions and support;
- (c) respecting children's preferences and involving children in decisions about their participation in activities;
- (d) planning and evaluating the physical environment and providing resources to support the needs of each child and to facilitate quality curriculum and interactions;
- (e) modelling non-discriminatory behaviour and promoting this with children;
- (f) implementing strategies to include all children.

2. Educators should demonstrate understanding of current theory and principles of learning and development and of the different characteristics of infants, toddlers and young children.

3. Educators should demonstrate knowledge and understanding of the learning and development of each child, identify learning goals for individual children, and use this information as a basis for planning, evaluating and improving curriculum programmes.

4. Educators should implement curriculum and assessment practices which:

- (a) reflect the holistic way that children learn;
- (b) reflect the reciprocal relationships between the child, people and the learning environment;
- (c) involve parents/guardians and, where appropriate, whanau;
- (d) enhance children's sense of themselves as capable people and competent learners.

5. Educators should plan, implement and evaluate curriculum for children in which:

- (a) their health is promoted and emotional well-being nurtured; and they are kept safe from harm;
- (b) connecting links with the family and the wider world are affirmed and extended; children know they have a

place and feel comfortable with routines, customs and regular events; and children know the limits and boundaries of acceptable behaviour;

- (c) there are equitable opportunities for learning for each child, irrespective of gender, ability, age, ethnicity or background; children are affirmed as individuals; and children are encouraged to learn with and alongside others;
- (d) children develop verbal and non-verbal communication skills for a range of purposes; children experience the stories and symbols of their own and other cultures; and children discover and develop different ways to be creative and expressive;
- (e) children's play is valued as meaningful learning and the importance of spontaneous play is recognised; children gain confidence in and control of their bodies; children learn strategies for active exploration, thinking and reasoning; and children develop working theories for making sense of the natural, social, physical and material worlds.

#### Communication and Consultation:

6. Management and educators should ensure that communication and consultation with each other and with parents/guardians, whanau, hapu, iwi and local communities acknowledge and respect all parties' values, needs and aspirations.

7. Educators should seek information and guidance from specialist services where appropriate, to enable them to work effectively with children and their parents/guardians and whanau.

8. Educators should provide opportunities for parents/guardians and, where appropriate, whanau to:

- (a) feel welcome to spend time at the service<sup>4</sup>, discuss concerns and participate in decision-making concerning their child;
- (b) discuss, both informally and formally, their child's progress, interests, abilities and areas for development on a regular basis, sharing specific observation-based evidence;
- (c) have access to information concerning their child, the operation of the service and Education Review Office reports regarding the service.

#### **Operation and Administration:**

9. Management should develop and regularly review a statement of the service's philosophy and the charter, in consultation with educators, parents/guardians and, where appropriate, whanau.

10. Management and educators should implement policies, objectives and practices which:

- (a) reflect the service's philosophy, quality curriculum, current theories of learning and development, the requirements of the DOPs and legislation;
- (b) acknowledge parents/guardians and whanau needs and aspirations for their child;
- (c) reflect the unique place of Maori as tangata whenua and the principle of partnership inherent in Te Tiriti o Waitangi;
- (d) are inclusive, equitable and culturally appropriate;
- (e) are regularly evaluated and modified by an on-going, recorded process of internal review.
- 11. Management should implement:
  - (a) personnel policies which promote quality practices including appointment of competent staff, staff appraisal and professional development for both management and educators;

- (b) employment policies which incorporate the principles of being a good employer, including equal employment opportunities;
- (c) financial management policies which include budgeting to ensure that policies and objectives are met.

12. Management makes the audited annual financial statement available to educators, parents/guardians, whanau, the local community and government, to account for the use of Ministry of Education funding.

This notice comes into force on the 1st day of April 1998.

#### Notice Pursuant to Section 24

#### Inquiry into Transitional Arrangements for the Australia New Zealand Food Standards System

In June 1996, the then National Food Authority undertook a full assessment of proposal P137 under section 23 of the National Food Authority Act 1991 (the Act) and prepared a new standard, Standard T1, to implement the transitional arrangements contained in the agreement between Australia and New Zealand establishing a system for the development of joint food standards.

On 19 June 1996, the authority published a notice indicating that it had decided, under section 37 of the Act, to omit to publish a notice seeking submissions in relation to the draft Standard T1. In that notice the authority stated that it had recommended that the National Food Standards Council adopt Standard T1 as a matter of urgency, in order to avoid comprising the objectives set out in section 10, and in particular the promotion of fair trade in food and the promotion of trade and commerce in the food industry.

On 19 June 1996, the then National Food Standards Council adopted Standard T1 without the authority holding an inquiry. Under sections 37 of the Act, the authority must hold an inquiry into the draft variation as soon as practicable after the council has adopted the draft variation. The authority is now conducting an inquiry into the draft variations, namely Standard T1.

The transitional arrangements contained in Standard T1 mean that foods imported from New Zealand, which comply with the New Zealand Food Regulations 1984, can be sold in Australia, provided they meet Australian requirements relating to residues of agricultural and veterinary chemicals and with Australian requirements

relating to maximum levels of the metal cadmium. These arrangements entered into force from 1 July 1996.

Standard T1 also contains some temporary provisions intended to ensure Australian industry is not disadvantaged by the transitional arrangements pending the development of the Australia New Zealand Food Standards Code. These temporary provisions are being reviewed as part of the inquiry.

The authority invites written submissions containing technical or other relevant information which will assist the authority in undertaking the inquiry from interested individuals and organisations by 23 October 1996.  $_{200}^{6400}$ 

#### Australia New Zealand Food Authority— Food Standards

#### Matters at Full Assessment

The authority has made a preliminary assessment, has accepted the following proposal and will now make a full assessment.

**Proposed food hygiene standard (P145).** The authority developed a proposal to introduce a new, national food hygiene standard to apply to all food businesses in Australia covered by the Food Standards Code. Although this proposal would not apply directly to primary food production, it would eventually have implications for this sector.

Food hygiene regulations are outside the food standard setting system the authority currently administers. They are presently developed and enforced separately by the states and territories.

The proposed food hygiene standard would require all food businesses, that can identify one or more food safety hazards, to develop and implement a food safety programme. The detail and scope of these programmes would vary according to the size and nature of the business and the level of risk posed to the community.

The proposed standard would promote a preventative rather than a reactive approach to food safety and ensure the same hygiene requirements operate throughout Australia. Implementation of the standard would be phased in over a 6-year period using criteria based on the risk classification of food businesses.

Xylanase in baked products including bread (A304). Received on 25 March 1996, from Novo Nordisk Bioindustrial Pty Limited this application seeks approval for use of the enzyme hemicellulase endo-1,4-beta-xylanase (EC 3.2.1.8) in baked goods, including bread.

Hemicellulase endo-1,4-beta-xylanase (EC 3.2.1.8) is produced using recominant DNA techniques from a strain of *Aspergillus oryzae* carrying the gene coding for the enzyme from *Thermomyces lanuginosus*.

The authority has prepared a draft variation to Standard A16—Processing Aids, to permit the of hemicellulase endo-1,4-beta-xylanase (EC 3.2.1.8) as a processing aid.

Labelling requirements for fermented comminuted meat products (P146). The authority prepared this proposal to introduce new labelling requirements for fermented comminuted meat products.

The authority did not seek submissions on this matter; it has made a full assessment, and prepared draft variations to Standard C1—Meat, Game Meat and Related Products.

#### **Matters Before Council**

The authority has completed an inquiry into the following application and has recommended that the Australia and New Zealand Food Standards Council adopt a draft variation to the Food Standards Code.

**Residues in Food (A283).** This application from the National Registration Authority for Agricultural and Veterinary Chemicals sought to establish Maximum Residue Limits (MRLs) for a number of new chemicals and to delete certain chemicals. The authority prepared draft variations to Standard A14—Residues in Food.

The recommendations, if approved by council, will vary Standard A14 by:

- including MRLs for the new chemicals bromochloromethane, clodinafop-propargyl, clodinafop acid, cloquintocet-mexyl, cloquintocet acid, 4-6 diamino-2-cyclopropylamino-pyrimidine-5-carbonitrile, doramectin, 2-1-(ethoxyimino) propyl-3-hydroxy-5-(3-butyrylmesityl) cyclohex-2-enone, fluquinconazole, fluxofenim, S-hydroprene, lufenuron, metolachlor, pyrithiobac sodium;
- including new MRLs for the chemicals bromoxynil, cyproconazole, difenoconazole, gibberellic acid, imidacloprid, ioxynil, moxidectin, triadimenol, virginiamycin;
- including changes to existing MRLs for the chemicals cyhalothrin, difenoconazole, glyphosate and pyridaben; and
- deleting the chemicals cloquintocet and piroxofop.

#### Papers

The authority periodically publishes discussion and options papers on matters before it to which it seeks written comment. It also publishes policy papers, codes of practice and survey results. All papers are available from the addresses below.

A policy document which provides a broad outline of the use of risk assessment and management practices at the authority is now available. The document, called **Framework for the assessment and management of food-related health risks**, provides an overview of the decision-making processes used for the protection of public health and safety in relation to the consumption of food. These processes are considered to be an integral part of the development of a safe and health food system.

#### Inquiry into transitional arrangements for the Australia New Zealand Food Standards System

The authority completed a full assessment of proposal P137 in June 1996. It prepared a draft standard (T1) to implement the transitional arrangements Australia and New Zealand agreed to which establish a system for developing joint food standards.

The authority published a notice on 19 June 1996, stating that it had recommended that the (then) National Food

Standards Council adopt Standard T1 as a matter of urgency so the promotion of fair trade in food and the promotion of trade and commerce in the food industry was not compromised.

The council adopted Standard T1, without the authority holding an inquiry. The authority (under section 37 of the Act) must now hold an inquiry into the draft variation—namely Standard T1.

The transitional arrangements in Standard T1 will mean that foods imported from New Zealand, which comply with the New Zealand Food Regulations 1984, can be sold in Australia. They must, however, meet Australian requirements concerning residues of agricultural and veterinary chemicals and Australian requirements concerning maximum levels of cadmium. These arrangements came into force on 1 July 1996.

Standard T1 also contains some temporary provisions to ensure Australian industry is not disadvantaged by the transitional arrangements while the Australia New Zealand Food Standards Code is being developed. All aspects of the transitional arrangements, including these temporary provisions, are being reviewed as part of the inquiry.
