# Recommendations From Consultation on ACC Employment Premiums

As required by section 167B of the Accident Rehabilitation and Compensation Insurance Act 1992, ACC has completed consultation with premium payers and has recommended to the Minister for Accident Rehabilitation and Compensation Insurance changes to be made to the Accident Rehabilitation and Compensation Insurance (Employment Premium) Regulations.

These recommendations are summarised as follows:

Premium Rate and Reserve Level Options

Maintain the 1996/97 average employment premium rate of \$2.61 for the 1997/98 premium year.

Sector Based Premium Risk Groups

Maintain the current premium risk groupings within economic sectors for the 1997/98 premium year; and note that a move to pure risk-based groupings will be considered for the 1998/99 premium year and included in the relevant consultation discussion papers.

#### Premium Classification Principles

Retain all the current premium classification principles and adopt an additional principle emphasising the need to ensure that the premium classification system is administered in a cost effective manner.

### Current Premium Classification Rules

Removal of the (-25%) lower transitional cap and review of the (+25%) upper transitional cap during the  $1\overline{997/98}$  premium year.

New Premium Classification Rule

<u>Incorporate</u> a new rule relating to "new activity classifications" into the premium classification rules structure. This new rule will reflect:

- > reviews on an annual basis; and
- $\rightarrow$  premium rates phased in at +/-25% per annum as per rule (c).

Draft Premium Risk Groups/Premium Classification Units Establish a new premium classification unit of "Services to Sports – administration services only" – for activities engaged in providing administration services to sporting activities;

Maintain "Business and Professional Associations" and "Interest Groups" within premium risk group 580;

Establish a new PRG for higher risk sport PCU's and set a higher premium which includes the corporation's judgment of the probable mature accident rate.

- 2. Contract Staff Both Office and Non Office Based;

- 3. Offering a lease of quota in lieu of paying deemed

value—(1) Subject to this clause, as from the date this notice comes into effect, any commercial fisherman who but for section 28ZG of the Fisheries Act 1983, could be required under section 28ZD of that Act to pay the deemed value of any fish that is specified as a bycatch species in this notice, may, not later than 15 days after the end of the month in which the fish were taken, by notice in writing, offer the Chief Executive of the Ministry of Fisheries a lease or sub-lease of the right to take fish, under any quota held or leased by that commercial fisher that are specified in the Schedule to this notice as a target species in relation to that bycatch species.

#### Crimes Act 1961

Reference to the Court of Appeal of the Question of the Conviction of Stephen Karl Collie for Wounding with Intent to Cause Grievous Bodily Harm, Threatening to Kill, and Assault with Intent to Commit Sexual Violation

Whereas on the 29th day of November 1993, Stephen Karl Collie was convicted in the High Court at Auckland on 17 charges against 7 complainants and, on the 21st day of December 1993, was sentenced to a total of 16 years imprisonment:

And whereas Stephen Karl Collie appealed to the Court of Appeal against these convictions and the sentences imposed:

And whereas, on the 3rd day of March 1995, the Court of Appeal allowed the appeal of Stephen Karl Collie against his conviction in respect of one count and dismissed his appeal against conviction in respect of all the other counts: And whereas, on the 19th day of May 1995, the Court of Appeal dismissed the appeal of Stephen Karl Collie against sentence:

And whereas an application, dated the 24th day of November 1995, has been made by Stephen Karl Collie for the exercise of the mercy of the Crown in respect of his convictions with regard to one of the 7 complainants, being the complainant—

- (a) Who gave evidence at the trial of Stephen Karl Collie that she was attacked by him some time between the 15th day of December 1990 and the 15th day of January 1991 and that he inflicted on her a cut on the side of her forehead and a knife wound to her vagina and that she was treated in hospital for these injuries; and
- (b) In respect of whom Stephen Karl Collie was convicted of the offences of wounding with intent to cause grievous bodily harm, threatening to kill, and assault with intent to commit sexual violation,—

who is in this order referred to as "the complainant":

And whereas Stephen Karl Collie was sentenced to 9 years imprisonment for wounding the complainant with intent to cause grievous bodily harm, cumulative on a 7-year sentence imposed for the rape of another of the complainants, and received sentences concurrent with this 16-year term for all the other offences:

And whereas the convictions of Stephen Karl Collie with regard to the complainant followed evidence given at trial that Stephen Karl Collie attacked the complainant some time between the 15th day of December 1990 and the 15th day of January 1991 and that he inflicted on her a cut on the side of her forehead and a wound to her vagina and that the complainant was treated in hospital for these injuries:

And whereas the application by Stephen Karl Collie for the exercise of the mercy of the Crown is made on the grounds that:

- (a) There never was an attack on the complainant as alleged; or
- (b) If there was such an attack, the perpetrator of the offence or offences was not Stephen Karl Collie:

And whereas the application by Stephen Karl Collie for the exercise of the mercy of the Crown makes, in support of these grounds, the submissions (among others) that:

- (a) There is evidence to prove that the offences could not have occurred when alleged in the indictment, raising major doubts as to the credibility of the complainant; and
- (b) There is evidence to prove the unlikelihood of the complainant having been knifed in the vagina and further the unlikelihood of her having received treatment at Auckland Hospital or any other medical care centre:

And whereas Stephen Karl Collie has tendered, in support of his application for the exercise of the mercy of the Crown, the following documents:

- (a) A letter, dated the 2nd day of July 1996, from Auckland Healthcare Services Limited advising (among other things) that the patient records of the Auckland Hospital A & E Department for the relevant period had been searched and that there was no record of a person with the complainant's name, or any of the names sometimes used by her, having been treated during the relevant period and that there was no record of any other person having been treated for knife injuries to the vagina during the relevant period; and
- (b) A copy of the evidence given by the complainant on the 28th day of May 1996 in the District Court at Auckland at the preliminary hearing of a charge of conspiracy to defeat the course of justice then pending against various persons, in which the complainant testifies (among other things) that she did not receive hospital treatment in respect of the attack by Stephen Karl Collie:

And whereas Stephen Karl Collie has also tendered, in support of his application for the exercise of the mercy of the Crown, the following documents (among others):

- (c) A report, dated the 22nd day of November 1995, by Andrew Mackintosh of Auckland, medical practitioner; and
- (d) An affidavit, dated the 17th day of November 1995, by Colin David Mantell of Auckland, medical practitioner; and
- (e) An affidavit, dated the 16th day of November 1995,

by Deborah Lucille Whitley of Auckland, solo parent; and

(f) An affidavit, dated the 16th day of November 1995, by Margaret Rose Ransfield of Rotorua, beneficiary:

And whereas it appears from the documents referred to in paragraphs (a) to (f) that evidence is available that could lead the Court of Appeal to the conclusion that, with respect to the charges alleging offences against the complainant, the trial of Stephen Karl Collie was unsatisfactory and that a miscarriage of justice might have occurred:

Now therefore, pursuant to section 406 (a) of the Crimes Act 1961, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby refers to the Court of Appeal for hearing and determination the question of the conviction of Stephen Karl Collie for the offences of wounding the complainant with intent to cause grievous bodily harm, threatening to kill the complainant, and assaulting the complainant with intent to commit sexual violation.

# Australia New Zealand Food Authority— Food Standards

#### Matters at Inquiry

The authority has completed full assessments of the following applications and will now conduct inquiries.

Artificial flavouring substances (A237). This application, received on 15 December 1994 from the Council of Australian Food Technology Associations (CAFTA), seeks a variation to the Food Standards Code to correct and update the Schedule of permitted artificial flavouring substances in Standard A6—Flavourings and Flavour Enhancers.

On 28 August 1996, the Flavour and Fragrance Association of Australia and New Zealand (FFAANZ) revised CAFTA's application and proposed that artificial flavouring substances should not be specifically listed in the standard. The FFAANZ proposed that Standard A6 should be amended to refer to artificial flavouring

substances which are contained in lists published by the United States Food and Drug Administration, the Flavor and Extract Manufacturers Association and the Council of Europe.

The authority has prepared a draft variation to Standard A6 which will delete the current list of chemical names for permitted artificial flavouring substances and provide references to published lists of flavouring substances that have been assessed for safety.

Ergot in cereal grains (A303). This application, received on 28 February 1996 from The Bread Research Institute of Australia, seeks to amend the Food Standards Code by reviewing clause (5) of Standard 12—Metals and Contaminants in Food, to provide an appropriate and realistic tolerance level for ergot in cereal products.

The authority has prepared a draft variation to Standard A12 to establish a tolerance level for ergot in cereal grain.

# **Matters Before Council**

The authority completed inquiries into the following applications and made recommendations to the Australia

New Zealand Food Standards Council that it adopt draft variations to the Food Standards Code.

Dimethyl dicarbonate (A259). This application, received on 9 June 1995 from Bayer Australia Limited, seeks to permit the use of dimethyl dicarbonate (DMDC) as a cold sterilising agent in alcoholic and non-alcoholic, carbonated and non-carbonated beverages.

The authority has prepared draft variations as amended to Standards A1—Labelling and Advertising, A4—Preservatives, A11—Specifications for Identity and Purity of Food Additives, Food Processing Aids, Vitamins, Minerals and Other Added Nutrients, O4—Soft Drinks and Soft Drink Products, O7—Orange Juice and Related Products, O9—Fruit Drinks and Fruit Drink Products and R9—Supplementary Foods.

The recommendation, if approved by council, will permit the use of dimethyl dicarbonate (DMDC) as a cold sterilising agent in non-alcoholic carbonated and non-carbonated beverages.

Use of processed eucheuma seaweed (A262). This application, received on 22 June 1995 from Goodman Fielder Limited and Woods and Woods Pty Limited, seeks to permit the use of natural grade carrageenan (also known as processed eucheuma seaweed) as an alternate form of carrageenan.

The authority has prepared draft variations to Standards A10—Modifying Agents and A11—Specifications for Identity and Purity of Food Additives, Food Processing Aids, Vitamins, Minerals and Other Added Nutrients to permit the use of processed eucheuma seaweed.

The recommendation, if approved by council, will allow for the addition of processed eucheuma seaweed as a permitted vegetable gum to food during manufacturing.

Deletion of Standard B5—Malt and Malt Extract (A275). This joint application, received on 3 July 1995 from the Council of Australian Food Technology Associations Inc (CAFTA), Nestle Australia Limited, Burns Philp & Co Limited and Coopers Brewery, seeks to delete or amend clauses of Standard B5 of the Food Standards Code.

The authority prepared draft variations to Standard A1—Labelling and Advertising, Standard B1—Cereals, Legumes, Flours, Meals and Bread and Standard K1—Sugar and Related Products and has proposed the deletion of Standard B5—Malt and Malt Extract.

The recommendation, if approved by council will reduce the prescriptiveness of the Food Standards Code and will better meet the needs of industry.

Animal protein in canned foods for infants and young children (A281). This application, received on 19 July 1995 from the Australian Meat and Livestock Corporation (AMLC), seeks removal of clause (7) of Standard R5—Canned Foods for Infants and Young Children. This standard imposes compositional and labelling requirements related to the protein content of such foods where a reference is made in the label, other than in the ingredient list, to a source of animal protein.

The authority prepared draft variations to Standard R5—Canned Foods for Infants and Young Children.

The recommendation, if approved by council, will remove the maximum protein levels which apply when a source of animal protein is named or its presence is implied in a label or advertisement for strained and junior canned foods. It will also require an alternative age suitability statement, 'only suitable for infants aged from six months' in the label of strained infant foods with more than 3 g of protein per 100 kJ.

Calcium disodium ethylenediaminetetraacetate in canned fish (A282). This application, received from Unifoods, a division of Unilever Australia, seeks to vary Standard D2—Canned Fish and Canned Fish Products, to permit the use of calcium disodium ethylenediaminetetraacetate (CaNa<sub>2</sub>EDTA) in canned crustaceans and canned molluscs, at a maximum level of 250 mg/kg. The authority proposed at full assessment to extend the permission to all canned fish, including canned salmon and tuna. According to the Food Standards Code, fish is defined as a fish or part of a fish ordinarily used for consumption by humankind and includes a crustacea or mollusc.

The authority prepared draft variations to Standard D2—Canned Fish and Canned Fish Products, to provide for all canned fish products.

The recommendation, if approved by council, will vary Standard D2 by permitting not more than 250 mg/kg calcium disodium ethylenediaminetetraacetate in canned fish, including salmon and tuna.

Extended use of lysozyme in cheese (A289). This application, received on 5 October 1995 from Chr Hansen Pty Limited and Canadian Inovatech Inc, seeks to extend the use of lysozyme (EC 3.2.1.17) in cheese.

The authority prepared draft variations to Standard H9—Cheese and Cheese Products, and Standard A11—Specifications for Identity and Purity of Food Additives, Food Processing Aids, Vitamins, Minerals and Other Added Nutrients, as amended.

The recommendation, if approved by council, will extend the use of lysozyme (EC 3.2.1.17) to cheeses other than cottage cheese, cream cheese, neufchatel cheese and whey cheese.
