Fisheries (Bycatch Trade-Off) Notice (No. 2) 1997 (No. F57)

Pursuant to section 28ZG of the Fisheries Act 1983, the Policy Manager Central, Ministry of Fisheries (acting pursuant to delegated authority in accordance with section 41 of the State Sector Act 1988), hereby gives the following notice.

Notice

1. Title and commencement—(1) This notice may be cited as the Fisheries (Bycatch Trade-Off) Notice (No. 2) 1997.
(2) This notice shall come into effect the day after the date of its notification in the *Gazette*, and shall expire on the 15th day of July 1997.

2. Interpretation—In this notice:

(a) Any reference to Quota Management Area means the appropriate Quota Management Area as defined in the Fisheries (Quota Management Areas, Total Allowable Catches and Catch Histories) Notice 1986*;

(b) Target species and bycatch species are specified by the way of fishstock codes, being Fishstock Codes defined in the Second Schedule of the Fisheries (Reporting) Regulations 1990†; and

(c) Methods are specified by way of method codes, being Method Codes defined in the Second Schedule of the Fisheries (Reporting) Regulations 1990†.

3. Offering a lease of quota in lieu of paying deemed value—(1) Subject to this clause, as from the date this notice comes into effect, any commercial fisherman who but for section 28ZG of the Fisheries Act 1983, could be required under section 28ZD of that Act to pay the deemed value of any fish that is specified as a bycatch species in this notice, may, not later than 15 days after the end of the month in which the fish were taken, by notice in writing, offer the Chief Executive of the Ministry of Fisheries a lease or sub-lease of the right to take fish, under any quota held or leased by that commercial fisherman that are specified in the Schedule to this notice as a target species in relation to that bycatch species.

(2) The ratios specified in the Schedule to this notice, are the ratios at which a lease or sublease of quota of the target species may be accepted in relation to the amount of the bycatch species for which the offer of quota is made, (e.g. if a fisher could be required to pay deemed value for 1 tonne of Gur 1 and wishes to offer a lease of Fla 1 then the amount that can be offered is 1 tonne \times 0.83 = 0.83 tonnes of Fla 1).

(3) The bycatch species must have been taken while fishing for the target species using the method or any of the methods specified in the Schedule, (e.g. in the case of the above example, the Gur 1 bycatch must have been taken using either the method of danish seine or setnetting).

(4) Any offers that relate to bycatch species as specified in this notice must relate to fishing that has occurred in the months of April, May or June 1997 respectively.

4. Revocation—The Fisheries (Bycatch Trade-Off) Notice (No. 1) 1997 (No. F48) appearing in the *New Zealand Gazette* on 7 February 1997, No. 11, page 255 is hereby revoked.

Income Tax Act 1994 Tax Administration Act 1994

Who Must File a Tax Return?

Notice to File Returns of Income Under the Tax Administration Act 1994 and the Income Tax Act 1994

The Commissioner of Inland Revenue gives notice to those who must file returns under the terms of the Tax Administration Act 1994 and the Income Tax Act 1994, as follows:

1. Returns of income for the year ended 31 March 1997 (or other approved balance date) are required from:

- (a) Every person who received income over \$34,200.
- (b) Every person who received New Zealand Superannuation and more than \$3,412.50 of other income (including 50% of non-taxable pensions).
- (c) Every person who had a Student Loan balance before 31 December 1996, except those who repaid the loan in full by 31 March 1996.
- (d) Every person who was required to pay child support.
- (e) Every person, and the partner of a person who was issued with a Family Assistance Certificate of Entitlement, or received Family Assistance with an income-tested benefit from NZISS and whose family income was over \$20,000.
- (f) Every person who received income that did not have the correct rate of PAYE or RWT deducted from it.
- (g) Every person who used a special tax code (IR 23), or the special shearers' codes SSH or SHR.
- (h) Every person who was an IR 56 taxpayer.
- (i) Every person who received income from withholding payments (IR 13 certificate).
- (j) Every person who received income from business, rents or any other income with no tax deducted before receipt of that income.
- (k) Every company, partnership, estate, trust, Maori Authority or any other incorporated or unincorporated body, that is not:
 - approved by Inland Revenue as fully exempt from income tax; or
 - a non-active company that meets the conditions for and has completed an IR 4NA Declaration.
- (l) Every person who has been asked by Inland Revenue to send in a return.

2. Returns may be filed electronically, posted or delivered to Inland Revenue.

3. Due dates for filing returns of income for the year ended 31 March 1997 are:

- (a) **7 June 1997**, in cases where all income has had tax deducted at the time it was earned or received (i.e. income from salary, wages, benefits, pensions, interest and/or dividends) and no other income whatsoever was generated. Use the IR 5 return (green).
- (b) **7 June 1997**, in all other cases. For taxpayers with a late balance date, not later than the 7th day of the 4th month after the balance date. The returns to use are:
 - IR 3 (light grey) for individuals.
 - IR 3NR (lilac) for non-residents.

- IR 4 (blue) for companies.
- IR 6 (red) for estates and trusts.
- IR 7 (brown) for partnerships.
- IR 8 (gold) for Maori Authorities.
- IR 9 (olive) for clubs and societies.
- IR 44 (dark grey) for registered superannuation funds.

4. Any person requiring a return form can request one using the Inland Revenue "forms and stationery" telephone number which can be found in the Blue Pages of the telephone book.

5. Any person who is not required under paragraph (1) to file a return and who has derived income from employment may choose to file a return using form IR 5. A tax refund may arise, if for example:

- additional rebates or exemptions were not included in the tax code during the year, and/or
- employment was for part of the year only.

6. Any person or company who is required to but does not file an income tax return within the prescribed time may be prosecuted for 'failure to furnish a return' and if convicted, may be fined as follows:

- up to \$2,000 for a first offence;
- up to \$4,000 for a second offence;
- up to \$6,000 for any subsequent offence.
