HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to section 37ZZZJ of the Local Government Act 1974, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

#### Order

**1. Commencement**—(1) This order may be cited as the Local Government (North Shore City Council) Reorganisation Order 1998.

(2) Except as provided in subclause (3) of this clause, this order shall come into force 28 days after the day on which this order is published in the *New Zealand Gazette*.

(3) Clauses 3 to 7 of this order, so far as is necessary to provide for the triennial general election to be held on 10 October 1998, shall come into force 28 days after the day on which this order is published in the *New Zealand Gazette*, but otherwise shall come into force on the said 10 October 1998.

**2. Interpretation**—In this order, unless the context otherwise requires,—

“Act” means the Local Government Act 1974:

“Board” means a community board within a community

established within the district pursuant to Part IVB of the Act:

“Council” means the North Shore City Council:

“District” means the district of North Shore City.

**3. Wards**—(1) For the purposes of the triennial general election of the council to be held on 10 October 1998, the district shall be divided into 3 wards.

(2) Those 3 wards shall be:

- (a) The Northern Ward, comprising the area described in Part I of the First Schedule to this order;
- (b) The Central Ward, comprising the area described in Part II of the First Schedule to this order; and
- (c) The Harbour Ward, comprising the area of the former Birkenhead-Northcote Ward as delineated on S.O. Plan No. 63518 and the former Glenfield Ward as delineated on S.O. Plan No. 63521.

**4. Membership**—(1) The council shall consist of a mayor, to be elected by the electors of the district, and 15 members, who shall be elected as follows,—

- (a) Five members, who shall be elected by the electors of the Northern Ward; and
- (b) Five members, who shall be elected by the electors of the Central Ward; and
- (c) Five members, who shall be elected by the electors of the Harbour Ward.

(2) Notwithstanding section 101H of the Act, the council shall not determine its membership and the basis of the election of its members prior to the triennial general election to be held on 10 October 1998.

**5. Communities**—(1) Each Community presently existing within the district shall be abolished.

(2) There shall be constituted the following communities—

- (a) A community to be known as “the East Coast Bays Community” comprising the area described in Part I of the Second Schedule to this order; and
- (b) A community to be known as “the Albany Community” comprising the area described in Part II of the Second Schedule to this order; and
- (c) A community to be known as “the Takapuna Community” comprising the area described in Part III of the Second Schedule to this order; and
- (d) A community to be known as “the Devonport Community” comprising the area of the former Devonport Ward delineated on S.O. Plan No. 63522; and
- (e) A community to be known as “the Birkenhead-Northcote Community” comprising the area of the former Birkenhead-Northcote Ward delineated on S.O. Plan No. 63518; and
- (f) A community to be known as “the Glenfield Community” comprising the area of the former Glenfield Ward delineated on S.O. Plan No. 63521.

**6. Membership of community boards**—The board for each community constituted by clause 5 (2) of this order shall consist of,—

- (a) four members elected by the electors of the community; and
- (b) two appointed members within the meaning of section 101ZQ of the Act.

**7. Powers of community boards**—Each board constituted by clause 5 (2) of this order, until 13 October 2001, and with respect solely to the area of its own community—

- (a) shall have such functions, powers and duties as may

from time to time be delegated to that board by the council; and

(i) may report to the council on any matter of interest or concern; and

(ii) shall report to the council on any matter on which the council has sought the views of the board,

provided that no board may hear, consider or determine any application for any consent to which sections 93 or 94 of that Act apply.

(2) Notwithstanding the proviso to subclause (1) (b) of this clause, where any board has commenced hearing any application to which that proviso applies before the commencement of this clause, and that board has not finished hearing, considering or determining that application by the date of the commencement of this clause it shall continue to have the power to deal with that application.

**9. Revocation**—The Local Government (North Shore City Council) Reorganisation Order 1997\* is hereby revoked.

This Standard defines and regulates the composition and labelling of foods specially formulated to assist sports people in achieving specific nutritional or performance goals. Such foods are intended as supplements to a diet rather than for use as the sole or principal source of nutrition.

Due to the particular physiological demands of sports people, this Standard provides for the addition to formulated supplementary sports foods of certain micronutrients and other ingredients which are not permitted to be added to other foods. This means that such products are not suitable for consumption by children.

**Division 1—Formulated Supplementary Sports Foods Generally***Interpretation*

‘one-day quantity’ in relation to formulated supplementary sports food, is the amount of that food which is to be consumed in one day in accordance with directions specified in the label.

*Composition*

2. A formulated supplementary sports food—

(a) may contain additives as follows—

- (i) colourings;
- (ii) flavourings;
- (iii) antioxidants in accordance with Standard A7;
- (iv) artificial sweetening substances in accordance with Standard A8;
- (v) modifying agents listed in Table 1 of Standard A10;

(b) may contain the vitamins and minerals specified in the Table to this paragraph provided that—

- (i) the vitamin or mineral is added in a form listed in the Schedule to Standard A9 or in column 2 of the Schedule to this Standard; and

(ii) the amount of the vitamin or mineral in the food does not exceed the amount, if any, specified in column 3 of the Table;

#### Required labelling statements

3. (1) The label on a formulated supplementary sports food must include statements to the effect that—

- (a) the food is not a sole source of nutrition and should be consumed in conjunction with a nutritious diet; and
- (b) the food should be used in conjunction with an appropriate physical training or exercise program.

(2) The label on a formulated supplementary sports food must include—

- (a) directions stating the recommended quantity and frequency of intake of the food;
- (b) a statement of the recommended consumption in one day; and
- (c) a nutrition information panel in accordance with Standard A1.

(3) The label on a formulated supplementary sports food must include, in standard type of 3 mm, the statement—

**“NOT SUITABLE FOR CHILDREN UNDER 15 YEARS OR PREGNANT WOMEN: SHOULD ONLY BE USED UNDER MEDICAL OR DIETETIC SUPERVISION”.**

(4) If a formulated supplementary sports food contains added phenylalanine then the label must include, in standard type of 3 mm, the statement—

**“PHENYLKETONURICS: CONTAINS PHENYLALANINE”.**

#### Ingredient claims

4. (1) If the label on a formulated supplementary sports food refers to the presence of a particular ingredient, other than—

- (a) vitamins or minerals; or
- (b) in a statement required elsewhere in this Code

the label must also include a statement of the amount by weight (expressed per 100 g food or as a percentage) of the ingredient in that food either—

- (c) immediately after the statement referring to the presence of the ingredient; or
- (d) immediately following the name of that ingredient in the statement of ingredients.

(2) Subclause (1) does not apply if the nutrition information panel lists the particular ingredient and the average quantity by weight of the ingredient in—

- (a) a serving of the food; and
- (b) per 100 g or 100 mL of the food.

**Vitamin and mineral claims**

5. (1) The label on a formulated supplementary sports food must not claim the presence of a vitamin or mineral unless—
- (a) the reference is required elsewhere in this Code; or
  - (b) the reference is specifically permitted by this clause.
- (2) The label on a formulated supplementary sports food may only claim the presence of a vitamin or mineral in the food if—
- (a) the food contains—
    - (i) at least 10 percent of the recommended dietary intake for that vitamin or mineral in a serving of that food or, in relation to a food which requires dilution or preparation according to directions, the quantity of the food which when diluted or prepared produces a normal serving; or
    - (ii) at least 10 percent of the amount specified in column 3 of the Schedule to this Standard for that vitamin or mineral in a normal serving of that food, or in relation to a food which requires dilution or preparation according to directions, the quantity of the food which when diluted or prepared produces a normal serving; and
  - (b) the amount claimed does not exceed the amount specified in column 2 of the table to paragraph 11 (b); and
  - (c) the label on the food includes a statement in accordance with clause 6 of Standard A9.

**Prohibition on representations**

6. Unless specific permission is given in this Part, the label on a formulated supplementary sports food must not include an express or implied representation that relates any property or proposed use of the food to enhanced athletic performance or beneficial physiological effects.

**Division 2—Particular Formulated Supplementary Sports Foods****High carbohydrate supplement**

7. (1) A high carbohydrate supplement is a formulated supplementary sports food for which—
- (a) not less than 90 percent of the energy yield of the product is derived from carbohydrate; and
  - (b) more than 15 percent of the product by weight is carbohydrate when prepared as directed.
- (2) The label on a high carbohydrate supplement must include statements to the effect that—
- (a) if used during exercise, the food should be consumed in accordance with directions, to avoid the possibility of gastrointestinal upset; and
  - (b) the food must be consumed with an appropriate fluid intake.
- (3) The label on a high carbohydrate supplement may include statements to the effect that—
- (a) the product is useful either before, during and/or after sustained strenuous exercise; and
  - (b) appropriate usage may assist in the provision of energy in the form of carbohydrates.

**Protein energy supplement**

8. (1) A protein energy supplement is a formulated supplementary sports food for which—
- (a) not more than 30 percent and not less than 15 percent of the energy yield of the product is derived from protein;
  - (b) not more than 25 percent of the energy yield of the product is derived from fat; and
  - (c) not more than 70 percent of the energy yield of the product is derived from carbohydrate.
- (2) The label on a protein supplement must include a statement to the effect that the food must be consumed with an appropriate fluid intake.
- (3) The label on a protein supplement may include statements to the effect that—
- (a) the product may assist in providing a low-bulk diet as may be required during training;
  - (b) the product may assist in supplementing the diet with a high energy source as may be required during training;
  - (c) usage as directed may assist in the development of muscle bulk; and
  - (d) the product is useful either before, during and/or after sustained strenuous exercise.

**Energy supplement**

9. (1) An energy supplement is a formulated supplementary sports food for which not more than 20 percent of the energy yield of the product is derived from protein.
- (2) The label on an energy supplement must include statements to the effect that—
- (a) if used during exercise, the food should be consumed in accordance with directions, to avoid the possibility of gastrointestinal upset; and
  - (b) the food must be consumed with an appropriate fluid intake.
- (3) If more than 30 percent of the energy yield of the energy supplement is derived from fat, the label on the energy supplement must include a statement to the effect that the product is a high fat food and should be used for special fat loading strategies rather than everyday use.
- (4) The label on an energy supplement may include statements to the effect that—
- (a) the product may assist in supplement the diet with an energy source as may be required during training; and
  - (b) the product is useful either before, during and/or after the sustained strenuous exercise.

**Prescribed name**

10. The names by which particular formulated supplementary sports foods are defined in this Division are not prescribed names.
