Dumping and Countervailing Duties Act 1988

Anti-Dumping Duties: Notice That Anti-Dumping Duties on Refined Sugar from Belgium, Denmark, Germany, Malaysia, the Netherlands and Thailand are to Cease to Apply

Subject to section 14 (9) of the Dumping and Countervailing Duties Act 1988 ('the Act'), anti-dumping duties imposed on refined sugar from Belgium, Denmark, Germany, Malaysia, the Netherlands and Thailand* will cease to apply to those goods on 3 November 1998 unless, at that date, the goods are subject to review under section 14 (8) of the Act.

Any interested party that might request the Secretary of Commerce to initiate a review before the termination date referred to above, should be aware that positive evidence justifying the need for a review must be provided to the Secretary.

If an application is received which provides positive evidence justifying the need for a review, the Secretary must undertake a review investigation and report to the Minister of Commerce within 180 days on whether the anti-dumping duties should continue to be applied. Positive evidence justifying the need for a review would need to provide reasons for believing that the expiration of anti-dumping duties would see the recurrence of dumping of refined sugar from Belgium, Denmark, Germany, Malaysia, the Netherlands and Thailand, and for believing that such dumping would cause material injury to the New Zealand industry producing refined sugar. The reasons should be supported by evidence and not based on mere allegations or assertions.

“20C.1 The object of this part of this programme is to provide financial assistance for farmers in the Marlborough and North Canterbury regions who have been affected by the droughts which occurred in the spring and summer of 1997/98.

“20C.2 This part of the programme comes into effect on 1 April 1998 and ceases to apply on 1 April 1999 unless extended by the Minister.

“20C.3 For the purposes of this part the definition of “cash assets” in clause 3.1 does not apply and the following definition is substituted:

“ “Cash assets”, in relation to any person, means assets of that person and his or her spouse (if any) that can be readily converted into cash and include—

- ‘(a) shares, debentures, bonus bonds, and other bonds;
- ‘(b) bank accounts, including fixed and term deposits with any bank, friendly society, credit union, or building society;
- ‘(c) money invested with or lent to any bank or other financial institution;
- ‘(d) the net equity held in any property or land not used as the person’s home (except that the net equity in a land based industry, as defined in clause 20.6, is not to be included as a cash asset in relation to an application for a grant under Part IV);
- ‘(e) building society shares;
- ‘(f) mortgage investments and other long term loans;
- ‘(g) bills of exchange or promissory notes;
- ‘(h) the applicant’s share in a partnership;

but do not include—

- ‘(i) the motor vehicle principally used by the applicant for his or her personal use;
- ‘(j) a caravan, boat, or other vehicle—
 - (i) the net equity in which is less than \$2,000; or
 - (ii) which is used by the person or member of his or her immediate family for day to day accommodation;
- ‘(k) the personal effects of the person and his or her spouse (if any);
- ‘(l) the proceeds from the sale of capital pastoral stock

(whether or not held in any of the assets in paragraphs (b), (c), (f) or (g) of this definition);”

“20C.4 For the purposes of this part clause 20.4 does not apply and the following clauses are substituted:

“20.4 Grants may not be made under clause 20.3 for more than a period of 1 year.

“20.4A If the Minister of Social Welfare has extended the application of this part for a further period, on application made by the farmer the Director-General may, in his or her discretion, make grants under clause 20.3 for up to that extended period if, after conducting a review of the farmer’s circumstances, the Director-General considers the personal circumstances of the farmer justify such grants being made.”

“20C.5 For the purposes of this part clause 20.5 does not apply and the following is substituted:

“20.5 The maximum amount of grants under clause 20.3 are—

To a married person with one dependent child	75 per cent of the appropriate current unemployment benefit rate diminished by \$1 a week for every \$1 a week of that person’s income.
To a married person with 2 or more dependent children	75 per cent of the appropriate current unemployment benefit rate diminished by \$1 a week for every \$1 a week of that person’s income.
To a married person with no dependent children	75 per cent of the appropriate current unemployment benefit rate diminished by \$1 a week for every \$1 a week of that person’s income.
To a sole parent with one dependent child	75 per cent of the appropriate current unemployment benefit rate diminished by \$1 a week for every \$1 a week of that person’s income.
To a sole parent with 2 or more dependent children	75 per cent of the appropriate current unemployment benefit rate diminished by \$1 a week for every \$1 a week of that person’s income.
To an unmarried person with no dependent children	75 per cent of the appropriate current unemployment benefit rate diminished by \$1 a week for every \$1 a week of that person’s income.’

- (ii) continue to satisfy that instructor of their competency to carry out those manoeuvres; and
- (iii) continue to operate aircraft under the supervision of that instructor,

from the requirement of Civil Aviation Rule 91.701 that each pilot operating an aircraft in aerobatic flight below a height of 3000 feet; or carrying a passenger in aerobatic flight; shall hold an aerobatic rating issued under Part 61:

(b) all persons who—

- (i) have logged at least 200 hours flight time, including at least 100 hours as pilot-in-command of the category of aircraft being used for the parachute drop; and
- (ii) have a log book entry that they have been briefed on the use of parachutes, parachuting operations, and emergency procedures by a jumpmaster; and
- (iii) have a log book entry that they have demonstrated their competency in parachute drop operations to the holder of a Category A or B flight instructor rating who is qualified to drop parachutists,

from the requirements of Civil Aviation Rule 91.705 that each pilot performing parachute drop operation shall hold a parachute drop rating issued under Part 61;

(c) all persons who—

- (i) have logged at least 200 hours flight time in aeroplanes, including at least 100 hours as pilot-in-command of powered aeroplanes; and
- (ii) have a log book entry that they have demonstrated to a flight examiner a sound knowledge of standard signals, safety practices, and emergency procedures related to glider training, and the ability to perform competently all normal towing manoeuvres whilst acting as pilot-in-command of an aeroplane towing a glider,

from the requirement of Civil Aviation Rule 91.709

that each pilot towing a glider, or gliders, in flight shall hold a glider tow rating issued under Part 61; and from the requirement of Civil Aviation Rule 91.711 that each private pilot towing an object, other than a glider, in flight to hold a tow rating issued under Part 61.

This exemption shall apply until the 31st day of March 1999.

The director has withdrawn the previous general exemption 97/EXE/56 granted on 30 May 1997.

General Exemption—Automatic ELT, CAR 91.529 (a):

Ref 98/EXE/149, on 28 March 1998, the director granted an exemption to all gliders from the requirement of Civil Aviation Rule 91.529 (a) that requires aircraft to have an automatic ELT installed.

This exemption shall apply until the 1st day of October 1998.

Barnstorm Enterprises Limited—CAR 135.353 (1) (II):

Ref 98/EXE/147, on 27 March 1998, the director granted an exemption to Barnstorm Enterprises Limited from Civil Aviation Rule 135.353 (1) (ii) in respect of the radios required for communication in each of Barnstorm Enterprises Limited's two aircraft, Boeing Stearman ZK-STM and Tiger Moth ZK-BRL.

Provided that—

(1) Prior to departure each aircraft has one serviceable radio installed; and
