1. **Title and commencement**—(1) This notice may be cited as the Fisheries (Bycatch Trade-Off) Notice (No. 2) 1998.  
(2) This notice shall come into effect the day after the date of its notification in the *Gazette*, and shall expire on the 15th day of July 1998.
2. **Interpretation**—In this notice:
  - (a) Any reference to Quota Management Area means the appropriate Quota Management Area as defined in the Fisheries (Quota Management Areas, Total Allowable Catches and Catch Histories) Notice 1986\*;
  - (b) Target species and bycatch species are specified by the way of fishstock codes, being Fishstock Codes defined in the Second Schedule of the Fisheries (Reporting) Regulations 1990†; and

(c) Methods are specified by way of method codes, being Method Codes defined in the Second Schedule of the Fisheries (Reporting) Regulations 1990†.

**3. Offering a lease of quota in lieu of paying deemed value**—(1) Subject to this clause, as from the date this notice comes into effect, any commercial fisherman who but for section 28zG of the Fisheries Act 1983, could be required under section 28zD of that Act to pay the deemed value of any fish that is specified as a bycatch species in this notice, may, not later than 15 days after the end of the month in which the fish were taken, by notice in writing, offer the Chief Executive of the Ministry of Fisheries a lease or sub-lease of the right to take fish, under any quota held or leased by that commercial fisherman that are specified in the Schedule to this notice as a target species in relation to that bycatch species.

(2) The ratios specified in the Schedule to this notice, are the ratios at which a lease or sublease of quota of the target species may be accepted in relation to the amount of the bycatch species for which the offer of quota is made, (e.g. if a fisher could be required to pay deemed value for 1 tonne of Gur 1 and wishes to offer a lease of Fla 1 then the amount that can be offered is 1 tonne  $\times$  0.83 = 0.83 tonnes of Fla 1).

(3) The bycatch species must have been taken while fishing for the target species using the method or any of the methods specified in the Schedule, (e.g. in the case of the above example, the Gur 1 bycatch must have been taken using either the method of Danish seine or setnetting).

(4) Any offers that relate to bycatch species as specified in this notice must relate to fishing that has occurred in the months of April, May or June 1998 respectively.

Income Tax Act 1994****Who Must File a Tax Return?****Notice to File Returns of Income Under the Tax Administration Act 1994 and the Income Tax Act 1994**

The Commissioner of Inland Revenue gives notice to those who must file returns under the terms of the Tax Administration Act 1994 and the Income Tax Act 1994 as follows:

1. Returns of income for the year ended 31 March 1998 (or other approved balance date) are required from:

- (a) Every person who received income over \$34,200.
- (b) Every person who received New Zealand Superannuation and more than \$10,296 if you were single, or \$7,722 each if married of other income (including 50% of non-taxable pensions).
- (c) Every person who had a student loan balance before 31 December 1997, except those who repaid the loan in full by 31 March 1997.
- (d) Every person who was required to pay child support.
- (e) Every person, and the partner (or ex-partner if separated) of a person who was issued with a Family Assistance Certificate of Entitlement, or received Family Assistance with an income-tested benefit from Income Support and whose family income was over \$20,000. Any person with dependent children who is not currently receiving Family Assistance should check to see if they qualify. They can ring our automated phone service, 0800 43 53 63 for a taxpack. All they need is a touch tone phone and their IRD number.
- (f) Every person who received income that did not have the correct rate of PAYE or RWT deducted from it.
- (g) Every person who used a special tax code (IR 23), or the special shearers' codes SSH or SHR.
- (h) Every person who was an IR 56 taxpayer.
- (i) Every person who received income from withholding payments (IR 13 certificate).
- (j) Every person who received income from business rents or any other income with no tax deducted before receipt of that income.
- (k) Every company, partnership, estate, trust, Maori authority or any other incorporated or unincorporated body, that is not:
  - approved by Inland Revenue as fully exempt from income tax; or

- a non-active company that meets the conditions for and has completed an IR 4NA Declaration.
- (l) Every person who received income from overseas.
- (m) Every person who has been asked by Inland Revenue to send in a return.
2. Returns may be filed electronically, posted or delivered to Inland Revenue.
3. Due dates for filing returns of income for the year ended 31 March 1998 are:

(a) **7 June 1998**, in cases where all income has had tax deducted at the time it was earned or received (ie income from salary, wages, benefits, pensions, interest and/or dividends) and no other income whatsoever was generated. Use the IR 5 return (green).

(b) **7 July 1998**, in all other cases. For taxpayers with a late balance date, not later than the 7th day of the 4th month after the balance date. The returns to use are:

- IR 3 (light grey) for individuals
- IR 3NR (lilac) for non-residents
- IR 4 (blue) for companies
- IR 6 (red) for estates and trusts
- IR 7 (brown) for partnerships
- IR 8 (gold) for Maori authorities
- IR 9 (olive) for clubs and societies
- IR 44 (maroon) for registered superannuation funds.

4. Any person requiring a return form can request one using the Inland Revenue automated phone service 0800 43 53 63. They can ring any day from 6 a.m.–midnight. All they need is a touch tone phone and their IRD number.

5. Any person who is not required under paragraph (1) to file a return and who has derived income from employment may choose to file a return using form IR 5. A tax refund may arise if, for example:

- additional rebates or exemptions were not included in the tax code during the year
- employment was for part of the year only
- you made donations and/or
- you paid for child care or a house/keeper.

6. This year, for the first time, Inland Revenue will charge a late filing penalty. Failure to file your return on or before the due date can result in a late filing penalty. The amount of late filing penalty depends on the amount of net income. The following table outlines the possible penalty:

<i>Net Income</i>	<i>Penalty</i>
Less than \$100,000	\$ 50.00
\$100,000–\$1 million	\$250.00
More than \$1 million	\$500.00

Any person or company who is required to but does not file an income tax return within the prescribed time may be prosecuted for 'failure to furnish a return', and if convicted, may be fined (under section 143 of the Tax Administration Act 1994) as follows:

- up to \$4,000 for a first offence
- up to \$8,000 for a second offence
- up to \$12,000 for any subsequent offence.

### Accident Rehabilitation and Compensation Insurance Act 1992

#### Direction to the Accident Rehabilitation and Compensation Insurance Corporation Relating to Government Policy on Investment of Premium Income for the Employers' and Earners' Accounts Established under the Accident Rehabilitation and Compensation Insurance Act 1992 ("the ARCI Act").

*To the Accident Rehabilitation and Compensation Insurance Corporation ("ACC")*

#### Background

The current reserves policy established under section 128 of the ARCI Act provides that the equivalent of 6 months expenditure be kept in reserves in each of the Employers' and Earners' Accounts established under the ARCI Act 1992.

The level of premiums prescribed in the Accident Rehabilitation and Compensation Insurance (Employment Premiums) Regulations 1997 and the Accident Rehabilitation and Compensation Insurance (Earner Premium) Regulations 1997 is such that the levels of funds will soon pass those set under the reserves policy. This means that in the 1998/99 premium year, ACC will collect more funds than required to meet the forecast pay-as-you-go costs and reserve requirements.

ACC investment policy is governed by clause 18 of the Second Schedule to the ARCI Act which requires ACC to invest "in the same manner as if it were a trustee, all money received by it and not immediately required for expenditure".

#### Policy Direction

Pursuant to section 159 of the Accident Rehabilitation and Compensation Insurance Act 1992, I hereby direct the Corporation that:

#### *Employers' Account*

a. The Corporation shall account for the funds collected under the Accident Rehabilitation and Compensation Insurance (Employment Premiums) Regulations 1997 in two parts:

- i. "Employers' Account Part A Funds"—That part of the premium required to fund the pay-as-you-go costs and 6 months reserves (an average of \$1.70 per \$100 of liable earnings); and
- ii. "Employers' Account Part B Funds"—That part of

the premium collected to reduce the unfunded liability (an average of \$0.65 per \$100 of liable earnings)

b. Employers' Account Part A Funds are required to be identified separately from Employers' Account Part B Funds by premium group. Investment income from each Part's Funds is to be credited to the appropriate Fund.

#### *Earners' Account*

c. The Corporation shall account for the funds collected under the Accident Rehabilitation and Compensation Insurance (Earner Premium) Regulations 1997 in two parts:

- i. "Earners' Account Part A Funds"—That part of the premium required to fund the pay-as-you-go costs and 6 months reserves (\$0.7111 per \$100 of liable earnings); and
- ii. "Earners' Account Part B Funds"—That part of the premium collected to reduce the unfunded liability (\$0.3556 per \$100 of liable earnings).

d. Earners' Account Part A Funds are required to be identified separately from Earners' Account Part B Funds. Investment income from each Part's Funds is to be credited to the appropriate Fund.

#### *General*

e. Employers' Account Part B and Earners' Account Part B funds are to be held for meeting the future costs of current claims.

f. This policy direction will terminate when revoked by the Minister.

Section 6 of the Treaty of Waitangi Act 1975, describes what a claim is. Claims may be posted or sent to the Registrar, Waitangi Tribunal, Seabridge House, 110 Featherston Street (P.O. Box 5022), Wellington.

If no claim about this land is made to the Waitangi Tribunal before the 3rd day of August 1998, then the Tribunal may recommend that the land no longer be liable to be resumed by the Crown and returned to Maori.
