After export produce has become the property of the board, in accordance with this notice, such produce may become the property of the supplier again:

- on agreement between the board and the supplier prior to final grading of the product; and
- at the board's option upon the board finding such export produce to be contaminated or to contain

foreign matter to such an extent that it does not conform to the board's specification prescribed in the board's order for that produce.

The terms and conditions of acquisition set out above have been adopted by the board under the statutory powers of sections 17 and 18 of the Act.
