First Schedule

Functions in Relation to Blood and Controlled Human Substances the Performance of Which shall be the Responsibility of the New Zealand Blood Service Limited

This appointment applies to:

- (a) Blood as defined in section 92A of the Health Act 1956 (as inserted by section 3 of the Health Amendment Act 1998); and
- (b) Controlled human substances as defined in subparagraphs (i) and (ii) of paragraph (a) of the definition of controlled human substances in section 92A of that Act (as so inserted).

It is noted that there is provision for substances to be declared by Order in Council to be included in the definition of controlled human substance (pursuant to subparagraph (iii) of paragraph (a) of that definition, as so inserted). Where substances are declared in this manner,

there is provision in section 92H of the Health Act 1956 (as so inserted) to amend this appointment to include such substances within the scope of this appointment.

It is also noted that section 92C (5) of the Health Act 1956 (as so inserted) requires appointed entities, and their employees or agents, who take blood or controlled human substances to give due recognition to the fact that the blood or controlled human substance has been donated.

The functions that the New Zealand Blood Service Limited shall be responsible for are:

- To collect donated blood and controlled human substances.
- To process donated blood and controlled human substances.
- To test donated blood and controlled human substances in accordance with contemporary standards so as to determine their fitness for therapeutic use.
- To store donated blood and controlled human substances.
- To ensure efficient banking and cross-matching systems are operated for blood and controlled human substances.
- To provide blood and controlled human substances to such health care providers that may lawfully administer or arrange for the administration of blood and controlled human substances to consumers.

For the avoidance of doubt, it is declared that the responsibility of the New Zealand Blood Service Limited for the above functions does not extend to where blood and controlled human substances are taken from its control, or from a blood bank operated by one of its agents, for administration to a consumer.

Nothing in this appointment prevents the New Zealand Blood Service Limited from making arrangements with health providers in respect of services related to blood or controlled human substances taken for the purpose of autologous transfusion.

Second Schedule

Terms and Conditions of this Appointment

- While carrying out the functions for which it is responsible, as specified in the First Schedule of this appointment, the New Zealand Blood Service Limited shall ensure those functions are carried out safely and to a level of high quality, and shall take all reasonable precautions with a view to ensuring that the blood and controlled human substances are safe for use, and are of a high quality for use.
- The New Zealand Blood Service Limited shall ensure that its authorised agents, its employees and the employees of its agents, have appropriate skills and expertise and use those skills and that expertise when carrying out the functions for which it is responsible under this appointment.
- The New Zealand Blood Service Limited shall ensure that high quality systems are in place to efficiently monitor and trace the blood and controlled human substances.
- The New Zealand Blood Service shall strive for efficiency in carrying out the functions for which it is responsible under this appointment, without compromising quality or safety.
- The New Zealand Blood Service Limited shall consult with the Ministry of Health on issues having, or likely to have, substantial effects on consumers, on the blood system, or on the ability of the New Zealand Blood Service Limited to carry out its function under this

appointment or to comply with these terms and conditions. Where the likelihood of such issues is foreseen by the New Zealand Blood Service Limited, or where the issues come to the attention of New Zealand Blood Service Limited, the consultation shall be as soon as reasonably practicable afterward.

- The New Zealand Blood Service Limited shall continue to develop relationships with interested parties and consumer groups to facilitate communication, co-operation, and community appreciation of the services it provides or arranges.
- The New Zealand Blood Service Limited shall ensure that it keeps up with developments and new technologies that relate to the services it provides and arranges for the purpose of its functions under this appointment, and that it fully considers introduction of these developments and technologies.

Local Government Boundary Alteration Notice 1998

1. Short title and commencement—This notice may be cited as the Local Government Boundary Alteration Notice 1998.

2. Seaward boundaries altered—(1) The boundaries of the districts listed in the Schedule are altered by including in those districts all that area situated between the existing seaward boundary of each district and the line of mean low water springs.

(h) Married with 1 or more dependent children: \$209.73”

“8. For a married couple one of whom is in receipt of **New Zealand Superannuation** where the other is receiving a **sickness benefit** (granted before 1 July 1998): \$172.23

9. For a married couple one of whom is in receipt of **New Zealand Superannuation** where the other is receiving an **unemployment benefit**, a **training benefit** or a **sickness benefit** (granted on or after 1 July 1998): \$138.71

10. For a married couple one of whom is in receipt of **New Zealand Superannuation** where the other is receiving an **invalids benefit** or a **transitional retirement benefit**: \$200.29”

6. The Schedule in the Direction is amended by omitting clauses 13 and 14 and inserting the following:

“13. For a married couple one of whom is receiving a **domestic purposes benefit** under section 27G of the Act (*care of sick or infirm*) where the other is receiving an **unemployment benefit** or a **sickness benefit** (granted on or after 1 July 1998): \$155.81

14. For a married couple one of whom is receiving a **domestic purposes benefit** under section 27G of the Act (*care of sick or infirm*) where the other is receiving a **sickness benefit** (granted before 1 July 1998): \$189.33”

Explanatory Note

This note is not part of the Direction but is intended to indicate its general effect.

This Direction, made by the Minister of Social Welfare under section 5 (2) of the Social Security Act 1964, amends the Direction given by the Minister on 14 April 1997 relating to the grant of special benefit.

This Direction amends the Schedule to reflect the standard cost rates that were affected by the changes to income tax rates in the Income Tax Act 1994 Amendment Act 1996 (as amended in the Taxation (Income Tax Rates) Act 1997).

The Schedule has also been amended to distinguish between a sickness benefit granted before, or after 1 July

1998, in accordance with the Social Security Amendment Act 1998.

The standard costs have also been included for those receiving an emergency benefit, who are living at home and are aged 16 or 17 years.

This Direction comes into force on 1 July 1998.

Grant of Emergency Benefits to Students

In relation to the granting of the emergency benefit under section 61 of the Social Security Act 1964 to full-time students, and without limiting the discretion available to you in that section, you must have regard to the following matters:

1. In this direction, unless the context otherwise requires,—

“Act” means the Social Security Act 1964:

“Cash assets”, in relation to any person, means the assets of that person and his or her spouse (if any) that can be readily converted into cash and includes:

- (a) Shares, stocks, debentures, bonus bonds, and other bonds;
- (b) Bank accounts, including fixed and term deposits with any bank, friendly society, credit union, or building society;
- (c) Money invested with or lent to any bank or other financial institution;
- (d) The net equity held in any property or land not used as the person's home;
- (e) Building society shares;
- (f) Mortgage investments and other long term loans;
- (g) Bills of exchange or promissory notes;
- (h) The applicant's share in any partnership;

but does not include:

- (i) The motor vehicle principally used by the applicant for his or her personal use;
- (j) A caravan, boat, or other vehicle—
 - (i) The net equity in which is less than \$2,000; or
 - (ii) Which is used by the person or a member of his or her family for day to day accommodation;
- (k) The personal effects of the person and his or her spouse (if any):

“Course” means a full-time course within the meaning of the Student Allowances Regulations 1991:

“Full-time student” has the same meaning as in section 18 of the Social Security Amendment Act 1998:

“Student Allowance” means a basic grant or an

independent circumstances grant under the Student Allowances Regulations 1991;—

and terms otherwise defined in section 3 (1) of the Act have the meanings so defined.

2. Where an applicant for an emergency benefit is a full-time student and—

- (a) Has cash assets of or less than—
 - (i) \$4,300, where the applicant is single; or
 - (ii) \$7,464, where the applicant is married or single with dependent children; and
- (b) Has no other means to support himself or herself or his or her dependent spouse or dependent children; and
- (c) The applicant—
 - (i) Has been receiving a student allowance during the academic year; or
 - (ii) At the time of application is entitled to a student allowance or would be entitled to a student allowance but for the fact the course he or she intends to enrol in or has enrolled in has not commenced,—

the applicant may be granted an emergency benefit.

3. Where clause 2 (a) and (b) apply to an applicant for an emergency benefit who is a full-time student, but the applicant—

- (a) Has not received a student allowance during the academic year; or
- (b) At the time of the application for the benefit, is not entitled to a student allowance or would not be entitled to a student allowance if he or she was attending a course,—

the applicant should not be granted an emergency benefit unless, having regard to the following matters, you believe that such a grant is justified:

- (c) The sources of money for living costs which have been or are available to the applicant to support himself or herself, including a student loan;
- (d) Any decision by the applicant not to access any source of money available to him or her for living costs, including a student loan;
- (e) The reasons why the applicant is not entitled to a student allowance;
- (f) Where the applicant would not be eligible for a student allowance because of parental income, his or her parents' financial circumstances;
- (g) The causes of the applicant's hardship (if hardship exists);
- (h) The nature and likely duration of that hardship;
- (i) The health of the applicant;
- (j) The ability of the applicant to improve his or her financial situation; and
- (k) Any other matters that in the particular case you consider to be relevant.

4. Nothing in this Direction requires you to grant an emergency benefit if, in your discretion, you determine such grant ought not to be made.
