## Fisheries Act 1983

### Fisheries (Bycatch Trade-Off) Notice (No. 3) 1998 (No. F91)

Pursuant to section 28ZG of the Fisheries Act 1983, the Policy Manager, Ministry of Fisheries (acting pursuant to delegated authority in accordance with section 41 of the State Sector Act 1988), hereby gives the following notice.

#### Notice

1. **Title and commencement**—(1) This notice may be cited as the Fisheries (Bycatch Trade-off) Notice (No. 3) 1998.  
(2) This notice shall come into effect the day after the date of its notification in the *Gazette*, and shall expire on the 15th day of October 1998.
2. **Interpretation**—In this notice:
  - (a) Any reference to Quota Management Area means the appropriate Quota Management Area as defined in the Fisheries (Quota Management Areas, Total Allowable Catches and Catch Histories) Notice 1986\*;
  - (b) Target species and bycatch species are specified by the way of fishstock codes, being Fishstock Codes defined in the Second Schedule of the Fisheries (Reporting) Regulations 1990†; and
  - (c) Methods are specified by way of method codes, being Method Codes defined in the Second Schedule of the Fisheries (Reporting) Regulations 1990†.
3. **Offering a lease of quota in lieu of paying deemed value**—(1) Subject to this clause, as from the date this notice comes into effect, any commercial fisherman who but for section 28ZG of the Fisheries Act 1983, could be required under section 28ZD of that Act to pay the deemed value of any fish that is specified as a bycatch species in this notice, may, not later than 15 days after the end of the month in which the fish were taken, by notice in writing, offer the Chief Executive of the Ministry of Fisheries a lease or sub-lease of the right to take fish, under any quota held or leased by that fisher that are specified in the Schedule to this notice as a target species in relation to that bycatch species.  
(2) The ratios specified in the Schedule to this notice, are the ratios at which a lease or sublease of quota of the target species may be accepted in relation to the amount of the bycatch species for which the offer of quota is made, (e.g. if a fisher could be required to pay deemed value for 1 tonne of Jdo 1 and wishes to offer a lease of Fla 1 then the amount that can be offered is 1 tonne  $\times$  2.00 = 2.00 tonnes of Fla 1).  
(3) The bycatch species must have been taken while fishing for the target species using the method or any of the methods specified in the Schedule, (e.g. in the case of the above example, the Jdo 1 bycatch must have been taken using the method of setnetting or Danish seining).  
(4) Any offers that relate to bycatch species as specified in this notice must relate to fishing that has occurred in the months of July, August or September 1998 respectively.
4. **Revocation**—The Fisheries (Bycatch Trade-off) Notice (No. 2) 1998 (No. F83) appearing in the *New Zealand Gazette* on 30 April 1998, No. 60, page 1340 is hereby revoked.

#### “20F Grants to farmers in South Canterbury, North Otago and Gisborne

“20F.1 For the purpose of this programme,—

“South Canterbury” means the areas within the Timaru District, the Waimate District and the MacKenzie District described in the Schedule:

“North Otago” means the Waitaki District, and the areas within the Central Otago District and Dunedin City described in the Schedule: and

“Gisborne” means an area within the Gisborne District described in the Schedule.

“20F.2 Drought affected farmers in South Canterbury, North Otago and Gisborne are eligible for financial assistance under this Part as if clause 20C.1 applies to them.

“20F.3 In relation to such farmers, this Part comes into effect on 3 August 1998 and ceases to apply on 31 March 1999, unless extended by the Minister.

“20F.4 For the purposes of assisting such farmers under this Part, clause 20C.2 does not apply.”

#### Schedule

1. For the purpose of the definition of South Canterbury,—

(a) The relevant area within Timaru District is the area from the Opihi River south to the Timaru District boundary:

(b) The relevant area within Waimate District is the coastal plains and the area inland between the Waihao and Waitaki rivers including the Hakataramea Valley: and

(c) The relevant area within MacKenzie District is the area to the north and west of the Te Ngawai river, leading to and including the Fairlie basin.

2. For the purpose of the definition of North Otago,—

(a) The relevant area within Central Otago District is the Maniototo Basin, the Ida Valley and the Manuherikia Valley: and

(b) The relevant area within Dunedin City is Strath Taieri and the Waikouaiti Coast.

3. For the purpose of the definition of Gisborne, the relevant area within the Gisborne District is the area south of a line from Tolaga Bay, west to the District boundary.

#### *Explanatory Note:*

*This note is not part of the welfare programme but is intended to indicate its general effect.*

These amendments, approved by the Minister of Social Welfare under section 124 (1) (d) of the Social Security Act 1964, amend the welfare programme approved by the Minister on 8 January 1996 relating to special needs grants.

The amendments to the programme are to assist farmers affected by the droughts in parts of South Canterbury, North Otago and Gisborne.

The purpose of the community trust is to provide charitable, cultural, philanthropic and recreational benefits to the community. In April 1998 the name was changed to the Bay of Plenty Community Trust.

#### *Chairman's Report for the Year Ended 31 March 1998*

##### *A successful year for your trust:*

I am pleased to report to you on another successful year for your trust as we see the assets now exceed \$100,000,000. Total income for the year was \$10,180,705 which is an increase of approximately \$1.1 million over that achieved in the previous financial year.

##### *Future generations will be well-served, too:*

Of the remaining income, allocations were made to our reserves to ensure that future generations can benefit from the trust and that distributions to our communities continue. Accordingly, the trust has adopted a reserving policy to allow for inflation, regional population growth and for the contingency of yearly fluctuations to our income.

In administering this policy funds have been allocated to Bay of Plenty Community Trust Charities Limited which is a subsidiary owned 100 percent by the trust. This income will be available for future donations to charitable organisations.

The total assets of \$105,300,000 have been invested in a diversified portfolio of assets both nationally and internationally. For the 1998 reporting year a large portion of these investments were held in term deposits within New Zealand. As investment contracts were completed during the year funds were allocated to the portfolio. We are pleased to continue to have the advice of Frank Russell and Co our lead advisor who is assisting the trust with these investments.

##### *Benefits spread far and wide:*

A total of 245 Bay of Plenty organisations received donations totalling \$2,374,855 for a wide range of charitable, cultural, recreational, educational and social purposes. The basic criteria for the trust are to ensure that the donation helps to build, maintain and enhance Bay of Plenty communities.

During the year the trust was delighted to join Sport Bay of Plenty with its innovative and exciting coach force programme. This programme has potential to significantly enhance sporting opportunities particularly for youth throughout the Bay of Plenty region. The trust's funds have allowed coaching centres to be established in Rotorua, Tauranga and Whakatane and supported the employment of "coaching directors" to 11 different sporting codes. The key objective is to gain, train and retain effective coaches throughout the Bay and to encourage sporting participation for our young people.

Other initiatives were to support employment opportunities throughout the Bay through the business grow network and Task

Force Green projects. The trust continues its support for disabled students pursuing tertiary education with \$28,250 through the Dillon Scholarship scheme.

Your trust is in a sound financial position and the income has been used to help many organisations in the Bay of Plenty pursue their objectives in making the Bay of Plenty a better place to live.

To my fellow trustees I extend a very sincere thank you for the extensive hours worked on trust business during a challenging and interesting year. Special thanks go to our retiring trustee Margaret Rex-Benner after serving 4 years with the trust. My thanks also to the trust manager and staff, Bruce Cronin and Susan Northey for their significant contribution to the trust's successful 1998 year.

### Notes to the Financial Statements for the Year Ended 31 March 1998

#### 1. Statement of Accounting Policies

##### Reporting Entity

The Bay of Plenty Community Trust Incorporated is a charitable trust registered under section 14 (i) of the Trustee Banks Restructuring Act 1988. The group consists of Bay of Plenty Community Trust Inc and its subsidiary Bay of Plenty Community Trust Charities Limited.

The financial statements have been prepared as required by the Trustee Banks Restructuring Act 1988 and the trust deed dated 30 May 1988 and in accordance with generally accepted accounting practice.

##### Measurement Base

The accounting principles recognised as appropriate for the measurement and reporting of earnings and financial position on a historical cost basis are followed by the trust, with the exception of investments which are market valued as at 31 March 1998.

##### Specific Accounting Policies

The following specific accounting policies which materially affect the measurement of financial performance and the financial position have been applied:

- (a) *Donations:* Donations made during the year from revenue are included in the income statement. Those made from trust capital have been included in the statement of movements in equity.
- (b) *Investments:* All investments are stated at assessed market value.
- (c) *Fixed Assets:* Fixed assets are stated at cost less accumulated depreciation.
- (d) *Depreciation:* Depreciation is charged to write off the cost of fixed assets over their expected economic lives using the diminishing value method at rates from 12 percent to 40 percent per annum.
- (e) *Accounts Receivable:* Accounts receivable are recorded at their estimated realisable value.
- (f) *Financial Instruments:* The trust includes all financial instrument arrangements in the balance sheet using the concept of accrual accounting. Financial instruments are valued as per note 1, measurement base. These instruments arise as a result of everyday operations and include bank, accounts receivable, accounts payable and investments. Revenues and expenses in relation to all financial instruments are recognised in the statement of financial performance. Financial instruments are shown at their fair values.
- (g) *Consolidation:* The Bay of Plenty Community Trust and its subsidiary charitable company, Bay of Plenty Community Trust Charities Limited have been consolidated using the purchase method of consolidation.

##### Changes in Accounting Policies

All accounting policies have been applied on bases consistent with those used in previous years.

**Consolidated Notes to the Financial Statements for the Year Ended 31 March 1998**

**1. Statement of Accounting Policies**

*Reporting Entity*

The financial statements presented here are for the reporting entity Trust Bank Wellington Community Trust and its wholly owned company Wellington Community Trust Charities Limited, the company commenced trading on the 1st day of April 1997. The Trust Bank Wellington Community Trust is an incorporated charitable trust under the Charitable Trusts Act 1957.

*Reporting Basis*

The trustees have chosen to prepare general purpose financial reports which comply with generally accepted accounting practice.

*Measurement Base*

The measurement base adopted is historical cost with the exception of certain items for which specified accounting policies are identified.

*Investment Income (Net)*

Investment income (net) includes gross investment income less management fees payable to the fund managers.

*Accounts Receivable*

Accounts receivable are stated at expected realised value.

*Donations*

Donations made are included in the statement of financial performance when paid.

*Fixed Assets*

Fixed assets are stated at cost less accumulated depreciation.

*Depreciation*

Depreciation is charged at the maximum rates allowable by the Inland Revenue Department. The tax rates are as follows:

*Changes in Accounting Policies*

There have been no changes in accounting policies. All policies have been applied on bases consistent with those used in previous years.

*Shares and Investments*

Shares and other investments are stated at the market value. Changes in the market value of investments are taken to the statement of financial performance.

*Financial Instruments*

All financial instruments held by the trust are recorded in the statement of financial position. The financial instruments comprise equity securities, discounted securities, deposits and cash. Concentrations of credit risk arise as a result of holding equity securities as investments. These are subject to the normal market risk associated with investments of this nature. There are no significant differences between the fair value and book value of financial instruments.

**2. Nature of Business**

The Trust Bank Wellington Community Trust was incorporated as a charitable trust in accordance with the provisions of the Trustee Banks Restructuring Act 1988. The purpose of the community trust is to provide charitable, cultural, philanthropic and recreational benefits to the community, principally in the trust region.

The wholly owned Wellington Trust Charities Limited nature of business is restricted by its constitution to providing charitable benefits to the community, principally in the region of the Wellington Community Trust.

The Trust Bank Wellington Community Trust and the Wellington Community Trust Charities Limited both operate under the trading name of "The Community Trust of Wellington".

#### Fundamental Error

During the year ended 31 March 1997, the Trust Bank Wellington Community disposed of its ownership in TBNZ shares. From the sale of the TBNZ shares, the Trust Bank Wellington Community Trust recorded a profit of \$22,708,563 in the year ended 1997 financial statements. The full profit on sale was actually \$24,602,905, therefore in the year ended 31 March 1997, profit was understated by \$1,894,342.

Due to the significance of the amount, the trustees believe that in the 1998 financial statements, the 1997 comparatives should be amended to reflect the correct profit on sale.

The effect on the statement of financial position is to increase retained earnings by \$1,894,342.

#### 6. Taxation

The charitable status of the Trust Bank Wellington Community Trust is currently being reviewed by the Inland Revenue. The trustees are of the view that no income tax liability will arise.

For taxation purposes the Wellington Community Trust Charities Limited is deemed to be a charitable organisation and on this basis the income is not subject to taxation. The company's charitable status was confirmed on the 27th day of August 1997 by the Inland Revenue Department.

#### 7. Goods and Services Tax

The trust is not registered for goods and services tax purposes. Accordingly these financial statements are stated on a G.S.T. inclusive basis.

### Notes to the Financial Statements for the Year Ended 31 March 1998

#### 1. Statement of Significant Accounting Policies

##### General

The financial statements presented here are for the reporting entity the Community Trust of Southland (the trust) and the Community Trust of Southland Group (the group). The group consists of the trust, its wholly owned company Southland Community Trust Charities Limited, and the trust's interests in associates. The Community Trust of Southland was formed under the Trustee Banks Restructuring Act 1988, while the trust is incorporated under the Charitable Trusts Act 1957.

The financial statements are presented in accordance with the Financial Reporting Act 1993.

The financial statements are prepared on the basis of historical cost except that investment assets are stated at valuation.

The accounting policies have been consistently applied by the trust and the group, and are consistent with those of the previous year. Where appropriate, new accounting policies have been introduced to reflect the changes in the nature of activities, particularly investing activities, undertaken by the trust and the group.

##### Consolidation

The financial statements of the trust's wholly owned company Southland Community Trust Charities Limited are included in the group financial statements using the purchase method of consolidation.

##### Associates

Associates are entities in which the group has significant influence, but not control, over the operating and financial policies. The group financial statements include the group's share of the net deficit of associates on an equity accounted basis.

##### Investments

The Group states its equity in investments at market value, and reports gains or losses on holding these investments in the statement of financial performance. These gains or losses are shown in the statement of financial performance as income from revaluation of investments.

The group intends to hold bank deposits until maturity and states these investments at cost.

##### Fixed Assets

Fixed assets are initially stated at cost and then depreciated on a straight line basis to allocate the cost of an asset, less any residual value, over its useful life. The estimated useful lives of fixed assets are as follows:

##### Accounts Receivable

The group states these at expected realisable value.

##### Grants

The group brings these to account when approved by trustees. Unpaid grants are recorded as a liability.

##### Income Tax

The group provides for income tax on its net income after adjusting for tax accounting differences and any beneficiaries income determinations made pursuant to section OB1 (226) of the Income Tax Act.

##### Goods and Services Tax

The group is not registered for goods and services tax. The financial statements are prepared so that all components are stated inclusive of G.S.T.

#### 2. Sale of Shares in Trust Bank New Zealand

In May 1996 the trust sold its shares in Trust Bank New Zealand to Westpac Banking Corporation. The effective offer price, including a bonus issue and special fully imputed dividend amounted to \$2.92 per share held before the offer.

## 9. Financial Instruments

### *General*

The group states its investments at balance date at estimated market value, calculating accrued interest on bank deposits by reference to the contract rates. The trustees consider that the fair value of the financial assets is identical to the carrying value in the statement of financial position.

### *Concentration of Credit Risk*

The group has significant funds in trading bank deposits, and in TeNZ Fund units. The group limits risk by spreading the deposits over several trading banks, and the TeNZ Fund's policy of selecting 10 investments in its portfolio also limits the risk. The group has not required collateral or other security to support its financial statements. The group further limits risk through its policy of placing investment funds with 3 separate fund managers, with each fund manager having an investment mandate which requires that they in turn diversify their investments on the group's behalf. The group has sought and obtained the advice of a professional financial adviser prior to making its investment allocation and placement decisions.

### *Interest Rate Risk*

The bank deposits are sensitive to changes in interest rates, as are a proportion of the funds managed by the fund managers.
