- (b) Safety chains between the towed and towing vehicles fulfilling all the requirements of Australian Design Rule 62/00 Determination 2 of 1995 are fitted.

3. Operating Speed Conditions

- (a) The maximum permissible operating speed of Schedule 1 vehicles is restricted to 30 km/h when towing any trailer or trailed agricultural machine, except as provided in clauses 3 (b), (c) and (d) of this Schedule.
- (b) Where the trailer or trailed agricultural machine has been modified and is certified by a certifying engineer approved by the Land Transport Safety Authority.
- (c) (i) Where the manufacturer of any trailer or trailed agricultural machine, being a member of the Tractor and Machinery Association Incorporated of New Zealand, has certified that the trailer or trailed agricultural machine may be towed safely in its fully laden condition at the maximum speed capability of the Schedule 1 vehicle towing it, and;
- (ii) Where the trailer or trailed agricultural machine has not been modified subsequent to being issued with the certification required by clause 3 (b) (i) above;
- (c) Where all of the certification details are carried by the Schedule 1 vehicle at all times when towing a trailer or trailed agricultural machine which has been certified.

4. The certified vehicles must be maintained in accordance with the vehicle manufacturers' recommendations and continue to meet all the certification requirements.

5. The Land Transport Safety Authority's Policy Statement 5 is not applicable to Schedule 1 vehicles or the trailers or trailed agricultural machines they may tow.

The authority will conduct inquiries into the draft standards or variations to standards prepared at full assessment of the following application and proposals:

Sulphur Dioxide In Longans (A351). An application from the Far North Queensland Longan Growers' Association Inc to permit the fumigation of longans with sulphur dioxide.

Statement of Ingredients (P143). A proposal to review the current provisions for the statement of ingredients on food labels in order to develop a joint Australia New Zealand standard.

Specific Compositional Declarations (P163). A proposal to review the current provisions which require a range of miscellaneous labelling statements in food labels in order to develop a joint Australia New Zealand standard.

Novel Foods (P168). A proposal to establish a joint Australia New Zealand standard for novel foods.

Sugars, Honey and Related Products (P181). A proposal to review the regulations in Australia and New Zealand for sugars, honey and related products in order to develop a joint Australia New Zealand standard. With respect to this proposal the authority is satisfied that it raises issues of minor significance and complexity and that to omit to invite public submissions prior to making a full assessment will not have a significant adverse effect on the interests of any person or body. The authority has therefore decided to omit to invite public submissions prior to making a full assessment.

You are invited to present written submissions to the authority on matters relevant to these inquiries, including the potential regulatory impact on consumers, industry and government, by **30 September 1998**. The information papers on these matters provide further information, including advice on the authority's policy regarding submissions.

Matters Before Council

The authority has completed inquiries into the variations to standards prepared at full assessment of the following applications and proposal and has made recommendations to the Australia New Zealand Food Standards Council that the variations be adopted into the *Food Standards Code*:

Maximum Residue Limits (A349 and A352). Applications for amendments to current maximum residue limits in Standard A14.

Review of the Edible Oils Standard (P162). A proposal to provide for a revised standard for edible oils to be included in the *Food Standards Code* as a joint Australia New Zealand standard.
