### Notice of Decision of the Disciplinary Tribunal of the Institute of Chartered Accountants of New Zealand

At a hearing held on 26 June 1997, the Disciplinary Tribunal of the Institute of Chartered Accountants of New Zealand heard 1 charge against **Jeffrey Thomas Chapman**, formerly of Wellington, now Auckland.

**Jeffrey Thomas Chapman** did not appear before the disciplinary tribunal and pleaded not guilty to 1 part of the charge. After hearing submissions on behalf of the professional conduct committee, the disciplinary tribunal found the member:

- A. Guilty of an offence punishable by imprisonment and conviction which reflected on his fitness to practice accountancy and tended to bring the profession into disrepute. Acting under rule 21.31 of the rules of the Institute of Chartered Accountants of New Zealand the disciplinary tribunal ordered that **Jeffrey Thomas Chapman** be removed from the Register of Members of the institute and imposed a monetary penalty of \$4,000.

**Jeffrey Thomas Chapman** was also ordered to pay to the institute the sum of \$4,723 in respect of the costs and expenses relating to the inquiry by the disciplinary tribunal and of the investigation by the professional conduct committee.

An appeal against the penalty imposed and the costs awarded by the disciplinary tribunal was heard by the appeals council of the institute at a meeting on 11 August 1998.

The appeals council considered both written and oral submissions made by the member and on behalf of the professional conduct committee. The appeals council concluded the discretion available to the disciplinary tribunal had been appropriately exercised, and confirmed the monetary penalty and award of costs. The appeals council reserved its decision on costs, pending submissions from the appellant and counsel for the professional conduct committee.

The appeals council confirmed that the decision be published in the *Chartered Accountants Journal of New Zealand*, the *New Zealand Gazette* and for distribution through the New Zealand Press Association, with mention of the member's name and locality.

#### Business Development Boards Act 1991

##### Code For Business Development Boards 1998, Amendment No. 1

Pursuant to section 7 of the Business Development Boards Act 1991, the Minister of Business Development hereby amends the Code For Business Development Boards 1998 as follows:

#### Notice

**1. Title and commencement**—(1) This notice may be cited as the Code For Business Development Boards 1998, Amendment No. 1, and is to be read with and deemed part of the Code for Business Development Boards 1998<sup>1</sup> (referred to in this notice as the principal code).

(2) This notice comes into effect on the date that it is signed by the Minister.

**2. Decision making**—Subclause 9 (1) of the principal code is omitted and the following subclause substituted:

“(1) Each board may delegate to any employee any of the functions and powers of the board under the Business Development Programme, other than the power to contract with a person under clause 4 of the Schedule and the power to meet the costs of promoting and running appropriate training programmes under clause 8 of the Schedule; provided that the person to whom those functions and powers are delegated shall not delegate those functions and powers without the written consent of the board.”

**3. Amendments to Schedule**—(1) Clause 4 of the Schedule to the principal code is omitted and the following clause substituted:

“4. Boards may contract with any person to undertake preliminary business appraisals, based on the capabilities outlined in clause 3 of this Schedule, of any selected SMEs referred to that person by the Board.”

(2) Clause 7 of the Schedule to the principal code is omitted and the following clause substituted:

“7. Boards will refer SMEs to persons or entities who provide training in the relevant skill. Boards may also promote training programmes which they consider will improve the capabilities, skills and performance of SMEs in their region.”

(3) Clause 8 of the Schedule to the principal code is omitted and the following clause substituted:

“8. The costs of promoting and running training programmes for SMEs may be met by boards.”

**4. Amendments to Explanatory Note**—The explanatory note to the principal code is amended by omitting the paragraph beginning “The appraisal will be carried” and ending “to establish a business.” and substituting the following paragraph:

“The appraisal will be carried out by persons selected and paid for by boards. Pre-appraisals may be carried out by the boards for free.”

**Fish and Fish Products (P183).**—A proposal to revise current Australian and New Zealand regulations in order to develop a joint Australia New Zealand food standard for fish and fish products.

With respect to this application and proposal the authority is satisfied that they both raise issues of minor significance and complexity and that to omit to invite public submissions prior to making a full assessment will not have a significant adverse effect on the interests of any person or body. The authority has therefore decided to omit to invite public submissions prior to making full assessments.
