**3. Nomination of Tangata Tiaki/Kaitiaki**—The Tauwhare whanau, being tangata whenua holding manawhenua manamoana over the area from Piopiotahi to Kahurangi Point, have nominated William Ihaia Tauwhare as Tangata Tiaki/Kaitiaki for the area/rohe moana.

**4. ##### The Treaty of Waitangi Act 1975 The State-Owned Enterprises Act 1986

ANY MAORI PERSON WHO CONSIDERS THAT THEY, OR ANY GROUP WHICH THEY BELONG TO, HAS A CLAIM TO MAKE TO THE WAITANGI TRIBUNAL ABOUT THIS LAND SHOULD SUBMIT THEIR CLAIM TO THE WAITANGI TRIBUNAL BEFORE THE 30TH DAY OF DECEMBER 1998.

Section 6 of the Treaty of Waitangi Act 1975, describes

what a claim is. Claims may be posted or sent to the Registrar, Waitangi Tribunal, Seabridge House, 110 Featherston Street (P.O. Box 5022), Wellington.

If no claim about this land is made to the Waitangi Tribunal before the 30th day of December 1998, then the Tribunal may recommend that the land no longer be liable to be resumed by the Crown and returned to Maori ownership under section 27B of the State-Owned Enterprises Act 1986.
