In considering an application to amend the new standard the authority is required to make its assessment according to the ANZFA Safety assessment Guidelines for Foods Produced Using Gene Technology.

Processing Aids (P188) A proposal to review the recently established Standard A16, principally to seek comment regarding processing aids used in New Zealand but not recognised in the standard, with the intention of establishing a joint Australia New Zealand Standard.
