#### Consultation on Proposed Changes to 1999/2000 Premium and Experience Rating Regulations

ACC proposes to recommend changes in the employer and earner premiums and experience rating regulations to the Minister for ARCI.

The Government has directed ACC to move from pay-as-you-go to a full funded reserving basis. Full funding means ACC must collect enough premiums in the year the injury occurs to cover the full ongoing cost of that injury into the future.

# **1. Employment Premium Regulations**

ACC proposes to recommend a reduction to the workers' compensation (Employer Account) premiums.

This recommendation reflects lower scheme costs resulting from improved scheme performance.

As this account is a mature account (that is, it has been operational for 24 years), the move to full funding has little impact on premium rates.

There are two components to the 1999/2000 premium rates:

- The insurance component which is a full funded price for new claims accepted from 1 April 1999; and
- A "reserves portion" of the employer premium to fund existing claims as at 31 March 1999 for the next 15 years and to ensure sufficient reserves are built up to fully fund the Employers' Account at that stage.

When the Accident Insurance Bill currently before the House of Representatives is enacted, all employers paying premium in arrears will be required to make a cessation adjustment. The Corporation proposes to recommend that the cessation adjustment for arrears payers be based on the 1998/99 "pay-as-you-go" premium rate (i.e., \$1.70 per \$100 of liable earnings (excluding G.S.T.)).

# 2. Earners Premium Regulations

The Earners' Account pays for the cost of non-work and non-motor vehicle accidents for all earners (e.g., injuries at home and leisure time).

ACC proposes to recommend an increase to the earner premium.

This increase reflects the move from a pay-as-you-go to a full funding reserving basis. The Earners' Account is an immature one which has been in operation for only 6 years (i.e., the current scheme covers only 6 years' costs). The shift to full funding requires the cost of all future liabilities to be funded by today's premiums.

The Corporation proposes to recommend to the Minister for ARCI that the premium rate be increased from \$1.20 to \$1.30.

# **3. Experience Rating**

ACC proposes to recommend that the Experience Rating Regulations be amended so that:

- Small employers receive any 1998/99 experience rating discount using the new experience rating formula, but are not charged any resulting experience rating loading; and
- Experience rating assessments and any subsequent reassessments cease after 31 December 1999.

The area in the immediate vicinity of the mouth of the Rangitata River that comprises the bar to the river and any turbulent water on either side of the bar through which safe navigation requires a speed in excess of 5 knots.

### Second Schedule

1. Notwithstanding any other provision of this notice, no person who is permitted by any such provision to propel or navigate a small craft at a speed through the water exceeding 5 knots shall do so in any manner that is likely to endanger or unduly annoy any person who is, in, on, or using the waters or fishing, or undertaking any recreational activity in the vicinity of the small craft.

2. All persons in charge of a vessel shall adhere to and keep the provisions of all Acts and regulations not specifically exempted by this notice.

#### 1. Preamble

The variations set forth in the Schedule below are variations to the *Food Standards Code* (hereinafter called "the Code") which was published by the National Health and Medical Research Council in the *Commonwealth of Australia Gazette*, No. P 27, on 27 August 1987, and which has been varied from time to time.

The Schedule contains variations adopted by the Australia New Zealand Food Standards Council in October 1998.

These variations are published pursuant to section 32 of the Australia New Zealand Food Authority Act 1991.

#### 2. Citation

These variations may be collectively known as Amendment No. 41 to the Code.

#### 3. Commencement

These variations commence on 18 November 1998 and cease to have effect on 13 February 2000.

#### **Editorial Notes:**

(1) Subclauses (e), (f), (g), (h) and (i) implement a pilot trial of a management system for health claims. The outcomes of the pilot will be used to assist in the evaluation of a proposal to allow wider use of health claims in food labels and advertisements. The subclauses cease to have effect on 13 February 2000.

(2) Due to anticipated delays in the publication of amendments into the Food Standards Code, the approved foods/products listed in Column 1 to subclause (e) are also listed in a Register which is held at and by the Australia New Zealand Food Authority. The Register contains the most up to date list of approved foods/products.

(3) Clause (13) of Standard A1 should be read in conjunction with Standard A9 - Vitamins and Minerals.

(f) A health claim must not be made in respect of the following foods-

- (i) food standardised in Part P of this Code;
- (ii) food standardised in Standards R4, R5, R6, R7 and R10 of this Code; and
- (iii) soft cheeses and pâté.

(g) The label on or attached to a package of food, in respect of which a health claim set out in the Table has been made, must include—

- (i) a nutrition information panel in accordance with clause (13) of this Standard, which additionally includes the average quantity of folate in one serving of the food, beside the proportion of the RDI of folate contributed by one serving of the food;
- (ii) an asterisk accompanying the word "folate" in the nutrition information panel which refers to a footnote advising that the RDI of 200 micrograms referred to is for adults, whereas for women, at least 1 month before and during pregnancy, the recommended folate intake is 400 micrograms per day;

# Countrywide Banking Corporation Limited — Notification That Notice has Been Given to the Reserve Bank to Remove Countrywide Bank's Name From the Register of Banks

Countrywide Banking Corporation Limited ("Countrywide Bank") is requesting that it be removed from the register of registered banks because it will amalgamate with The National Bank of New Zealand Limited (the "National Bank") with effect from 27 November 1998.

As a result of the amalgamation:

(i) both Countrywide Bank and the National Bank will become one legal entity named The National Bank of New Zealand Limited;

- (ii) the National Bank will succeed to all the property, rights, powers, privileges, liabilities and obligations of Countrywide Bank;
- (iii) the business of Countrywide Bank will continue as usual, but will be carried on through a separate trading arm of the National Bank, rather than by Countrywide Bank as a separate legal entity;
- (iv) all correspondence with Countrywide Bank will continue to be directed through the current channels.

Countrywide Bank is required to formally notify the public that it has given notice to the Reserve Bank under section 71 (2) of the Reserve Bank of New Zealand Act 1989 requiring the Reserve Bank to remove the name of Countrywide Bank from the register of registered banks on 27 November 1998.
