1. Title and commencement—(1) This notice may be cited as the Fisheries (South Island Customary Fishing) Notice 1998.

(2) This notice shall come into effect the day after the date of its notification in the *New Zealand Gazette*.

2. Interpretation—In this notice:

(a) The term “customary food gathering” has the same meaning as defined in the Fisheries (South Island Customary Fishing) Regulations 1998.

(b) Any reference to “Tangata Tiaki/Kaitiaki” means the person or persons appointed under regulation 9 of the Fisheries (South Island Customary Fishing) Regulations 1998 as Tangata Tiaki/Kaitiaki for a general customary food gathering area/rohe moana and confirmed in clause 4 of this notice.

(c) Any reference to area/rohe moana means the area from Piopiotahi to Tokata extending seaward to the limit of the South Island fisheries waters as defined under regulation 2 of the Fisheries (South Island Customary Fishing) Regulations 1998, being the 200 mile limit; and inland to the boundaries defined for Te Runanga O Awarua, Te Runanga O Oraka Aparima, Hokonui Runaka and Waihopai Runaka in the First Schedule of Te Runanga O Ngai Tahu Act 1996. The area/rohe moana therefore includes South Island fisheries waters about and within Rakiura and other offshore islands situated within the 200 mile limit.

3. Nomination of Tangata Tiaki/Kaitiaki—Te Runaka O Waihopai supported by Te Runaka O Awarua, Oraka/Aparima Runaka and Hokonui Runaka, being the tangata whenua holding manawhenua manamoana over the area/rohe moana, have nominated John Bain as Tangata Tiaki/Kaitiaki for the area/rohe moana.

4. Appointment of Tangata Tiaki/Kaitiaki—The Associate Minister for Food, Fibre, Biosecurity and Border Control hereby confirms the appointment of John Bain as Tangata Tiaki/Kaitiaki for managing customary food gathering for the area/rohe moana. The appointment is for a term of 5 years commencing the day this notice comes into effect.

5. Power to authorise taking of fisheries resources for customary food gathering—The Tangata Tiaki/Kaitiaki may authorise any individual to take fisheries resources managed under the Fisheries Acts 1983 and 1996 for customary food gathering purposes from within the whole or any part of the above area/rohe moana. No customary food gathering of these resources may take place in the area/rohe moana without authorisation from the Tangata Tiaki/Kaitiaki.

Social Security Act 1964

Amendment to the Special Needs Grant Welfare Programme

“20H.1 Farmers affected by the prolonged period of rainfall that started in September 1997 in the Buller, Grey and Westland Districts are eligible for financial assistance under this Part as if clause 20C.1 applies to them.

“20H.2 Farmers affected by the floods in July 1998 in the Waikato and Franklin Districts are eligible for financial assistance under this Part as if clause 20C.1 applies to them.

“20H.3 In relation to such farmers, this Part comes into effect on 2 November 1998 and ceases to apply on 2 November 1999, unless extended by the Minister.

“20H.4 For the purposes of assisting such farmers under this Part, clause 20C.2 does not apply.”

Explanatory Note:

This note is not part of the welfare programme but is intended to indicate its general effect.

These amendments, approved by the Minister of Social Services, Work and Income under section 124 (1) (d) of the Social Security Act 1964, amend the welfare programme approved by the Minister on 8 January 1996 relating to special needs grants.

The amendments to the programme are to assist farmers affected by the prolonged period of rainfall in the Buller,

Grey and Westland Districts, and farmers affected by the floods in the Waikato and Franklin Districts.

The changes to the programme come into force on 2 November 1998.
