The intention is that the referendum be held in 1999 on the polling day for the general election.

Saturday, 18 December 1999, is the last possible polling day for the general election.

If the writ for the general election appoints a polling day earlier than 18 December 1999, this order may be revoked and the earlier polling day may be appointed as the day for the holding of the referendum.

- 2. Must comprise a format having separate sections for information on the class of motor vehicle, the vehicle description, vehicle identifiers, and certification;

  - make and model of the vehicle,

  - year of first registration (if a used vehicle),
  - cc rating or kW rating of engine,
  - Vehicle Identification Number or chassis number;
- 4. Must include information relating to the means by which original standards compliance, as specified in

section 4.4 of the rule, is demonstrated (this requirement may be met by attaching relevant documentation);

- 5. Must confirm that the vehicle complies with applicable requirements;
- 6. Must confirm, if appropriate, that any necessary specialist certification and other information specified in section 4.8 (6) has been obtained;
- 7. May include other relevant details.

## Conditional certification: in-service-fitness (temporary permit)

The document of compliance for the purpose of conditional certification (temporary permit) for in-service fitness (section 5.8 (2) of Land Transport Rule: Vehicle Standards Compliance 1998):

- 1. Must include the name and signature of the certifier and the date of certification;
- 2. Must include information on the:
  - class, registration number, make and model of the motor vehicle,
  - Vehicle Identification Number or chassis number;
- 3. Must include the name of the owner of the vehicle and the address of the owner;
- 4. Must include the date of expiry of the temporary certification (which must be no more than 28 days after the date of issue of the temporary certification);
- 5. May include conditions specified by the certifier;
- 6. May include other relevant details.

# Conditional certification: in-service fitness (daylight operation only)

The document of compliance for the purpose of conditional certification (daylight operation only) for in-service fitness (section 5.8 (3) of Land Transport Rule: Vehicle Standards Compliance 1998):

- 1. Must include the name and signature of the certifier and the date of certification;
- 2. Must include information on:
  - the registration number of the motor vehicle,
  - the make of vehicle;
- 3. Must include the name of the owner of the vehicle;
- 4. Must include the date of expiry of the conditional certification (daylight operation only);
- 5. Must include a condition that the vehicle not be operated during the hours of darkness;
- 6. May include other conditions specified by the certifier;
- 7. May include other relevant details.

#### Specialist certification

Documents of compliance for the purpose of specialist certification (including any of the purposes listed in section 2.4 (2) (b) of Land Transport Rule: Vehicle Standards Compliance 1998):

- 1. Must include the name and signature of the certifier and the date of certification;
- 2. Must have a format comprising sections with information relevant to the class of motor vehicle, the vehicle description, vehicle identifiers, and certification;
- 3. Must include information relevant to the purpose of specialist certification (for example modifications; repair; vehicle dimensions; matters relevant to the structure, systems, components or equipment of a vehicle, or installation or use of a vehicle's structure, systems, components or equipment; alternative fuel

systems; age or historic nature of a vehicle; class of vehicle; or any other attribute of a vehicle);

- 4. Must confirm that the vehicle, or any aspect of it relevant to the purpose of specialist certification, complies with applicable requirements as specified in Land Transport Rule: Vehicle Standards Compliance 1998; and
- 5. May include other relevant details.

### Stickers, compliance plates and labels

Pursuant to paragraph 2.7 (5) (c) of Land Transport Rule: Vehicle Standards Compliance 1998, I, Barry Georges Bouton, Business Manager, specify as records of certification for Land Transport Rule: Vehicle Standards Compliance 1998 stickers, compliance plates and labels that are of the format and contain information as specified below:

#### Certification for in-service fitness for all motor vehicles, except those vehicles specified in Schedule 2 of the rule, unless the vehicle is also specified in Schedule 3 ("Warrant of Fitness" label)

The Warrant of Fitness label prescribed by the General Manager, Operations, Land Transport Safety Authority on 27 July 1998 (*New Zealand Gazette*, 30 July 1998, No. 100, page 2295) is specified as the vehicle label which is a record of certification for in-service fitness (section 5.4 (2) (a)) for all motor vehicles, except those vehicles specified in Schedule 2 of the rule, unless the vehicle is also specified in Schedule 3.

(i) This exemption applies to vehicles with headlamps as specified by regulation 58 (1) (a) of the TR76 ['single headlamps'];

(ii) This exemption also applies to vehicles with dual headlamp systems<sup>1</sup> as specified by regulation 58 (1) (b) of the TR76, but only if any such dual headlamp system is the vehicle manufacturer's original equipment specification, and only if any such dual headlamp system comprises no more than two main beam headlamps;

<sup>1</sup> A pair of auxiliary headlamps (including front fog lamps) fitted to a vehicle with single headlamps does not make the vehicle a vehicle with a dual headlamp system for the purpose of this notice, even if the auxiliary headlamps (including front fog lamps) were fitted by the vehicle manufacturer as original equipment.

(iii) One pair, and only one pair<sup>2</sup>, of auxiliary headlamps (other than front fog lamps) may be fitted to a vehicle, whether as original equipment or after market, providing the lamps comply with one of the standards approved for headlamps under Item 5 of the Second Schedule of the VSR90<sup>3</sup>, and providing the lamps are electrically connected so that they cannot be operated when the vehicle's original equipment headlamps are switched on low beam;

- <sup>2</sup> For Group L vehicles, the fitting of only one auxiliary headlamp (other than a front fog lamp) is also permitted.
- <sup>3</sup> Auxiliary headlamps (other than front fog lamps) fitted to Class MA or NA vehicles first registered in New Zealand before 1 January 1992, or fitted to vehicles of other Classes of Groups M and N first registered in New Zealand before 1 January 1996, or fitted to any Group L vehicles, are not required to meet approved standards providing the lamps are fitted with globes that do not exceed 55 watt.

(iv) One pair, and only one pair<sup>4</sup>, of front fog lamps may be fitted to a vehicle, whether as original equipment or after market, providing the lamps comply with one of the standards approved for fog lamps under Item 13 of the Second Schedule of the VSR90<sup>5</sup>, and providing the lamps are mounted in a permanently dipped position;

- <sup>4</sup> For Group L vehicles, the fitting of only one front fog lamp is also permitted.
- <sup>5</sup> Front fog lamps fitted to vehicles first registered in New Zealand before 1 January 1996, or fitted to any Group L vehicles, are not required to meet approved standards providing the lamps are fitted with globes that do not exceed 55 Watt.

[Note: Under the TR76, a fog lamp is interpreted as a lamp providing illumination in conditions of fog, snow, cloud, or other atmospheric conditions which reduce visibility.]

(v) Any auxiliary headlamps (including front fog lamps) permitted by this exemption, whether fitted as original equipment or after market, must be securely and rigidly mounted, and must not emit light other than one that is substantially white or amber in colour.

### **Overseas Investment Policy, Delegation and Criteria**

1. This letter conveys the Government's general policy approach to overseas investment (investment) and indicates a new level of delegated authority for the Overseas Investment Commission (the commission) and its staff to determine applications and related matters as from the date of this letter.

### **General Policy Approach**

2. Section 9 (2) of the Overseas Investment Act 1973 (the Act) requires the commission to "comply with the general policy of the Government...transmitted in writing...by...the

Minister [Treasurer] and the Minister of Lands". We wish to convey the following general policy of the Government in relation to the exercise of the commission's functions, powers, and duties:

(a) The Government recognises the need for overseas capital and welcomes and encourages investment. Our policy reflects the need to develop strong international linkages and that the inflow of investment typically provides a net benefit to the New Zealand economy.

(b) The Government is committed to an open and facilitative investment regime. Accordingly:

- (i) The investment criteria applications must meet should be interpreted in a manner that facilitates rather than impedes investment;
- (ii) Proposals that satisfy the investment criteria should be approved unless good reason exists to refuse them; and
- (iii) Any regulations made under the Act should be applied in a clear, consistent and efficient manner.

(c) The commission's operating procedures should be consistent with the Government's intention to facilitate positive investment. Accordingly, the commission should:

- (i) Perform its functions in a timely, consistent and efficient manner;
- (ii) Seek to minimise the compliance and transactions costs to the private sector of the investment regime;
- (iii) Continue to make its decisions based largely upon material supplied to it by investors. It should regard the information as having been provided in good faith unless the commission has good reason to believe otherwise;
- (iv) Continue to advise Ministers on proposals with the presumption that the investment will be compatible with the policy of the Government relating to any other matter;
- (v) Seek to recover its operating costs, through fees that must be approved by the Treasurer, from persons who use its services;
- (vi) Continue to monitor compliance with any conditions of approval, consent, permission, or exemption granted under the regulations with an approach that seeks a balance between the objectives of ensuring compliance with any conditions and providing the commission with more accurate statistics on investment, and the desire to maintain a welcoming approach to investment; and
- (vii) Continue the practice of the commission's staff performing the commission's day-to-day functions, with the commission's role being primarily one of governance and overview.

3. We are aware that the commission compiles information on investment in New Zealand in the course of performing its functions. To the extent that existing resources permit, the commission, in conjunction with other relevant agencies, should:

(a) Disseminate information on investment in New Zealand;

(b) Seek to raise public awareness about the usefulness of investment; and

(c) Publicise and explain the nature of our regulatory regime to potential overseas investors.

### Delegation

4. The Treasurer delegates to the commission and its staff the power to determine all applications under Part II of the Overseas Investment Regulations 1995 (the regulations). 5. The Treasurer and the Minister for Food, Fibre, Biosecurity and Border Control (the Ministers) delegate to the commission and its staff, in relation to Part III of the regulations:

(a) their powers to determine applications which do not involve "sensitive" land as described in the First Schedule to the Act and regulations under the headings of Islands, and Foreshore, lakes and reserves and Land over 0.4 hectares on certain islands;

(b) notwithstanding (a) above, their powers to determine land applications:

- (i) which do not involve a freehold estate or other estate or interest in land equivalent to a freehold estate; or
- (ii) which are part of a purchasing programme previously approved by the Ministers under the Overseas Investment Regulations 1985 and 1995 or the Land Settlement Promotion and Land Acquisition Act 1952, where each acquisition is consistent with any conditions established for the programme; or
- (iii) involving land that is "sensitive" solely because it includes or adjoins a marginal strip that extends along and abuts any river or any stream.

6. The Ministers also delegate to the commission and its staff the following related matters:

(a) their powers under regulation 12 to specify information and particulars to be supplied by applicants;

(b) their powers under regulation 14 in respect of applications:

(i) which have been delegated in terms of paragraphs 4 and 5 above; or

(ii) which have been initially considered by the Ministers and that require an administrative amendment.

(c) their powers under regulation 16 in respect of applications that have been delegated in terms of paragraphs 4 and 5 above.

(d) their powers under regulation 16 in respect of adding entities to or deleting entities from the Schedules to the Overseas Investment Exemption Notice 1995;

(e) their powers under regulation 17 in respect of any matter delegated;

(f) their powers under section 15 of the Act in respect of applications that have been delegated; and

(g) in each case where a power has been delegated, the power of delegation under section 16 of the Act.

### Criteria

7. In considering any applications under delegation the commission and its staff must take into account the matters provided for under section 14A of the Act.

### **Revocation of Existing Delegation**

8. The existing delegation conferred on the commission and its staff on 21 December 1995 is hereby revoked as from the date of this letter.
