- (j) One member to be appointed by an electoral college comprising the local branches of Federated Farmers of New Zealand, Country Women's Institute, Women's Division of Federated Farmers of New Zealand, Young Farmers Club, and the Fruitgrowers' Federation of New Zealand.
- (k) Up to 5 members to be co-opted by the Otago Polytechnic Council if and when it thinks fit, taking into account the specific needs of the Otago Polytechnic, its unique character, and the gender, ethnic and socio-economic composition of the Otago Community.

4. Subject to section 173 of the Education Act 1989, the maximum term of office of members appointed to the council, other than the Chief Executive Officer, is three consecutive 4-year terms.

Social Security Act 1964

Ministerial Direction—Disability Allowance

To: The Chief Executive of the Department of Work and Income

Pursuant to section 5 of the Social Security Act 1964, I, Roger Morrison Sowry, Minister of Social Services, Work and Income, give you the following direction to take effect on 1 April 1999.

DIRECTION

Disability Allowance

In relation to the granting of disability allowance under section 69C of the Social Security Act 1964, you must have regard to the following matters:

1. In this direction, unless the context otherwise requires,—

“Act” means the Social Security Act 1964;

“Subsidised”, in relation to a pharmaceutical product, means that the cost of the product is met by a purchaser; and the terms “subsidy”, “partly subsidised” and “unsubsidised” have corresponding meanings,—

and terms otherwise defined in section 3 (1) and section 69C (8) of the Act have the meanings so defined.

Where the context requires, words referring to the singular include the plural, and vice versa.

Verification

2. Before determining whether a person has additional expenses of a kind required by section 69C (2A) (a) of the Act, you must require the applicant to provide written verification that—

- (a) He or she is incurring the expenses claimed; and
- (b) The expenses are of an ongoing kind; and
- (c) The expenses arise from the person's disability,—

by way of—

(d) A certificate from a registered health professional as to the need for the goods or services to which the expenses relate, how that need relates to the person's disability, the expected duration of that need, and the therapeutic value to the person in receiving the goods or services; and

(e) Invoices or receipts for payment of the expenses; and

(f) Any other verification that you consider necessary or satisfactory.

3. When reviewing a person's entitlement to any disability allowance, you are not required to verify the expenses where you are satisfied that—

(a) The circumstances have not changed having regard to the matters in clauses 4, 5, and 6; and

(b) Those expenses have been verified under this direction within the last 12 months.

Additional expenses arising from the disability

4. When determining whether a person has additional expenses of a kind required by section 69C (2A) (a) of the Act, you must consider—

(a) Whether the person is incurring ongoing expenses which result from the person's disability, having regard to—

(i) The relationship between the disability and the need to incur the expenses; and

(ii) The other matters referred to in clause 2 (d); and

(iii) Whether the person would be incurring the expenses if he or she did not have the disability; and

(iv) Whether the expenses or an expense of that kind was being incurred before the disability arose and the reasons for incurring that expense at that time; and

(b) Whether a person in a similar position who does not have the particular disability would incur expenses of that type or amount; and

(c) Whether there are less costly goods or services which might meet the need referred to in clause 2 (d); and

(d) Any other matters you consider to be relevant.

5. When determining whether the cost of a partly subsidised or unsubsidised pharmaceutical product is an additional expense of a kind required by section 69C (2A) (a) of the Act, you must have regard to the matters in clause 4 and the following additional matters—

(a) The availability of another subsidised or partly subsidised pharmaceutical product which may be adequate to meet the need referred to in clause 2 (d); and

Exercise of Discretion

6. Where you consider that the applicant fulfils the requirements of section 69C of the Act, you must grant a disability allowance only if, having regard to the following matters, you believe such grant is justified:

1.1 This welfare programme is called the Telephone Costs Payment programme.

2. Objectives of the Programme

2.1 The objectives of this programme are to—

(a) provide non recoverable financial assistance to certain persons who lose entitlement to a Disability Allowance for Telephone Rental Costs;

(b) ensure that the financial assistance set out in paragraph (a) is provided within the limits and for the reasons prescribed.

3. Definitions

3.1 In this programme, unless the context otherwise requires,—

“Act” means the Social Security Act 1964;

“Disability Allowance” means a disability allowance payable under section 69C (1) of the Act;

“Payment” means a telephone costs payment, being the assistance under this programme;

“Telephone Rental Costs” means the regular and ongoing costs of—

- (a) Renting a basic telephone; or
- (b) Telephone line rental; or
- (c) Both (a) and (b).

3.2 Expressions otherwise defined in section 3 (1) of the

Act have the meanings so defined unless the context otherwise requires.

Note: Words, or phrases whose words begin with capital letters generally refer to either a definition in clause 3.1 or an expression defined in section 3 (1) of the Social Security Act 1964.

4. Application of the Social Security Act

4.1 Sections 3, 12, 62, 63, 63A, 64, 66, 66A, 66B, 68, 68A, 70, 71, 73, 74, 74A, 76, 77, 78, 80A, 81, 82 (except 82 (6)), 82A, 84, and 86J of the Act apply, with any necessary modifications, to this programme as if a Payment under this programme were a Benefit under the Act.

4.2 Nothing in clause 4.1 limits any other provision of the Act.

5. Eligibility for Payment

5.1 The Chief Executive may grant a Payment to any person who—

(a) Was, immediately before 1 April 1999, and continuously until the decision referred to in paragraph (b), in receipt of a Disability Allowance for Telephone Rental Costs; and

(b) Is no longer in receipt of a Disability Allowance for Telephone Rental Costs because of a decision of the Chief Executive under section 69C (2A) (a) of the Act made on or after 1 April 1999.

6. Rate of Payment

6.1 Rate equal to Disability Allowance rate

The amount of a Payment on a weekly basis is an amount not greater than the amount of Disability Allowance for

Telephone Rental Costs which the person received immediately prior to 1 April 1999.

Provided that where the person continues to receive a Disability Allowance for other costs, the Chief Executive must adjust the amount of the Payment so that the total of the Disability Allowance and the Payment does not exceed on a weekly basis the maximum weekly rate of a Disability Allowance in clause 2 of the nineteenth schedule of the Act.

7. Beginning and end of payments

7.1 Beginning

No Payment may be made earlier than the Pay Day following the date on which the person ceased to be in receipt of a Disability Allowance for Telephone Rental Costs.

7.2 End

A Payment ceases to be payable—

(a) On the date the person ceases to be eligible to receive a Disability Allowance for some reason other than the application of section 69C (2a) (a) of the Act; or

(b) Where the person had received a Disability Allowance only for Telephone Rental Costs, on the date the Chief Executive decides that the person would have ceased to be entitled to that Disability Allowance for some reason other than the application of section 69C (2a) (a) of the Act.
