### Notice of Decision of the Disciplinary Tribunal of the Institute of Chartered Accountants of New Zealand

At a hearing held on the 23rd day of July 1998, the disciplinary tribunal of the Institute of Chartered Accountants of New Zealand heard 4 charges against **Gavin Richard O'Dea** of Hawera.

The charges related to the member's conduct of his accountancy practice and the administration of finance companies through that practice.

**Gavin Richard O'Dea** appeared before the disciplinary tribunal and pleaded not guilty to all charges.

After hearing submissions on behalf of the professional conduct committee and the member, the disciplinary tribunal found the member guilty on charges of:

- negligence and/or incompetence in a professional capacity which has been of such degree and/or frequency as to reflect on his fitness to practice as an accountant and/or tends to bring the profession into disrepute; and
- breaching the code of ethics of the institute.

Acting under rule 21.31 of the rules of the Institute of Chartered Accountants of New Zealand, the disciplinary tribunal ordered that **Gavin Richard O'Dea** be suspended from the Register of Members of the institute for a period of 2 years, and the certificate of public practice held by the member be cancelled.

**Gavin Richard O'Dea** was also ordered to pay to the institute the sum of \$40,000 (incl. G.S.T.) in respect of the costs and expenses relating to the inquiry by the disciplinary tribunal and of the investigation by the professional conduct committee.

The disciplinary tribunal ordered that its decision be published in the *Chartered Accountants Journal of New Zealand*, the *New Zealand Gazette*, and a circulating newspaper in the Taranaki area, with mention of the member's name and locality.

**Gavin Richard O'Dea** lodged an appeal against the decision of the disciplinary tribunal and the level of costs awarded.

At a hearing held on the 27th day of November 1998, the appeals council considered submissions from the member and on behalf of the professional conduct committee.

The appeals council confirmed the disciplinary tribunal decision and costs awarded as appropriate, and dismissed the appeal.

#### Consultation on the Self-employed Work Premium Regulations

##### Accident Insurance Act 1998

ACC currently provides all cover for personal injury. Under the Accident Insurance Act 1998, self-employed people may, from 1 July 1999, choose to buy work and most of their non-work personal injury insurance cover from a private insurer or remain with ACC.

A new self-employed work account will cover self-employed and private domestic workers who choose to continue to insure with ACC for their work injuries. The self-employed work account will be funded by premiums paid by self-employed and private domestic workers.

ACC invites interested premium payers to make submissions about the premium rates for the new self-employed work account before a final recommendation is made to the Minister for ARCI. The new premium rates will take effect from 1 July 1999.

ACC is proposing to adopt the existing employer premium classification system as the basis for a new self-employed work premium classification system. This will allow premium rates to reflect the accident risk according to the type of work undertaken by the premium payer.

Premiums for the account will be assessed on a fully-funded basis. The premium rate has 2 components:

- an income related benefit premium; and
- a non-income related benefit premium.

In addition, there will be up to 3 personal adjustment factors which will adjust the final premium payment to reflect the individual risk characteristics of each premium payer.

##### Variations to the Food Standards Code (Amendment No. 43)

###### 1. Preamble

The variations set forth in the Schedule below are variations to the Food Standards Code (hereinafter called "the code") which was published by the National Health and Medical Research Council in the *Commonwealth of Australia Gazette*, No. P 27, on 27 August 1987, and which has been varied from time to time.

The Schedule contains variations adopted by the Australia New Zealand Food Standards Council in January and March 1999.

These variations are published pursuant to section 32 of the Australia New Zealand Food Authority Act 1991.

###### 2. Citation

These variations may be collectively known as Amendment No. 43 to the code.

###### 3. Commencement

These variations commence on the date of publication of this *Gazette* with the exception of item [2.] which will commence on 13 May 1999.

[1.] Standard A12 is varied by—

[1.1] *omitting* from paragraph (1) (d)—

and, in the case of a food in a dried, dehydrated or concentrated form, shall be calculated with respect to the mass of the food after dilution or reconstitution; and

[1.2] *omitting* paragraph (1) (da) and substituting—

(da) unless otherwise specified, the concentration for a food which is dried, dehydrated or concentrated is to be calculated on the basis of the mass of the food, or the mass of the ingredients of the food, prior to drying, dehydration or concentration determined from one or more of the following—

- (i) the manufacturer's analysis of the food;
- (ii) calculation from actual or average quantity of water in the ingredients used;
- (iii) generally accepted data;

(db) the concentration for seaweed (edible kelp) whether dried, dehydrated, concentrated or not is to be calculated with respect to the mass of the seaweed at 85 percent hydration;

[2.] Standard A18 is varied by inserting immediately after the table to clause 2—

#### Exemption to general prohibition on sale

2A. (1) For the purposes of this clause—

- (a) "the Act" means the Australia New Zealand Food Authority Act 1991;
- (b) "the authority" means the Australia New Zealand Food Authority established under the Act;



- (c) "the council" means the Australia New Zealand Food Standards Council as defined by the Act.
- (2) The prohibition in clause 2 does not apply to a food produced using gene technology where—
- (a) the food is the subject of an application under section 12 of the Act to vary the table to that clause;
- (b) the application has been accepted in accordance with section 13 of the Act by the authority on or before 30 April 1999;
- (c) the authority has evidence that the food, in one or more countries, other than Australia or New Zealand, is lawfully permitted as a food, by a national food regulatory agency; and
- (d) the council has not become aware of evidence that the food poses a significant risk to public health and safety.
- [3.] Standard N1 is varied by inserting after clause (11)—
- (12) (a) Longans may be treated with sulphur dioxide.

(b) The edible aril of longans treated with sulphur dioxide as referred to in paragraph (a) must not contain more than 10 mg/kg of sulphur dioxide at the time of retail sale.

(c) (i) Where longans have been treated as referred to in paragraph (a) are displayed for retail sale otherwise than in a package, the display of longans must be accompanied by a statement indicating the possible presence of sulphur dioxide on the longans.

(ii) The label on or attached to a container of longans treated with sulphur dioxide, or a package containing longans which have previously been treated with sulphur dioxide in such a container, must include a statement indicating the possible presence of sulphur dioxide on the longans.
