Now therefore I, Sir Michael Hardie Boys, the Governor-General of New Zealand, and as such the Governor of the Dependency, appoint

Kevin Richard Rigarsford

to be an officer of the Government of the Dependency while he acts as Senior New Zealand Representative at Scott Base during the period beginning with this appointment and ending with the close of 16 October 1999:

I confer on Kevin Richard Rigarsford, while he holds office as an officer of the Government of the Dependency, all the powers exercisable in New Zealand by a Justice of

the Peace, and also the powers exercisable in New Zealand by a Coroner:

Kevin Richard Rigarsford is to exercise his functions at such places within the Dependency as may be directed by an officer of the Government of the Dependency who has the general executive and administrative authority in preserving Her Majesty’s rights and sovereignty and the laws in force in the Dependency.

10. Where a boundary is shown there shall be immediately adjacent to those lands a fire safety margin of 1 kilometre deemed to be within the boundaries of the Eastland Rural Fire District, but does not include where the fire safety margin overlaps an adjacent Rural Fire District.

11. The boundaries are more particularly delineated, but excluding the fire safety margin, on those plans NRFA 128 and NRFA 131 entitled Eastland Rural Fire District, deposited in the office of the Chief Executive of the New Zealand Fire Service, Wellington.”

#### Bylaw Requiring Snow Chains to be Carried or Fitted by Vehicles Using State Highway No. 94 (Milford Sound Highway)

Pursuant to section 61 (3) of the Transit New Zealand Act 1989, Transit New Zealand hereby makes the following bylaw:
