#### Accident Insurance Act 1998

#### Direction to the Accident Compensation Corporation Relating to Government Policy on Education Support for Children

#### Background

- 1. Under regulations made pursuant to the Accident Rehabilitation and Compensation Insurance Act 1992, ACC provided transport to schools, and teacher aides for children who were covered by that Act and needed assistance to receive education. Those regulations are revoked by the Accident Insurance Act 1998 ("the Act") from 1 July 1999.
- 2. Under section 290 of the Act, ACC must pay from the Non-Earners' Account, an amount to pay for education-related support for children requiring special assistance as a result of personal injury covered by the Act to enable them to receive education.

3. Section 290 (5) of the Act provides that the amount to be paid, the person to whom it must be paid, and the manner of payment must be as specified in a policy direction.

#### **Policy Direction**

#### **Definitions**

- 4. The following definitions apply in this Policy Direction:
  - (a) "Insured" means any person who has cover under the Act, and is:
    - (i) Enrolled at a registered school within the meaning of the Education Act 1989 or is exempted under section 21 of that Act from the requirement to be enrolled or is exempted under section 26 (other than under section 26 (1) (b) (iii)) of that Act from attending a school; and
    - (ii) Entitled to free education at any state school under section 3 of the Education Act 1989; or
  - (b) Is attending an early childhood education service which is chartered by the Ministry of Education and which is, under section 316 of the Education Act 1989, licensed or exempted from licensing requirements.
- "Teacher Aide" means a person—
  - (a) Who assists an insured during the school day or during an early childhood education service with:
    - (i) Educational activities (whether remedial or practice work) set and supervised by the insured's teacher;
    - (ii) Dressing, grooming, feeding, toileting, and other personal care tasks;
    - (iii) Mobility and positioning; and
    - (iv) Communication and interpersonal skills; but
  - (b) Who is not, at the time of giving that assistance, the insured's classroom or subject teacher.
- 5. Pursuant to sections 290 and 481 (2) of the Act, I hereby direct that ACC must pay an amount for the costs of education-related support for children requiring special assistance as a result of personal injury covered by the Act to enable them to receive education. The amount is for the period from 1 July 1999 to 31 December 1999, and is to be calculated by adding Amount A to Amount B.

#### Amount A - Teacher Aides

- 6. ACC must pay an amount ("Amount A") for the provision of Teacher Aides.
- 7. Amount A must be calculated by:
  - (a) ACC's assessing the number of hours that each insured needs to have a Teacher Aide as the result of the injury for which they have cover under the Act; and
  - (b) Following such an assessment, paying \$13.02 for each hour that a Teacher Aide is assessed as being required for the insured.
- 8. ACC must pay the relevant parts of Amount A to each of the schools that provide the Teacher Aide.
- ACC must make payment after receiving an invoice from the schools.

#### Amount B - Transport

10. ACC must pay an amount ("Amount B") being a contribution to the cost of transport between each insured's school or early childhood education service and place of residence. Amount B is the total of, for

each insured who is entitled to Teacher Aide assistance under this Policy Direction, the amounts reached by:

- (i) Calculating the lowest fare payable on the cheapest of any available scheduled transport; or
- (ii) Where there is no scheduled transport, or such transport is not appropriate due to the insured's injury for which they have cover under the Act, calculating at the rate of \$1.00 per kilometre.
- 11. The amounts calculated must be reduced by any conveyance allowance paid by the Ministry of Education.
- 12. The amounts calculated must not exceed the amount that would have been calculated for the journey between the insured's place of residence and the nearest appropriate school or early childhood education service that meets the insured's needs.
- 13. ACC must pay the relevant parts of Amount B:
  - (i) Where it is calculated under paragraph 10 (i) above, to the insured and after the transport has been provided: or
  - (ii) Where it is calculated under paragraph 10 (ii) above, to each of the providers of the transport, after receiving an invoice from the provider.

Pursuant to section 20 (1) (b), I hereby also give notice of my intention to apply to the Minister for Enterprise and Commerce for his approval of revocation of the Approved Code of Practice for Design, Safe Operation, Maintenance and Servicing of Boilers, published by the Occupational Safety and Health Service, Department of Labour, Wellington, New Zealand, in March 1996.

#### 1. Title and commencement

- 1.1. This programme is called the Work Start Grant programme, and every grant made under it is called a work start grant.
- 1.2. This programme comes into effect on 1 July 1999.

#### 2. Interpretation

- 2.1. In this programme, unless the context otherwise requires,—
  - "52 Week Period", in relation to a Grant, means the 52 weeks immediately preceding the date of application for the Grant:
  - "Act" means the Social Security Act 1964:

- "Applicant" means the person applying for a Grant under this programme, or, as the case requires, a person on whose behalf an application for a Grant is made:
- "Bridging Finance" has the meaning in clause 5.1.4 (b):
- "Cash Assets", in relation to any person, means the assets of that person and his or her Spouse (if any) that can be readily converted into cash and include—
  - (a) Shares, stocks, debentures, bonus bonds, and other bonds:
  - (b) Bank accounts, including fixed and term deposits with any bank, friendly society, credit union, or building society:
  - (c) Money invested with or lent to any bank, other financial institution, or person:
  - (d) The net equity held in any property or land not used as the person's home:
  - (e) Building society shares:
  - (f) Mortgage investments and other long term loans:
  - (g) Bills of exchange or promissory notes:
  - (h) The person's share in any partnership,—

but do not include-

- (i) The motor vehicle principally used by the person for his or her personal use:
- (i) A caravan, boat, or other vehicle:
  - (i) The net equity in which is less than \$2,000; or
  - (ii) Which is used by the person or a member of his or her Immediate Family for day to day accommodation:
- (k) The personal effects of the person:
- "Customer" means a person of or over the age of 16 years who is seeking work, and who interacts with the Department as—
  - (a) A Beneficiary whose principal source of income is a Benefit under the Act; or
  - (b) A Job Seeker:
- "Employment" means paid employment, but does not include self-employment:
- "Grant" means a work start grant, being the special assistance authorised under this programme:
- "Immediate Family", in relation to a person, means—
  - (a) In the case of a married person, that person and his or her Spouse and Dependent Children (if any); and
  - (b) In the case of a Sole Parent, means that person and his or her Dependent Children:
- "Income" means income within the meaning of section 3 (1) of the Act, modified in accordance with clause 7?
- "Job Seeker" means a person who, in accordance with the policies of the Department, is actively enrolled with the Department as a job seeker:
- "Parents", in relation to an Applicant who is a Dependent Child, means the person or persons on whom the Applicant is financially dependent:
- "Transition To Work Expenses" has the meaning in clause 5.2.
- 2.2. Terms otherwise defined in section 3 (1) of the Act have the meanings so defined, unless the context otherwise requires.

Note: Words, or phrases whose words begin with capital letters in this programme generally have the meanings

- defined in clause 2.1. In this programme, unless the context otherwise requires,— or in section 3 (1) of the Act.
- 2.3. Words referring to the singular include the plural, and words referring to the plural include the singular.

#### 3. Objects

3.1. The objects of this programme are to increase Job Seekers' prospects of obtaining sustainable Full-time Employment or Part-time Work, and thereby gaining financial independence, by providing non-recoverable financial assistance toward certain essential costs of entering Employment to persons who would not be able to enter Employment without that assistance.

#### 4. Application of Social Security Act

- 4.1. Sections 3, 12, 62, 63, 64, 66, 66A, 66B, 68, 68A, 71, 73, 74, 74A, 76, 77, 80A, 81, 82 (7), 82A, 84 and 86J of the Act apply to this programme and to an applicant for a Grant under this programme, as if a Grant were a Benefit under the Act.
- 4.2. Nothing in clause 4.1 limits any other provision of the Act.

#### 5. Eligibility

- 5.1. Subject to this programme, the Chief Executive may make a non-recoverable Grant to an Applicant who—
  - 5.1.1. Is Ordinarily Resident in New Zealand; and
  - 5.1.2. Is a Customer; and
  - 5.1.3. Has been—
    - (a) Offered Employment for at least 15 hours a week; or
    - (b) Offered an interview for Employment of at least 15 hours a week; and
  - 5.1.4. Has an immediate need for financial assistance for one or more of the following types of essential costs—
    - (a) For an Applicant taking up the offer of Employment, Transition To Work Expenses:
    - (b) For an Applicant whose Benefit is cancelled or suspended upon entering the Employment, essential living expenses in the period between the end of the Benefit and the first payment of wages or salary ("Bridging Finance"):
    - (c) For an Applicant to whom clause 5.1.3 (b) applies, the essential costs of attending the interview; and
  - 5.1.5. Is unable to meet the need for Bridging Finance or costs from his or her resources or from any other source (including any other form of assistance available under the Act); and
  - 5.1.6. Cannot enter or continue the Employment or, as the case requires, reasonably attend the interview, unless the Grant is made.
- 5.2. In clause 5.1.4 (a), "Transition To Work Expenses" mean the essential costs that the Applicant will need to incur to enter the Employment, such as—
  - (a) The cost of job-related clothing or equipment (not being clothing or equipment the employer is required to supply to comply with the employer's obligations under the Health and Safety in Employment Act 1992):
  - (b) Initial child care costs:
  - (c) Initial transport costs:
  - (d) The costs of tattoo removal (if the Applicant is referred to a tattoo removal service by a registered medical practitioner):

(e) Relocation costs, if the Applicant needs to relocate his or her place of residence to take up the Employment,—

but do not include the cost of any training.

- 5.3. In clause 5.1.4 (c), the essential costs of attending the interview, the essential costs of attending the interview are costs such as—
  - (a) Clothing costs:
  - (b) Child care costs:
  - (c) The cost of an interpreter:
  - (d) Transport costs:
  - (e) The costs of tattoo removal (if the Applicant is referred to a tattoo removal service by a registered medical practitioner).

#### 6. Ineligibility

- 6.1. An Applicant is not eligible for a Grant during a period when the Applicant is subject to—
  - 6.1.1. A Non-entitlement Period under any of sections 60H, 115, or 116 of the Act, unless the Applicant is participating in an Organised Activity and is receiving a Benefit granted provisionally under section 123в of the Act; or
  - 6.1.2. A reduction or suspension of Benefit under any of sections 115, 116, or 117 of the Act; or
  - 6.1.3. A stand down of his or her Benefit under section 80BA of the Act.
- 6.2. For the avoidance of doubt, an Applicant is not eligible for a Grant to enter—
  - 6.2.1. Employment-related training (except for training paid for by the employer as part of the Employment the Applicant is entering), education, or work experience; or
  - 6.2.2. Community work or voluntary work; or
  - 6.2.3. An Organised Activity other than attending an interview for Suitable Employment.

#### 7. Financial Restrictions

- 7.1. An Applicant is not entitled to a Grant if his or her Income is such that it would prevent the payment of an invalid's benefit under the Act.
- 7.2. In clause 7.1. An Applicant is not entitled to a Grant if his or her Income is such that it would prevent the payment of an invalid's benefit under the Act, an Applicant's Income includes the Income of—
  - (a) His or her Spouse (if any); or
  - (b) If the Applicant is a Dependent Child, his or her Parents.
- 7.3. An Applicant is not entitled to a Grant unless the Applicant and the persons mentioned in paragraphs (a) and (b) of clause 7.2 have no Cash Assets.

#### 8. Amounts of Grants

8.1. The amount of a Grant under clause 5.1. must not exceed \$250.

- 8.2. The Chief Executive may make more than one Grant under clause 5.1. to an Applicant in a 52 Week Period, but the maximum amount of Grants made to the Applicant in a 52 Week Period must not exceed \$250.
- 8.3. For the purposes of clause 8.2., the following grants are to be considered Grants under this programme:
  - (a) A non-recoverable grant for transition to work expenses under the Special Needs Grant welfare programme approved under section 124 (1) (d) of the Act:

- (c) The Fletcher Challenge Group shall be in full compliance with section 17 of the EIR Act on expiration of this exemption.

The commission may vary or revoke this exemption at any time in accordance with section 81 (5) of the EIR Act.

# Notice of Exemption—Infrastructure & Utilities NZ Limited

- (b) During the period of the exemption, Infrastructure & Utilities NZ Limited will maintain an arms length relationship with both CentralPower Limited and Powerco Limited. Maintaining an arms length relationship means complying with the arms length rules defined in Schedule 1 of the Electricity Industry Reform Act 1998.
- (c) Infrastructure & Utilities NZ Limited will not exercise any right it may have to promote or veto the appointment of any director in CentralPower Limited or Powerco Limited. In particular, in respect of Powerco Limited, it will allow New Plymouth District Council, the other major shareholder in Pukeariki Holdings Limited, to make any determinations on directors that are required to be made under the Pukeariki Holdings Limited structure. Similarly, it will allow Palmerston North City Council and the CentralPower Electricity Trust to make the same decisions with respect to the appointment of directors to CentralPower Limited under the shareholders' deed in respect of CentralPower Limited.
- (d) The exemption expires at midnight on 30 June 2000 unless any variation or earlier revocation in terms of section 81 (5) occurs.
- (e) Infrastructure & Utilities NZ Limited will notify the commission 2 weeks in advance of additional involvement in any electricity lines or supply business, as defined in the Electricity Industry Reform Act 1998, which provides it on its own, or together with an associate, with an additional 0.5% of the assets, control rights or equity return rights of the electricity business.
- (f) Infrastructure & Utilities NZ Limited will provide the commission with monthly written reports beginning 1 month after the date of this decision on the progress it is making to achieve compliance with the Electricity Industry Reform Act 1998.

- (d) The exemption expires at midnight on 30 June 2000 unless any variation or earlier revocation in terms of section 81 (5) occurs.

- (e) Alliant International New Zealand Limited and Utility Investments Limited will notify the commission 2 weeks in advance of additional involvement in any electricity lines or supply business, as defined in the Electricity Industry Reform Act 1998, which provides either company on its own, or together with any associate, with an additional 0.5% of the assets, control rights or equity return rights of the electricity business.
- (f) Alliant International New Zealand Limited and Utility Investments Limited will provide the commission with monthly written reports beginning 1 month after the date of this decision on the progress they are making to achieve compliance with the Electricity Industry Reform Act 1998.
