- (5) Frequency use is on a shared basis and the Secretary does not accept liability under any circumstances for any loss or damage of any kind occasioned by the unavailability of frequencies or interference to reception.
- (6) Should interference occur the Secretary reserves the right to require that any apparatus licensed herein change frequency or cease operation.
- **4. Revocation** of previous notices—The Radiocommunications (General Licence for Spread Spectrum Radio Apparatus) Notice 1999 dated 2 February 1999 is hereby revoked.
- **5. Period of validity of Licence**—This licence expires on the 31st day of January 2004.

  - (i) entered into a contract for services with the company and then only in accordance with the terms of that contract; and
  - (ii) entered into a client agreement with a broker or dealer who is authorised or licensed by the laws of the country in which it operates to deal in futures contracts on behalf of that person and to hold client money for that purpose; and
- (d) does not carry on the business of dealing in futures contracts on behalf of any person other than in relation to transactions effected through a broker or dealer referred to in paragraph (c) (ii); and

that the authorisation applies in respect of futures contracts made on or effected through a futures exchange in a country other than New Zealand which is authorised by the laws of that country to operate as a futures exchange.

(3) The authorisation expires on the close of 30 August 2004.
