#### British Settlements Act 1887

#### Officer of the Government of Ross Dependency Appointed

MICHAEL HARDIE BOYS, Governor-General

Background:

- A. An Order in Council dated 30 July 1923\* ("the order") made under the British Settlements Act 1887 (UK) appoints the Governor-General of New Zealand to be the Governor of the Ross Dependency ("the Governor") and vests in the Governor certain powers:
- B. The order empowers the Governor to make rules and regulations for the peace, order, and good government of the Dependency:

- C. Regulations made by the Governor on 14 November 1923† provide that all persons appointed by the Governor may be empowered to do such things as may be necessary or desirable to ensure that the laws in force in the Dependency are duly observed and complied with in every respect, and to do all things necessary or expedient for the peace, order, and good government of the Dependency, and to safeguard and preserve Her Majesty's rights and sovereignty over and in respect of the Dependency:

- D. It is now expedient that Peter James Brookman be appointed an officer of the Government of the Dependency:

Now therefore I, Sir Michael Hardie Boys, the Governor-General of New Zealand, and as such the Governor of the Dependency, appoint

Peter James Brookman

to be an officer of the Government of the Dependency while he acts as Senior New Zealand Representative at Scott Base during the period beginning with this appointment and ending with the close of 28 February 2002:

I confer on Peter James Brookman, while he holds office as an officer of the Government of the Dependency, all the powers exercisable in New Zealand by a Justice of the Peace, and also the powers exercisable in New Zealand by a Coroner:

Peter James Brookman is to exercise his functions at such places within the Dependency as may be directed by an officer of the Government of the Dependency who has the general executive and administrative authority in preserving Her Majesty's rights and sovereignty and the laws in force in the Dependency.

As witness the hand of His Excellency the Governor-General as the Governor of the Ross Dependency, this 23rd day of November 1999.

## Accident Rehabilitation and Compensation Insurance Corporation

### Accident Insurance Act 1998

#### Consultation on Proposed Changes to the Self-employed Work Account Premiums

ACC invites premium payers to make submissions on the premium rates for the Self-employed Work Account, before a recommendation is made to the Minister for Accident Insurance. It is proposed that the new premium rates will become law from 1 April 2000.

#### Proposed Legislative Change

Parliament is currently considering a Bill designed to make changes to the competitive provision of accident insurance. This Bill, the Accident Insurance (Transitional Provisions) Bill, was introduced into Parliament before Christmas and referred to a special Select Committee for consideration. It is expected that this Bill will become law by 1 April 2000.

For self-employed people, the Bill focuses on removing the ability of the self-employed to choose an insurer other than ACC from 1 April 2000. There will be no change for those self-employed people who chose to remain with ACC. However, those who have chosen to be covered by a private insurer will be returned to ACC for cover. The self-employed work account will continue to provide cover for work place accidents for self-employed.

#### Proposed Self-employed Work Account Premium Rates

Improved scheme performance allows ACC to consult on a reduction in the average self-employed work account premium rate. Currently the average gross rate is \$2.20, but this is discounted to \$1.85 on average. The new average rate proposed is \$1.54 per \$100 of liable earnings—17% less than the effective rate.

The Self-employed Work Account pays for the costs associated with the work related personal injuries of those self-employed people and private domestic workers who are

insured with ACC. Their non-work injuries are funded by the Earners' Account. The earner premium has already been set for the year starting 1 April 2000 at \$1.08 (including G.S.T.) per \$100 of liable earnings.

The Accident Insurance Act 1998 requires that self-employed work premiums be calculated on a full funded basis and are to include a competitive neutrality component.

Full funding means that ACC needs to collect enough money in 2000 to meet all the current and future costs of the injuries that occur in 2000.

The Minister for Accident Insurance is required to issue a policy direction on competitive neutrality, for incorporation in the Self-employed Work Account premiums from 1 July 2000. On 13 December 1999 the Minister issued a policy direction that the competitive neutrality portion is to be a nil amount.

Full details of the premium rates are set out in a discussion paper (which includes the proposed regulations). These regulations provide an income benefit portion rate and a non-income portion rate for each of the 538 classifications.

## General Section

### Medical Council of New Zealand

#### Medical Practitioners Act 1995

##### Rules Made Under Section 56 Prescribing When Annual Practising Certificates are in Force

###### Preamble

Pursuant to section 9 of the Medical Practitioners Act 1995 ("the Act"), no person (other than the holder of temporary registration or interim registration) shall practise medicine under the title medical practitioner unless he or she holds both probationary registration, general registration or vocational registration and a current annual practising certificate (APC).

###### Rules for Cyclical Issue of APCs

1. The Medical Council of New Zealand ("the Council") gives notice under section 56 (1) (a) of the Act, that in 2000 there will be a change from a single annual issue of APCs (based on a year commencing 1 April) to a quarterly cyclical issue, based on a year according to the applicant's birth date.

2. The following rules made under section 56(2) of the Act give effect to the general principle that APCs be in force for 1 year, but make provision for APCs to have effect for a shorter or longer period in the following cases:

(a) First issue of APC to a medical practitioner:

Such an APC will be issued immediately after the Council meeting at which the applicant is approved for probationary or general registration.

Probationers (Classes 2-7) will be issued either an APC valid for the duration of their employment contract or an APC appropriate to the quarter in which their birth date falls, whichever the Registrar determines best satisfies the requirements of Section 9 of the Medical Practitioners Act 1995.

All other applicants will be issued with an APC appropriate for the quarter in which their birth date falls. See paragraph 4 below.

(b) Issue of APCs to medical practitioners returning to practice:

Medical practitioners may apply throughout the year as they resume practice after a period of non-practice. Such APCs will be issued in accordance with the cycle set out in paragraph 4 below.

(c) Issue of APCs during 2000/2001 transition period

Most medical practitioners will be issued two APCs in the transition year 2000/2001. Paragraph 3 sets out the transition arrangements.

3. All medical practitioners will apply for renewal of their APCs before April 2000 as usual. Such APCs will be renewed to cover the period to 31 August 2000, 30 November 2000, 28 February 2001 or 31 May 2001 depending on the quarter in which the practitioner's birth date falls. Forms will clearly state the currency of the APC and the fee payable. Fees and levies will be adjusted proportionally in accordance with the fees notice published in the New Zealand Gazette on 27 January 2000 pursuant to sections 126 and 127 of the Act.

4. Currency of APCs and allocation of medical practitioners to cycle for APC renewal:

(a) Medical practitioners born in the quarter 1 June to 31 August will be allocated to an APC year starting 1 September.

(b) Medical practitioners born in the quarter 1 September to 30 November will be allocated to an APC year starting 1 December.

(c) Medical practitioners born in the quarter 1 December to the end of February will be allocated to an APC year starting 1 March.

(d) Medical practitioners born in the quarter 1 March to 31 May will be allocated to an APC year starting 1 June.

5. The Council will normally send out a renewal notice 6 weeks before a medical practitioner's current APC expires.

6. These rules come into effect on 14 February 2000 in conjunction with the issue of APC renewal notices to all current holders of APCs due to expire on 31 March 2000.

## National Beekeepers' Association of New Zealand (Inc)

### Commodities Levies Act 1990

#### Notification of Rates of Levy for the 2000 Calendar Year

The National Beekeepers' Association of New Zealand (Inc.) advises that the rates of levy payable under this order have been fixed by the association for 2000.

The levy is payable at 2 rates, being:

- (a) Class 1: A rate of \$54.00 plus G.S.T. payable for each beekeeper's first apiary site; and

- (b) Class 2: A rate of \$26.00 plus G.S.T. payable for each additional apiary site.

The levy for 2000 is calculated for a beekeeper on the basis of the number of the beekeeper's apiary sites on 1 June 1999.

A beekeeper who owned or controlled fewer than 11 beehives and had fewer than 4 apiary sites on 1 June 1999 is exempt from paying the levy for 2000, provided he/she supplies a statutory declaration to that effect to the association.
