**3.** Nomination of Kaitiaki—Ngai Tai Iwi, being the tangata whenua holding manawhenua manamoana over the area/rohe moana, have nominated Arapeta Geoffrey Mio, Tawhiao Kingi, Reuben Houia, Selwyn Lawson, Clifford Delamere, Russell Grant Mio, James William Maxwell, and Memory Mio as Kaitiaki for the area/rohe moana.

**4. Appointment of Kaitiaki**—The Manager Operational Policy, Ministry of Fisheries, hereby confirms the appointment of Arapeta Geoffrey Mio, Tawhiao Kingi, Reuben Houia, Selwyn Lawson, Clifford Delamere, Russell Grant Mio, James William Maxwell, and Memory Mio as Kaitiaki for managing customary food gathering for the area/rohe moana by the Minister of Fisheries. The appointment will commence the day after this notice is published.

**5.** Power to authorise taking of fisheries resources for customary food gathering—The Kaitiaki may authorise any individual to take fisheries resources managed under the Fisheries Acts 1983 and 1996, other than those fisheries resources that are taken in fresh water, for customary food gathering purposes from within the whole or any part of the area/rohe moana.
