Electricity Industry Reform Act 1998

Notice of Exemption—Powerco Limited

The commission, pursuant to section 81 (5), varies its previous exemption, contained in Decision 360 and published in the *New Zealand Gazette* on 8 July 1999, of

Infrastructure and Utilities NZ Limited from the application of section 35 (1) (e) of the Electricity Industry Reform Act 1998 in relation to a prohibited cross-involvement in the electricity lines business of Powerco Limited and the electricity supply business of TrustPower Limited.

The exemption is now subject to the following terms and conditions:

- (a) Infrastructure & Utilities NZ Limited will continue to use all reasonable endeavours to cease its involvement in Powerco Limited by becoming non-associated with the New Plymouth District Council in respect of Powerco Limited.

- (b) During the period of the exemption, Infrastructure & Utilities NZ Limited will maintain an arms length relationship with Powerco Limited. Maintaining an arms length relationship means complying with the arms length rules defined in Schedule 1 of the Electricity Industry Reform Act 1998.
- (c) Infrastructure & Utilities NZ Limited will not exercise any right it may have to promote or veto the appointment of any director in Powerco Limited. It will allow New Plymouth District Council, the other major shareholder in Pukeariki Holdings Limited, to make any determinations on directors that are required to be made under the Pukeariki Holdings Limited structure.
- (d) The exemption expires at midnight on 1 September 2000 unless any variation or earlier revocation in terms of section 81 (5) occurs.
