- To meet the requirements of the National Education Guidelines in an innovative and stimulating manner best suited to the learning desires of the children and families who choose this style of learning.
- To enable students to pursue areas of interest and personal relevance rather than to follow predetermined paths. The requirements of the national curriculum will be met through the child's chosen path, rather than through a prescribed route.
- To enable students and their families to see learning as a total process that is multi-faceted and life long. An holistic approach will be taken which ensures parents are a vital part of the learning agreement. The objective is to involve parents, families and communities in the learning process.
- To always ask children first about what they need in order to learn.
