(e) An early childhood teaching qualification which, at the date of this notice, was held by a person responsible and had been recognised by the Ministry of Education or the New Zealand Qualifications Authority as equivalent to a Diploma of Teaching;

(f) Subject to paragraphs (i) and (ii) of this subclause, 100 licensing points verified by the New Zealand Qualifications Authority:

- (i) For existing persons responsible, this qualification is recognised only until 31 December 2004.

Fisheries (Rāpaki Bay Mātaitai Reserve Bylaws) Notice 2000 (No. F165)

Pursuant to Regulations 25 and 26 of the Fisheries (South Island Customary Fishing) Regulations 1999, the Minister of Fisheries hereby gives the following notice.

Notice

1. Title and commencement—(1) This notice may be cited as the Fisheries (Declaration of Rāpaki Bay Mātaitai Reserve Bylaws) Notice 2000.

(2) This notice shall come into effect 28 days after the date of its notification in the *New Zealand Gazette*.

2. Interpretation—In this notice:

(a) The term "Rāpaki Bay Mātaitai Reserve" means the Mātaitai reserve at Rāpaki Bay, Lyttelton Harbour, notified in the Fisheries (Declaration of Mātaitai Reserve) Notice 1998 (*New Zealand Gazette*, 17 December 1998, No. 200, page 4762).

- (b) Any reference to “Tāngata Tiaki/Kaitiaki” means any person or persons appointed as Tāngata Tiaki/Kaitiaki for the Rāpaki Bay Mātaitai Reserve under Regulation 21 of the Fisheries (South Island Customary Fishing) Regulations 1999.
- (c) “Rāpaki Marae Office” means the Marae Office located at Te Wheke Marae, Rāpaki Bay, P.O. Box 107, Lyttelton, Banks Peninsula.
- (d) “Cockle” means mollusc *Chione (austrovenus) stuchburyi*.
- (e) “Pāua” *Haliotis iris*, *Halitotis australis* and *Haliotis virginea*.
- (f) “Pipi” means the mollusc *Paphies australis*.
- (g) “Whairepo” means a skate of the Genus *Raja*, *Bathyrāja*, or *Arhynchabotis* or a ray of the Genus *Dasyatis*, *Myliobatis*, *Mobula*, *Torpedo*, or *Typhlonarke*.

3. Declaration of bylaws for the Rāpaki Bay Mātaitai Reserve—The Minister of Fisheries hereby declares the following bylaws for the Mātaitai Reserve at Rāpaki Bay, Lyttelton Harbour:

- (a) All fishing within the Rāpaki Bay Mātaitai Reserve is to be reported to the Tāngata Tiaki/Kaitiaki of the Reserve within five (5) days by filing a catch return form available from the Rāpaki Marae Office.

- (b) The taking or possession of whairepo (skate and ray) from within the Rāpaki Bay Mātaitai Reserve is prohibited.
- (c) The taking or possession of pāua from within the Rāpaki Bay Mātaitai Reserve is prohibited.
- (d) The taking or possession of seaweed within the Rāpaki Bay Mātaitai Reserve is prohibited.
- (e) Bylaw 3 (d) does not apply to the taking or possession of *Undaria pinnatifida*.
- (f) No person shall in any one day take or possess more than 50 cockles from the Rāpaki Bay Mātaitai Reserve.
- (g) No person shall in any one day take or possess more than 50 pipi from the Rāpaki Bay Mātaitai Reserve.

4. Fishing subject to these bylaws—Under Regulations 25 (3) and 43 of the Fisheries (South Island Customary Fishing) Regulations 1999, all fishing within the Rāpaki Bay Mātaitai Reserve is subject to these bylaws.

5. Revocation—The Fisheries (Rāpaki Bay Mātaitai Reserve Bylaws) Notice 1999 (No. F125) published in the *New Zealand Gazette* on 12 August 1999, No. 94, page 2248 is hereby revoked.

Casino Control Act 1990

Directions to Licensed Casino Operator—Internal Controls, and Administrative and Accounting Procedures

Pursuant to section 70 (1) of the Casino Control Act 1990, the Casino Control Authority hereby gives to Sky City Casino Management Limited directions as set out in the schedule to this notice.

Dated this 1st day of December 2000.

Schedule

1. Commencement, variation, and cancellation—

(1) These directions shall come into force on 1 December 2000.

(2) The Authority may add to, substitute for, cancel, or vary all or any of the provisions of these directions pursuant to the provisions of section 70 of the Act.

2. Application—These directions apply to and in relation to the operation of the casino at Level Two, 16-24 Beach Street, Queenstown, by Sky City Casino Management Limited.

3. Construction—(1) Nothing contained in these directions shall be so construed as to conflict with any provision of the Act or of any other applicable Act.

(2) If any provision of these directions is inconsistent with a provision of the Act or of any other applicable Act:

- (a) the provision of the Act or other Act (as the case may be) prevails; and
- (b) the application of these directions in relation to the casino licensee and the casino is modified accordingly.

(3) If any provision of these directions, or the application thereof to any person or circumstance, is held to be invalid, that holding shall not be construed so as to affect, impair, or invalidate any of the other provisions of these directions, or the application of the provision held to be invalid to any other person or circumstances, but shall be confined in its operation to the provision directly involved in the holding or the circumstances involved therein.

(4) In these directions, power given to do any act or thing, or submit to any act or thing, is capable of being exercised from time to time, as the occasion may require, unless the nature of the words used or of the thing itself indicates a contrary intention.

4. Interpretation—(1) In these directions, unless the context otherwise requires:

- (a) words and expressions used that are defined in the Casino Control Act 1990 shall have the same meaning as in the Act; and
- (b) the following words and expressions shall have the following meanings:

“Act” means the Casino Control Act 1990;

“approved internal control system”, in relation to the casino or the casino licensee, means the system of internal controls and administrative and accounting procedures approved (whether provisionally or otherwise) for the time being under these directions in relation to the casino operated by the casino licensee;

“Authority” means the Casino Control Authority established by section 7 of the Act;

“casino” means the licensed casino operated by Sky City Casino Management Limited on the casino premises at 16-24 Beach Street, Queenstown;

“casino employee” means any person acting in relation to the operation of the casino as an employee or agent on behalf of, or subject to the control of, the casino licensee;

“casino licensee” means Sky City Casino Management Limited;

“employee” includes any natural person engaged under a contract for services;

“gaming equipment” means any device or other thing (other than chips) used, or capable of being used, for or in connection with gaming;

“member” means a member of the Authority; and

“person” includes a corporation sole, and also a body of persons, whether incorporated or unincorporated.

(2) In these directions, unless the context otherwise requires, a reference to:

- (a) an Act is a reference to an Act of New Zealand;
- (b) an Act, whether by name or otherwise, includes the amendments to the Act for the time being in force, and also any Act passed in substitution thereof or in lieu thereof and the rules, regulations and by-laws for the time being in force thereunder;
- (c) a subsection is to a subsection of the section in which the reference occurs;
- (d) a function includes a reference to a power, an authority and a duty; and

(e) the exercise of a function includes, where the function is a duty, a reference to the performance of the duty.

(3) In these directions, unless the context otherwise requires, words importing the singular number include the plural number, and vice versa.

5. Approved internal control system to be implemented—(1) The casino licensee shall not conduct operations in the casino unless the Authority has approved a system of internal controls and administrative and accounting procedures for the casino.

(2) Any such system may be amended, as the Authority thinks fit, in accordance with the provisions of these directions.

(3) An approval granted under this section to an internal control system takes effect when notice of it is given in writing to the casino licensee, or on such later date as is specified in the notice.

(4) The casino licensee shall ensure that:

- (a) the casino is at all times operated in accordance with the approved internal control system for the casino; and
- (b) all casino employees are made aware of, and comply with, those provisions of the approved internal control system relating to their specific functions in, or in relation to, the casino.

6. Content of approved internal control system—(1) An approved internal control system shall include, but is not limited to, details of the following:

- (a) job descriptions, the system of organising personnel, and the chain of command authority, such as to establish diversity of responsibility among employees engaged in casino operations and identification of primary and secondary supervisory positions for areas of responsibility, which areas shall not be so extensive as to be impractical for an individual to supervise effectively;
- (b) procedures for the conduct and playing of games;
- (c) procedures for the receipt, storage, recording, and disbursement of chips, cash and cash equivalents, the redemption of chips and vouchers, and the recording of all transactions pertaining to gaming and gaming-related operations;
- (d) procedures for the collection, transfer, and security of money, chips, vouchers, and other money's worth pertaining to gaming and gaming-related operations;
- (e) procedures and security for the collection, counting, and recording of revenue and assets;
- (f) procedures for the use of forms and documents pertaining to gaming and gaming-related operations;
- (g) procedures for the purpose of safeguarding assets and enhancing the reliability of financial records relating to the operation of the casino;
- (h) procedures and standards for the maintenance, security, storage, and movement of gaming equipment;
- (i) procedures for the use of security and surveillance facilities, including access systems and closed circuit television systems; and
- (j) procedures for the utilisation of security personnel within the casino.

(2) For the purposes of an approval, or amendment of an approval, of an internal control system, controls and procedures shall be described in writing, in such manner and detail as the Authority may approve or require.

7. Changes to approved internal control system—(1) The casino licensee shall not alter the approved internal

control system unless and until such alteration is approved by the Authority.

(2) An approved internal control system may be amended by being substituted, varied, revoked, or added to.

(3) An amendment may be proposed:

- (a) by the casino licensee, pursuant to subsection (4); or
- (b) by the Authority, pursuant to subsection (6).

(4) The casino licensee may apply to the Authority for approval to amend the provisions of the approved internal control system, by applying to the Authority in writing setting out the amendment proposed and such other particulars as the Authority may require. The application shall contain or be accompanied by such additional information as the Authority may request, and be supported by such further information as the Authority may require.

(5) The Authority may, in its discretion, grant, either wholly or in part, or refuse to grant, any application for approval made pursuant to subsection (4). An approval granted under this subsection to an amendment to an approved internal control system takes effect when notice of the approval is given in writing to the casino licensee, or on such later date as is specified in the notice.

(6) If the Authority considers it appropriate, the Authority may, after consultation with the casino licensee, by notice in writing to the casino licensee, require such amendments to the approved internal control system as may be specified in the notice.

(7) Unless the casino licensee disputes the reasonableness of any requirement of a notice given by the Authority, pursuant to subsection (6), the casino licensee shall comply with and give effect to the requirements of the notice.

(8) If the casino licensee disputes the reasonableness of any requirement of a notice given by the Authority, pursuant to subsection (6), the casino licensee may make submissions in writing to the Authority in relation to the matter, within such period as the Authority may allow.

(9) Having considered the submissions made pursuant to subsection (8), the Authority may:

- (a) decide that the proposed amendment should be made, either with or without changes from that originally proposed, in which event the casino licensee shall forthwith comply with the decision of the Authority; or
- (b) decide that the proposed amendment should not be made.

8. Provisional approval—(1) The Authority may, pending a decision on an application by the casino licensee for approval of a proposed internal control system or amendment to an approved internal control system, grant to the casino licensee a provisional approval.

(2) A provisional approval granted under this section is subject to any conditions of which the casino licensee is notified by the Authority when the approval is issued.

(3) A provisional approval may be cancelled by the Authority at any time and, unless sooner cancelled or surrendered, ceases to have effect upon the approval or refusal of the casino licensee's substantive application for approval.

9. Delegation—(1) The Authority may, by resolution, delegate the exercise of all or any of its functions under these directions, except this power of delegation:

- (a) to a member or committee of the Authority; or
- (b) to an employee of the Authority;
- (c) to the holder of an office with the Authority, specifying the office but without naming the holder; or
- (d) to any combination of the foregoing.

(2) A delegation under this section:

- (a) may be made subject to such conditions as the Authority thinks fit, and may be made either generally or in relation to any particular case;
- (b) may at any time be revoked, wholly or in part, or varied by the Authority;
- (c) shall, until it is revoked, continue in force according to its tenor; and
- (d) shall not prevent or prejudice the exercise of any function by the Authority.

(3) The Authority may make such and so many delegations under this section, and to such number of delegates, as it considers necessary or desirable.

(4) A function delegated by the Authority under this section shall be exercised by the delegate in accordance with the instrument of delegation, and when so exercised shall, for the purposes of these directions, be deemed to have been exercised by the Authority and shall be presumed, unless the contrary is established, to have been exercised by a person duly authorised by a delegation under this section.

(5) Where a function is delegated that involves the exercise of a discretion which would be dependent upon an opinion or state of mind and that discretion is vested in the Authority, the discretion may be exercised by the delegate, pursuant to his or her own opinion or state of mind, unless the power to do so is limited by the terms of the instrument of delegation.

(6) In exercising a function delegated under this section, a delegate may refer any issue arising in the course of the exercise of the function to the Authority for its determination.

Australia New Zealand Food Authority Variations to the *Food Standards Code* (Amendment No. 52)

1. Preamble

The variations set forth in the Schedule below are variations to the *Food Standards Code* (hereinafter called "the Code")

which was published by the National Health and Medical Research Council in the *Commonwealth of Australia Gazette*, No. P 27, on 27 August 1987, and which has been varied from time to time.

The Schedule contains variations adopted by the Australia New Zealand Food Standards Council in July, October and November 2000.

These variations are published pursuant to section 32 of the *Australia New Zealand Food Authority Act 1991*.

2. Citation

These variations may be collectively known as Amendment No. 52 to the Code.

3. Commencement

These variations commence on the date of gazettal with the exception of:

1. [1.2] —which commences six months from the date of publication of this *New Zealand Gazette*; and
2. [3] —Division 2 of **Standard A18** which commences twelve months from the date of publication of this *New Zealand Gazette*.

4. Correction of typographical error

Amendment 51 published on 24 August 2000 contained a typographical error on page 2 in the section relating to commencement dates. The reference to “3.2.1” should read “3.2.2”.

5. Exceptions

In relation to **Applications A374, A398, A401 and A407** which are included in this gazettal notice, new maximum residue limits, variations to existing maximum residue limits and a changed commodity entry for lasalocid, lincomycin, neomycin and oxytetracycline have not been included.

STANDARD A18

FOOD PRODUCED USING GENE TECHNOLOGY

Purpose

Division 1 of this Standard addresses health and safety requirements, regulating the sale of food produced using gene technology, other than additives and processing aids. The Standard prohibits the sale and use of these foods unless they are included in the Table to clause 2 and comply with any special conditions in that Table.

The Authority will assess the safety for human consumption of each food produced using gene technology or such class of food prior to its inclusion in the Table. The safety assessment will be performed according to the Authority's approved safety assessment criteria.

Additives and processing aids which are produced using gene technology are not regulated in Division 1 of this Standard. Other Standards in this Code regulate additives and processing aids and require pre-market approval for these substances.

Division 2 of this Standard specifies labelling and other information requirements for foods, including food additives and processing aids, produced using gene technology.

Clauses

Division 1—Sale and use of food produced using gene technology

1. Interpretation

For the purposes of this Standard—

a food produced using gene technology means a food which has been derived or developed from an organism which has been modified by gene technology.

Editorial Note:

This definition does not include a food derived from an animal or other organism which has been fed food produced using gene technology, unless the animal or organism itself is a product of gene technology.

gene technology means recombinant DNA techniques that alter the heritable genetic material of living cells or organisms.

2. General prohibition on the sale and use of food produced using gene technology

A food produced using gene technology, other than a substance regulated as a food additive or processing aid, must not be sold or used as an ingredient or component of any food unless it is listed in Column 1 of the Table to this clause and complies with the conditions, if any, specified in Column 2.

3. Exemption to general prohibition on sale and use

(1) For the purposes of this clause—

- (a) the Act means the Australia New Zealand Food Authority Act 1991;
- (b) the Authority means the Australia New Zealand Food Authority established under the Act;

- (c) the Council means the Australia New Zealand Food Standards Council.
- (2) The prohibition in clause 2 does not apply to a food produced using gene technology where—
- that food is the subject of an application under section 12 of the Act to vary the Table to that clause;
 - the application has been accepted in accordance with section 13 of the Act by the Authority on or before 30 April 1999;
 - the Authority has evidence that that food, in one or more countries, other than Australia or New Zealand, is lawfully permitted to be sold or used as an ingredient or component, by a national food regulatory agency; and
 - the Council has not become aware of evidence that that food poses a significant risk to public health and safety.

Division 2—Labelling etc of food produced using gene technology

4. Interpretation and Application

- (1) For the purposes of this Division—

genetically modified food means food which is, or contains as an ingredient, including a processing aid, a food produced using gene technology which—

- contains novel DNA and/or novel protein; or
- has altered characteristics;

but does not include —

- highly refined food, other than that with altered characteristics, where the effect of the refining process is to remove novel DNA and/or novel protein;
- a processing aid or food additive, except where novel DNA and/or novel protein from the processing aid or food additive remains present in the food to which it has been added;
- flavours present in the food in a concentration no more than 1g/kg; or
- a food, ingredient, or processing aid in which genetically modified food is unintentionally present in a quantity no more than 10g/kg per ingredient.

altered characteristics means any of the matters specified in paragraphs 7 (a), (b), (c) or (d) of this Standard.

novel DNA and/or novel protein means DNA or a protein which, as a result of the use of gene technology, is different in chemical sequence or structure from DNA or protein present in counterpart food which has not been produced using gene technology.

- (2) Any statement required by clause 5 may be contained in the statement of ingredients where the genetically modified food is an ingredient or processing aid.
- (3) Where genetically modified food is displayed for retail sale other than in a package, any information that would have been required under clause 5 of this Standard on the label on or attached to the food if it was packaged, must be displayed on or in connection with the display of the food.
- (4) This Division does not apply to food intended for immediate consumption which is prepared and sold from food premises and vending vehicles, including restaurants, take away outlets, caterers, or self-catering institutions.

5. Labelling of genetically modified food

The label on or attached to a package of genetically modified food must include the statement ‘genetically modified’ in conjunction with the name of that food or ingredient or processing aid.

Example for single ingredient genetically modified foods:

Soy Flour
Genetically Modified
Soy Flour

From genetically modified soya beans

Example for genetically modified food ingredients:

Ingredients: Soy Protein Isolate (genetically modified), Maltodextrin, Vegetable Oil; Food Acid (332), Emulsifier (471), Vegetable Gum (407), Water Added.

6. Labelling of food which is not genetically modified

The label on or attached to a package of food which is not defined as ‘genetically modified food’ in clause 4 of this Standard is not required to include any statement about the genetic status of the food.

7. Additional labelling/information requirements

Notwithstanding the provisions of this Division, Column 2 of the Table to clause 2 may specify labelling or other information requirements in relation to food produced using gene technology listed in Column 1 of the Table where—

- the genetic modification has resulted in one or more significant composition or nutritional parameters having values outside the normal range of values for existing counterpart food not produced using gene technology;
- the level of anti-nutritional factors or natural toxicants are significantly different in comparison to the existing counterpart food not produced using gene technology;
- the food produced using gene technology contains a new factor known to cause an allergic response in particular sections of the population;
- the intended use of the food produced using gene technology is different to the existing counterpart food not produced using gene technology; or
- the genetic modification raises significant ethical, cultural and religious concerns regarding the origin of the genetic material used in the genetic modification.

Editorial Notes:

The Compliance Guide for Standard A18 as published by the Australia New Zealand Food Authority should be read in conjunction with this Standard.

Claims about genetic modification or its absence are subject to the Australian Trade Practices Act 1974 and State and Territory Food Acts, and the Western Australian Health Act, and the New Zealand Fair Trading Act 1986 and Food Act.

Division 2 of this Standard is to be reviewed 3 years from its date of gazettal.

STANDARD 3.2.1

FOOD SAFETY PROGRAMS (Australia only)

Purpose

This Standard is based upon the principle that food safety is best ensured through the identification and control of hazards in the production, manufacturing and handling of food as described in the Hazard Analysis and Critical Control Point (HACCP) system, adopted by the joint WHO/FAO Codex Alimentarius Commission, rather than relying on end product standards alone. This Standard enables States and Territories to require food businesses to implement a food safety program based upon the HACCP

concepts. The food safety program is to be implemented and reviewed by the food business, and is subject to periodic audit by a suitably qualified food safety auditor.

Division 1—Interpretation and application

1. Interpretation

In this Standard—

auditing frequency means the most recently determined frequency of auditing determined by the appropriate enforcement agency, or a food safety auditor, in accordance with the Act.

food safety program means a food safety program that satisfies the requirements of clause 5.

food safety auditor means a person approved as a food safety auditor under the Act as a person competent to audit the relevant class of food business.

Editorial Note:

Jurisdictions may approve environmental health officers, private contractors, or a mixture of the two as food safety auditors.

monitoring includes checking, observing or supervising in order to maintain control.

2. Application of this Standard

(1) This Standard applies to food businesses in Australia in accordance with Standard 3.1.1 (Interpretation and Application) and subclause (2).

(2) This Standard applies to all food businesses that are determined by the appropriate enforcement agency under the Act to be within a priority classification of food business from the commencement date for that priority classification of food business.

Editorial Note:

Under the Act, the appropriate enforcement agency must determine the priority classification of individual food businesses.

Jurisdictions may determine the mechanism by which a priority classification system and date of commencement is established, i.e. by regulation or declaration.

Division 2—Food safety programs

3. General food safety program requirements

A food business must:

- (a) systematically examine all of its food handling operations in order to identify the potential hazards that may reasonably be expected to occur;
- (b) if one or more hazards are identified in accordance with paragraph (a), develop and implement a food safety program to control the hazard or hazards;
- (c) set out the food safety program in a written document and retain that document at the food premises;
- (d) comply with the food safety program; and
- (e) conduct a review of the food safety program at least annually to ensure its adequacy.

4. Auditing of food safety programs

A food business must:

- (a) ensure that the food safety program is audited by a food safety auditor at the auditing frequency applicable to the food business;
- (b) make the written document that sets out the food safety program, and the appropriate records referred to in paragraph 5 (f), available to any food safety auditor who has been requested to conduct an audit of the food safety program; and
- (c) retain copies of all written reports of the results of all audits of the food safety program conducted by a food safety auditor within the last four years, for inspection upon request by a food safety auditor who audits the food safety program or an authorised officer.

Editorial Note:

ANZFA has developed food safety auditor approval criteria for food safety auditors in conjunction with the States and Territories.

5. Content of food safety programs

A food safety program must:

- (a) systematically identify the potential hazards that may be reasonably expected to occur in all food handling operations of the food business;
- (b) identify where, in a food handling operation, each hazard identified under paragraph (a) can be controlled and the means of control;
- (c) provide for the systematic monitoring of those controls;
- (d) provide for appropriate corrective action when that hazard, or each of those hazards, is found not to be under control;
- (e) provide for the regular review of the program by the food business to ensure its adequacy; and
- (f) provide for appropriate records to be made and kept by the food business demonstrating action taken in relation to, or in compliance with, the food safety program.

6. Fund raising events

A food business does not have to prepare a food safety program in accordance with this Standard in relation to fundraising events conducted by the food business, that is, events that raise funds solely for community or charitable causes and not for personal financial gain.
