Bolster attachments certified to be in compliance with the *Bolster Attachment Code* (issue 27 November 1998) are deemed to be in compliance with the *Bolster Attachment Code* (issue 1 May 2001).

Bolster attachments on vehicles fitted with convertible bolsters for the carriage of long logs must comply with the *Bolster Attachment Code* (issue May 1 2001), unless certified by a manufacturer of logging vehicles who is also a manufacturing certifier, or by a *Bolster Attachment Code* certifying engineer, to be in accordance with the conditions of Schedule 4.

### Schedule 3

(a) Logging trailers equipped with load cells supporting the attachment of the bolster to the vehicle chassis:

One additional safety chain of 6 tonnes breaking strength (rated strength) per bolster must be applied over the load, attached to certified anchorages on the chassis, in addition to the safety chain attached to each bolster in accordance with normal industry practice. This requirement is a continuation of the instruction issued by the Land Transport Safety Authority in its Factsheet dated 31 July 1997. When belly chains are required by the Truck Loading Code, the above additional safety chain is still required.

### (b) All logging vehicles:

Bolsters and their attachments on all logging vehicles are to be subjected to a more detailed inspection for ongoing security as part of the requirements for these vehicles to be issued with a Certificate of Fitness (CoF). Details will be issued in a revision to the *Heavy Vehicle Safety Inspection Guide* and the inspection criteria will be applied at the first Certificate of Fitness inspection for each vehicle subsequent to 1 November 2001.

### Schedule 4

Bolster attachments for long log logging vehicles fitted with convertible bolsters are exempted from compliance with a version of the *Bolster Attachment Code*, provided that the manufacturer (who must also be a manufacturing certifier) or a *Bolster Attachment Code* certifying engineer has evidence available for audit by the Land Transport Safety Authority that the particular design of the bolster attachments has successfully completed, on a single vehicle, 250,000 kilometres of service without any indication of cracking due to fatigue or other significant failure. A certificate to this effect must be presented to the Transport Service Delivery Agent at the time of first presentation of the vehicle for registration.

# Bylaw Declaring One-Way Roads on State Highways

Pursuant to section 61 (3) of the Transit New Zealand Act 1989, Transit New Zealand hereby makes the following bylaw.

### Bylaw

- **1. Title and commencement**—This bylaw may be cited as the Transit New Zealand (One-Way Roads) Bylaw 2001/3 and shall come into force 28 days after the date of its publication in the *New Zealand Gazette*.
- **2. Interpretation**—In this bylaw:
  - (a) "Vehicle" has the same meaning as in the Transport Act 1962.
  - (b) Without limiting or restricting their general meaning, the words "public work" shall include the operations of cleaning roads or streets, whether by sweeping or washing or other mechanical means.
- **3. Declaration of one-way road**—The sections of State highway described in the Schedule to this bylaw are one-way roads and no person shall drive or cause to be driven any vehicle or animal on such sections of road in a direction contrary to the one direction designated in the Schedule to this bylaw, and signs shall be erected on such sections of road accordingly.
- **4. Defence to driving against direction of traffic**—It shall be a defence to any driver of a vehicle charged with an offence of proceeding in the wrong direction along any part of a road described in the Schedule to this bylaw if the driver proves that:
  - (a) the vehicle was engaged in a public work or work involving utility servicing on the road at the time of the act or omission; and

- (b) the vehicle was being used on the road with due consideration for other traffic using the road; and
- (c) the act of proceeding contrary to the direction of traffic was reasonably necessary for the purposes of that work; and
- (d) the driver took all reasonable care to prevent any accident, mishap, collision, or damage, or any injury to or interference with any person, animal, or property arising by reason of such act.

### **Schedule**

- **5.** The section of State Highway No. 29 (Tauranga-Piarere) adjacent to its junction with the Matamata-Kaimai road being the left-hand slip lane for westbound vehicles only, a distance of approximately 290 metres. Traffic on this section of State Highway No. 29 shall proceed only in a south-westerly direction.
- **6.** The section of State Highway No. 73 passing under the Sockburn overbridge from a point located 40 metres in a north-easterly direction from the centre-line of the Sockburn overbridge, to a point located 35 metres in a north-westerly direction from the centre-line of the Sockburn overbridge. Traffic on this section of State Highway No. 73 shall proceed only in a north-westerly direction.
- 7. Traffic on the sections of State Highway No. 1, Dunedin City, as more particularly described below shall proceed in the direction designated below:

### Description

- Cumberland Street between Great King Street and Albany Street
- Cumberland Street between Queens Gardens and Frederick Street
- Cumberland Street between Queens Gardens and Andersons Bay Road
- Great King Street between Albany Street and Pine Hill Road
- Gowland Street between Albany Street and Frederick Street
- Malcolm Street between Frederick Street and Albany Street
- Castle Street between Frederick Street and High Street
- High Street between Castle Street and Queens Gardens
- Crawford Street between Andersons Bay Road and Queens Gardens
- Queens Gardens between High Street and Cumberland Street
- Queens Gardens between Crawford Street and Cumberland Street

### Required Direction of Movement

- South-westerly from Great King Street towards Albany Street
- North-easterly from Queens Gardens towards Frederick Street
- South-westerly from Queens Gardens towards Andersons Bay Road
- North-easterly from Albany Street towards Pine Hill Road
- Southerly from Albany Street towards Frederick Street
- Northerly from Frederick Street towards Albany Street
- South-westerly from Frederick Street towards High Street
- South-westerly from Castle Street towards Queens Gardens
- North-easterly from Andersons Bay Road towards Queens Gardens
- South-westerly from High Street towards Cumberland Street
- North-easterly from Crawford Street towards Cumberland Street
- **8.** All that section of State Highway No. 4 on the Putiki slip lane commencing from a point 300 metres north-west of its junction with State Highway No. 3 to its junction with State Highway No. 3 in a generally south-easterly direction. Traffic on this section of State Highway No. 4 shall proceed only in a south-easterly direction.

# Bylaw Requiring Snow Chains to be Carried or Fitted by Vehicles Using State Highway No. 94 (Milford Sound Highway)

Pursuant to section 61 (3) of the Transit New Zealand Act 1989, Transit New Zealand hereby makes the following bylaw.

### Bylaw

- 1. This bylaw may be cited as the Transit New Zealand (Milford Sound Highway Chains) Bylaw 2001/4.
- **2.** This bylaw shall come into force 28 days after the date of its publication in the *New Zealand Gazette*.
- **3. Interpretation**—In this bylaw:
  - (a) "Vehicle" has the same meaning as in the Transport Act 1962.
  - (b) "Chains" means 2 separate lengths of chain (commonly referred to as snow chains) which are designed and are able to be fitted over the wheels of a vehicle providing drive-on-the-road surface, thereby increasing the vehicle's traction in ice and snow.
- **4.** This bylaw shall apply to that part of State Highway No. 94 between the Lower Hollyford Road (at Route Position 212/15.88) and Milford Sound/Piopiotahi (at Route Position 241/16.55) being part of the State highway known as Milford Sound Highway.
- **5.** Between 1 May and 30 November in each year, no vehicle shall be driven on the said portion of State Highway No. 94 past any sign erected on or adjacent to the highway which stipulates either:
  - (a) that "chains must be carried" unless the vehicle is carrying a set of chains which can be conveniently fitted to the driving wheels of the vehicle, or
  - (b) that "chains must be fitted" unless a set of chains has been fitted to the driving wheels of the vehicle.
- **6.** Nothing in this bylaw shall apply to any vehicle on the said State highway being used by a contractor appointed by Transit New Zealand and undertaking maintenance duties on the State highway.

# Bylaw Regulating the Speed of Vehicles in Part Time School Speed Zones

### Bylaw

- **1. Title and commencement**—This bylaw may be cited as the Transit New Zealand (Part Time School Speed Zones Bylaw) Bylaw 2001/5 and shall come into force 28 days after its publication in the *New Zealand Gazette*.
- **2. Interpretation**—In this bylaw:
  - (a) "Vehicle has the same meaning as in the Transport Act 1962;
  - (b) "Part time speed limit" means the speed limit of 40 kilometres per hour, as shown by the part time speed limit sign, displayed on the sections of State highway in the schedule below on school days between the hours of 8.25 a.m. and 9.00 a.m., and 2.50 p.m. and 3.15 p.m.

- (c) "Part time speed limit sign" means the 40 kilometres per hour speed limit sign which has a light emitting diode (LED) display for the steady 40 kilometres per hour legend and flashing yellow warning lights in each corner of the display.
- (d) "School days" means the days on which the schools adjacent to the sections of State highway in the schedule below are open for instruction.
- **3.** The part time speed limit shall be in force when the steady state 40 kilometres per hour legend in the part time speed limit sign is illuminated and when the yellow corner warning lights are flashing on the sections of State highway described in the following schedule.

## Bylaw Prescribing Traffic Lane for Use by a Timetabled Public Passenger Service Vehicle

Pursuant to section 61 (3) of the Transit New Zealand Act 1989, Transit New Zealand makes the following bylaw.

## Bylaw

- 1. This bylaw may be cited as the Transit New Zealand Bylaw 2001/17.
- **2.** This bylaw shall come into force 28 days after its publication in the *New Zealand Gazette*.
- **3.** In this bylaw unless a contrary intention appears:
  - 3.1 "Accident" means an unintentional or unexpected act causing a vehicle to become immobile or practically immobile for the purposes of travelling safely on the motorway;
  - 3.2 "Breakdown" means an unexpected defect in the machinery of a vehicle causing that vehicle to become immobile or practically immobile for the purposes of travelling safely on the motorway;
  - 3.3 "Breakdown vehicle" has the same meaning as that phrase as defined in the Traffic Regulations 1976;
  - 3.4 "Bus Lane" means:
  - 3.4.1 That part of the shoulder of the motorway set out below:
    - (a) The bus lane on the southbound shoulder of the Auckland Northern Motorway section of State Highway No. 1 between Constellation Drive southbound on-ramp and the Exmouth Road Footbridge; and
    - (b) The bus lane on the south-east-bound shoulder of the Auckland north-western motorway section of State Highway No. 16 between the Selwood Road southbound on-ramp and the Patiki Road off-ramp.

For avoidance of doubt, the bus lanes set out above shall commence at the point marked by the traffic sign set out in Schedule B appended hereto and shall end at the point marked by the traffic sign set out in Schedule D appended hereto. The traffic sign set out in Schedule C appended hereto shall be displayed at intervals of not more than 400 metres along the extension of the respective bus lanes between the traffic signs set out in Schedule B and Schedule D hereto: The traffic sign set out in Schedule A appended hereto shall be displayed approximately 100 metres before commencement of the bus lane as marked by the sign shown in Schedule B.

3.4.2 That part of the Auckland Northern Motorway section of State Highway No. 1 comprising Lane 1 (outside or verge lane) from the Shelly Beach off-ramp near the southern abutment of the Auckland Harbour Bridge for a distance of approximately 600 metres until that lane merges with the general motorway at a point approximately 150 metres south-east of the Shelly Beach Road Underpass.

For avoidance of doubt, the bus lane described immediately above shall be defined by the signs set out in Schedules A to D appended hereto as required. In addition, other signs as set out in Schedules E to G appended hereto shall be placed over Lane 1 on the Auckland Harbour Bridge preceding the Bus Lane. The signs in Schedules E to G shall only be displayed during the hours described in paragraph 4 of this bylaw or at other times where, due to emergency conditions, it is necessary in the interests of safety to restrict the use of the Lane 1 Bus Way as described above for bus use only.

- 3.5 "Motorway" has the same meaning as that phrase as defined in the Transit New Zealand Act 1989;
- 3.6 "Passenger service" has the same meaning as that phrase as defined in the Transport Services Licensing Act 1989;
- 3.7 "Police Officer" has the same meaning as that phrase as defined in the Traffic Regulations 1976;
- 3.8 "Public passenger service" means a passenger service used or available for use by the community at large and servicing the public without restriction or limitation to any particular class of the community;
- 3.9 "Shoulder" means that sealed area on the extreme left hand side of a motorway, such sealed area being physically defined on both sides by a continuous white line;
- 3.10 "Timetabled public passenger service" means a public passenger service, the routes, areas of operation, operating hours, fares and other details of which have been notified in compliance with section 48 of the Transport Services Licensing Act 1989 and such notified public passenger service has been registered pursuant to section 49 of that Act;
- 3.11 "Timetabled public passenger service vehicle" means a motor vehicle within the meaning of the Transport Act 1962 while it is used in fulfilling, conducting and performing a timetabled public passenger service;
- 3.12 "Traffic Officer" has the same meaning as that phrase as defined in the Traffic Regulations 1976;
- 3.13 "Use" has the same meaning as that phrase as defined in the Traffic Regulations 1976;
- 3.14 "Vehicle" has the same meaning as that phrase as defined in the Traffic Regulations 1976.
- **4.** No person, being the driver of a vehicle or person in charge of a vehicle, shall use, drive, stop, stand or park that vehicle on or along any part of a bus lane whether that vehicle is attended or unattended during the period of 6.30 a.m. and 9.30 a.m., Monday to Friday (inclusive) unless:
  - 4.1 that person is driving or is in charge of a timetabled public passenger service vehicle and that vehicle is fulfilling a timetabled public passenger service at the time of travelling along the bus lane; or
  - 4.2 that person is driving or in charge of a vehicle which has suffered an accident or a breakdown on the motorway, such accident or breakdown occurring within 10 metres of any part of the bus lane and it is not reasonably practicable in the interests of road safety to use, stop, stand or park that vehicle in any other location while that vehicle is immobilised; or
  - 4.3 that person is driving or in charge of a breakdown vehicle which is required by a traffic officer to attend to an accident or breakdown of a vehicle.

Any reference in this bylaw to any statute or regulation is deemed to include all amendments and revisions made from time to time to that statute or regulation.

- (b) In respect of shorn wool, dags and dag wool sold privately in New Zealand, 2 percent of the gross proceeds received from the sale less the cost of testing

the wool where that cost has been incurred by the grower prior to the sale and can be substantiated by the levy collection agent to the satisfaction of the Wool Board. The cost of transport will not be deductible.

- (c) In respect of shorn wool, dags and dag wool sold through alternative marketing systems, for example pools and tenders, 2 percent of the gross proceeds received from the sale less any costs, for example testing, selling, crushing, scouring and dumping, which have been incurred by the grower prior to the sale and which can be substantiated by the levy collection agent to the satisfaction of the Wool Board. The cost of transport will not be deductible.
- (d) In respect of slipe wool and fellmongered wool, an amount per kilogram estimated by the Wool Board to be equivalent to 2 percent of the seasonally-adjusted average price for new season's wool sold at auction (the market indicator) during the calendar month 2 months prior to the month in which the levy became payable or, if there were no auctions during that month, during the last calendar month before it in which there was an auction, adjusted to reflect an average yield for slipe wool of 85 percent and less the average selling charges and testing costs on auction-sold wool for the previous season, as calculated by the Wool Board.
- (e) In respect of wool on the skin, 1 percent of the gross proceeds received from the sale of the sheepskin, being a 2 percent levy on half of the gross proceeds from its sale.
- (f) In respect of greasy wool and scoured wool which is exported from New Zealand, 2 percent of the f.o.b. value of the wool less any costs, for example testing, selling, crushing, scouring and dumping, which have been incurred by the grower prior to export and which can be substantiated by the levy collection agent to the satisfaction of the Wool Board. The cost of transport will not be deductible.

(g) In respect of all wool (as defined in the Wool Board Act 1997) other than that falling into the categories (a) to (f) above e.g., processed and manufactured wool, which is either sold in New Zealand or exported from New Zealand, 2 percent of the original greasy wool value as assessed by the Wool Board.
