Are You a Descendant?

On 21 November 1997, the Crown and Te Rūnanga O Ngāi Tahu entered into a Deed of Settlement, setting out the terms of the settlement reached to give effect to the claims made by Te Rūnanga O Ngāi Tahu. The major part of the settlement was related to the main claim on behalf of the Ngāi Tahu iwi. However, minor claims that related to individual hapu or whanau were set aside and responsibility given to a special Trust set up for the purpose to vest these minor claims in the descendants of the original owners of the land or fisheries reserves alienated in some cases over 100 years ago.

Ancillary Claim Properties

There are 32 individual claim properties, 9 of which are all based on customary fishing areas. The total assessed value of the 32 properties is a little over \$1,000,000.00, but the cultural value is of lasting significance to Ngāi Tahu descendants.

Research

The Ancillary Claims Trust was established in November 1998 and, since then, the priority has been to carry out the necessary research to establish the original owners. This research has now been completed and this notice is the first of three notices to locate the descendants of the original owners in three groups of areas.

Properties to be Vested

The claim properties are being dealt with in this first batch, are all customary fishing claims in the North and South Canterbury districts. Please note that the following reserves are compensation lands. They differ from the reserves of the same name found in the Maori Land Court records.

Notes to the Consolidated Financial Statements for the Year Ended 31 March 2001

1. Statement of Accounting Policies

1.1 Reporting Entity

Eastern and Central Community Trust is a charitable trust incorporated in accordance with the provisions of the Trustee Banks Restructuring Act 1988.

The trust has a wholly owned company – Eastern & Central Community Trust Charities Limited – which is registered under the Companies Act 1993.

The consolidated financial statements have been prepared in accordance with generally accepted accounting practice.

1.2 Measurement Base

The measurement base applied is that of historical cost adjusted for the market valuation of investments.

1.3 Specific Accounting Policies

The following are the particular accounting policies which have a material effect on the measurement of results and financial position.

1.3.1 Basis of Consolidation

The consolidated financial statements include the trust and its wholly owned company accounted for using the purchase method. All significant inter-entity transactions are eliminated on consolidation. Both entities have a common balance date of 31 March.

1.3.2 Investment Income is accounted for on an accruals basis recognising both realised and unrealised gains or losses in value.

1.3.3 Foreign Currency balances are converted to NZD at the year end rate of exchange unless covered by a forward exchange contract. Where such contracts are in place, the contracted rate is adopted. Transactions completed during the year are converted at the rate applying at the approximate date of the transaction. Foreign exchange gains and losses are included within the statement of financial performance.

1.3.4 Investments are recorded at market value at year-end.

1.3.5 Cash comprises cash at bank, call deposits and short-term deposits but does not include cash held by fund managers.

1.3.6 Donations are included in the statement of financial performance when approved by the trustees.

1.3.7 Fixed Assets

Fixed assets are recorded at cost less accumulated depreciation.

1.3.8 Depreciation is provided on a straight line basis on all tangible fixed assets at rates calculated to allocate the assets' cost less estimated residual value over their estimated useful lives.

The depreciation periods are:

Computer equipment	three years
Fixtures and fittings	nine years
Furniture	ten years
Office equipment	five years

1.3.9 Income Tax is not provided as the trust has charitable status for tax purposes.

1.3.10 G.S.T. inclusive accounting has been adopted, as the trust is not registered for G.S.T.

1.4 Changes in Accounting Policies

There have been no changes in accounting policies. All policies have been consistently applied.

9. Segmental Reporting

The trust operates as a charitable trust distributing funds to the community in the central North Island region.

10. Financial Instruments

Financial instruments include short-term deposits, New Zealand bonds, international bonds, derivatives and investments in managed funds both within New Zealand and overseas.

10.1 Credit Risk

The trustees regularly review their investment strategy. The investment strategy ensures an appropriate diversification of investments so that the trust has no significant concentration of counterparty or credit risk.

10.2 Fair Values

The trust has recorded its financial assets and liabilities at current market values, which represent estimated fair values and credit risk exposure.

10.3 Currency Risk

The trust has exposure to currency risk through its investments in offshore equities and bonds. The current investment policy requires full hedging of currency risk for overseas bonds and 50% hedging of currency risk for overseas equities. This is managed by fund managers with a range of tolerance.

10.4 Credit Facilities

The trust has no credit facilities.

10.5 Interest Rate Risk

The trust investments in fixed rate securities are subject to interest rate risk.

11. Net Current Assets

Cash, bank deposits and accrued income are expected to be realised within 12 months. All liabilities are due within 12 months.



Consolidated Notes to the Financial Statements for the Year Ended 31 March 2001

1. Statement of Accounting Policies

Reporting Entity

The financial statements presented here are for the reporting entity Trust Bank Wellington Community Trust and its wholly owned companies, Wellington Community Trust Charities Limited and Jarden Mile Investments Limited. The Trust Bank Wellington Community Trust is an incorporated charitable trust under the Charitable Trusts Act 1957.

Reporting Basis

The trustees have chosen to prepare general purpose financial reports which comply with generally accepted accounting practice.

Measurement Base

The measurement base adopted is historical cost with the exception of certain items for which specified accounting policies are identified.

Investment Income (Net)

Investment income (net) includes gross investment income less management fees payable to the fund managers.

Investment Property

The investment property held is valued at net current value. Depreciation is not charged on the investment property. The net change in the value of the investment property is recorded in the consolidated statement of financial performance.

Basis of Consolidation

The consolidated financial statements have been prepared using the purchase method of consolidation and include the financial statements of the parent and subsidiary companies.

All significant inter-entity profits and transactions have been eliminated in preparing the consolidated financial statements.

Accounts Receivable

Accounts receivable are stated at expected realisable value.

Donations

Donations made from current year's income are recorded in the statement of financial performance when paid. Donations from prior years' income are recorded in the donation reserve account when paid.

Fixed Assets

Fixed assets are stated at cost less accumulated depreciation.

Depreciation

Depreciation is charged at the maximum rates allowable by the Inland Revenue Department. The tax rates are as follows:

Computer equipment	24.0 – 48.0	%CP
Office furniture	9.0 – 60.0	%DV

Goods and Services Tax

The financial statements for The Community Trust of Wellington are prepared on a G.S.T. inclusive basis with the following exceptions:

- The Wellington Community Trust Charities Limited is registered for goods and services tax on the basis that taxable supplies are derived from rent received and the reimbursement of operating expenses from the sub-leasing of their premises. Income and expenditure relating to this are stated on a G.S.T. exclusive basis.
- Transactions relating to Jarden Mile Investments Limited are prepared on a G.S.T. exclusive basis as it is registered for goods and services tax.

Shares and Investments

Shares and other investments are stated at the market value. Changes in the market value of investments are taken to the statement of financial performance.

Financial Instruments

All financial instruments held by the trust are recorded in the statement of financial position. The financial instruments comprise equity securities, discounted securities, secured investments, borrowings, deposits and cash. Concentrations of credit risk arise as a result of holding equity securities as investments. These are subject to the normal market risk associated with investments of this nature. There are no significant differences between the fair value and book value of financial instruments.

Where possible, financial assets and liabilities are supported by collateral or other security. These arrangements are described in the individual policy statements associated with each item.

Changes in Accounting Policies

There have been no changes in accounting policies. All policies have been applied on bases consistent with those used in previous years.

2. Nature of Business

The Trust Bank Wellington Community Trust was incorporated as a charitable trust in accordance with the provisions of the Trustee Banks Restructuring Act 1988. The purpose of the community trust is to provide charitable, cultural, philanthropic and recreational benefits to the community, principally in the trust region.

The nature of business of the wholly owned companies, Wellington Community Trust Charities Limited and Jarden Mile Investments Limited, is restricted by their constitution to providing charitable benefits to the community, principally in the region of The Community Trust of Wellington.

The Trust Bank Wellington Community Trust and its subsidiary companies operate under the trading name of "The Community Trust of Wellington".

The property has been valued at \$1,300,000 as at 31 March 2001. The carrying value of the property includes allowances for potential disposal costs. The valuation was carried out on 4 April 2001 by an independent registered valuer, C. W. Nyberg F.N.Z.P.I., of Darroch Limited.

6. Taxation

Trust Bank Wellington Community Trust is not exempt from income tax as a charitable trust. A tax liability of \$20,694 was recorded in the financial statements for the previous year. During that time the charitable status of the trust was being reviewed by Inland Revenue. The review has since resulted in a reversal of tax expense and no liability arises for tax to 31 March 2001.

For taxation purposes, Wellington Community Trust Charities Limited is deemed to be a charitable organisation and on this basis the income is not subject to taxation. The company's charitable status was confirmed on 27 August 1997 by the Inland Revenue Department.

For taxation purposes, Jarden Mile Investments Limited is deemed to be a charitable organisation and on this basis the income is not subject to taxation. The company's charitable status was confirmed on 29 September 1998 by the Inland Revenue Department.
