### Te Whanau-a-Taupara Trust Empowering Bill

#### Notice of Intention to Promote a Private Bill—Te Whanau-a-Taupara Trust Empowering Bill

1. The Waerenga-a-hika Trust Board gives notice that it intends to promote a private Bill, the Te Whanau-a-Taupara Trust Empowering Bill (“the Bill”), by petitioning the House of Representatives (“the House”) that the Bill be introduced to the House.

#### Background

2. The Taupara whanau gifted a block of land known as “Waerenga-a-Hika” to the Crown by deed dated 9 April 1857, for the purpose of establishing an educational trust.

3. The Crown then gifted this piece of land to the Bishop of Waiapu and a deed of trust was executed for a school for Māori in connection with the Anglican Church.

4. This school was destroyed in a fire in 1937 and the trust funds were not sufficient to rebuild the school. As a result, the Waerenga-a-hika Trust Act 1947 was enacted to expand the charitable and educational objects of the Waerenga-a-hika Trust.

5. The main object of the trust is to provide for the post-primary educational needs of the children of Te Whanau-a-Taupara. The objects of the trust provide that half of the trust’s income must be put towards scholarships at schools conducted by the Church of England, and that in all other cases preference must be given to schools of the Church of England.

6. However, it is difficult for the trust board to fulfil its objectives as children must travel further afield to boarding schools to take up their scholarships.

7. The powers of the trustees are restrictive. In addition, it is required that all leases be in accordance with the Public Bodies Leases Act 1969. This has led to a situation in which most of the leases are 21 year perpetually renewable leases, known as “Glasgow leases”.

8. The 1947 Act is outdated and the trustees desire to:

- (i) widen the charitable and educational objects of the trust and widen the powers of the trustees under a new trust; and
- (ii) ameliorate the restrictive conditions imposed on the trust by virtue of the Public Bodies Leases Act 1969.

9. The members of the Waerenga-a-hika Trust Board have executed a Deed of Trust, of the Te Whanau-a-Taupara Trust.

#### Purpose of the Bill

10. The purpose of this Bill is to facilitate the modernisation of the administration of the Waerenga-a-hika Trusts. To this end, the Bill provides:

- that the assets of the Waerenga-a-hika Trust Board are vested in the trustees of Te Whanau-a-Taupara Trust, which is set out in the trust deed dated 30 October 2001, a copy of which is set out in Schedule 2 of the Bill; and
- that the board, constituted by the Waerenga-a-hika Trust Act 1947, shall be dissolved; and
- that all previous trusts shall be extinguished; and
- that the Waerenga-a-hika Act 1947 is repealed; and
- that all trusts specified in the trust deed are charitable trusts for all purposes at law; and
- that the application of the Public Bodies Leases Act 1969 is limited.

- (i) Immunity from suit and legal process in respect of things done or omitted to be done by them in the course of the performance of their official duties;
- (ii) exemption from income tax in respect of emoluments received for services in respect of their official duties; and
- (iii) exemption from taxes on the importation of goods for official use in New Zealand, that exemption to be subject to compliance with such conditions as the Minister of Customs may determine for the protection of the revenue.

### Earthquake Commission Act 1993

#### Direction to the Earthquake Commission

Pursuant to section 12 of the Earthquake Commission Act 1993:

- (i) This direction comes into effect on 1 November 2001 and as of that date, the direction dated 2 June 1998 is hereby revoked.
- (ii) The Earthquake Commission (“the Commission”) shall invest the Natural Disaster Fund (“the Fund”) in:

- (a) New Zealand Government securities comprising Treasury bills and/or Government stock and/or Inflation-Indexed Bonds tradeable only through the New Zealand Debt Management Office;
  - (b) global equities; and
  - (c) New Zealand bank bills.
- (iii) The commission shall invest the fund with the objectives of:
- (a) achieving an average rate of return of at least 1% per annum over the Crown's cost of borrowing over a rolling 10 year period (where the Crown's cost of borrowing is measured by the change in the CSFB New Zealand Government Stock Gross Index);
  - (b) subjecting the fund to no more than 1 chance in 4 that over any 10 year period, the annual rate of return will be less than the Crown's cost of borrowing; and
  - (c) ensuring that there is no more than 1 chance in 30 of the fund incurring an investment return of less than negative 2% in any one financial year.
- (iv) The commission must invest the fund on a prudent, commercial basis and in doing so, must manage and administer the fund in a manner consistent with:
- (a) best practice portfolio management;
  - (b) maximising return without undue risk to the fund as a whole; and
  - (c) avoiding prejudice to New Zealand's reputation as a responsible member of the world community.
- (v) The commission must prepare, and adhere to, a statement of investment policies, standards and procedures for the fund that is consistent with paragraph (iv) of this direction.
- (vi) The commission must review those investment policies, standards and procedures for the fund at least annually.
- (vii) A statement of investment policies, standards and procedures must cover (but is not limited to):
- (a) the classes of investments in which the fund is to be invested and the selection criteria for investments within those classes;
  - (b) the determination of benchmarks or standards against which the performance of the fund as a whole, and classes of investments, will be assessed;
  - (c) standards for reporting the investment performance of the fund;
  - (d) ethical investment for avoiding prejudice to New Zealand's reputation as a responsible member of the world community;
  - (e) the balance between risk and return in the overall fund portfolio;
  - (f) the fund management structure;
  - (g) the use of options, futures and other derivative financial instruments;
  - (h) the management of credit, liquidity, operational, currency, market and other financial risks;
  - (i) the retention, exercise or delegation of voting rights acquired through investments;
  - (j) the method of, and basis for, valuation of investments that are not regularly traded at a public exchange; and
  - (k) prohibited or restricted investments or any investment constraints or limits.
- (viii) The commission must consult with the Minister of Finance ("the Minister") if it intends to modify the statement of investment policies, standards and procedures to any substantive degree.
- (ix) The commission must consult with the Minister if it intends to modify the portfolio composition from the following:
- (a) New Zealand Government securities;
  - (b) up to a maximum of 35% of the market value of the fund in global equities; and
  - (c) up to a maximum of \$250 million of New Zealand bank bills.
- (x) The commission must consult the minister if it forms the intention to cover its pre-disaster currency exposures and may not proceed with the implementation of a hedging strategy without the consent of the minister being first had and obtained.
- (xi) In the event of a major natural disaster likely to involve claims on the commission in excess of \$250 million, the commission must consult with the minister before liquidating any part of the investment portfolio of the fund apart from the holdings of New Zealand bank bills.
- (xii) If the commission considers at any time that any provision in this direction is inconsistent with another provision in this direction or any other direction, under section 12 of the Earthquake Commission Act 1993 or any provision under that Act, it shall advise the minister of that inconsistency.
