**Objections to Proposed Boundaries and Classification
of Electoral Districts of New Zealand**

The Representation Commission appointed pursuant to section 28 of the Electoral Act 1993 hereby publishes, in accordance with the provisions of section 38 of that Act, a summary of the objections lodged with the Commission to the proposed boundaries and classification of the electoral districts, as set out in the Schedule hereto.

The full objections are available for public inspection at the offices of the Chief Electoral Office, Level 9, Sovereign House, 180 Molesworth Street, Wellington from Thursday 10 January 2002 until Thursday 24 January 2002 or individual objections by request through our 0800 service 0800 800 610. Those requiring photocopies of the full objections may incur photocopying charges. Copies of objection summaries are available for viewing at the places set out in the Schedule hereto:

The Representation Commission will receive written counter-objections to these objections, or any of them, if in the hands of the Commission no later than Thursday 24 January 2002. Late Counter-objections i.e. those received after Thursday 24 January 2002, cannot be considered.

All counter-objections are requested to clearly state:

- (i) the name, address and telephone contact number (day and night) of the counter-objector;
- (ii) the electorate(s) to which the counter-objection applies;
- (iii) the specific objection(s) the counter-objection applies to, using where possible the objection numbers allocated by the Commission;
- (iv) the grounds of the counter-objection; and
- (v) the solution suggested by the counter-objector.

The Commission requests that counter-objectors indicate whether they wish to speak briefly to their counter-objections before meetings of the Commission to be held in Auckland, Wellington, Christchurch, Dunedin and possibly other locations as required in February 2002.

Full details of each counter-objection must be in writing. Whether or not a counter-objector is heard, his or her written counter-objection will be fully considered. However, late counter-objections cannot be considered.

A separate counter-objection should be filed in respect of each separate objection which you oppose.

A suggested format for counter-objections is available at the places listed in the Schedule hereto.

Note: Public Libraries will not be gazetted as places for inspection. Proposed General and Maori electorates together with maps, descriptions and reasons will be available at libraries in those areas where boundary changes have occurred.

Notes:

- Summarised objections have been allocated under the proposed electorate where the area specified in the objection is located. For example, if an objector stated an objection to, say, Pyes Pa being located in the proposed Rotorua Electorate OR objected to Pyes Pa not being in the Bay of Plenty Electorate, then in both cases the objection has been assigned to the proposed Rotorua Electorate.
- It is recommended that people interested in a particular electorate should also look at objections relating to neighbouring electorates as these could affect the electorate they are concerned with.

Suggested solution Move this electorate and the other three large 'F' electorates (Kaikoura, Otago and Clutha-Southland) into the 'G' classification.

Objects to the name 'Northcote' for the proposed electorate as this does not reflect the community of interest of much of the proposed electorate.

Suggested solution A neutral name would be more appropriate, such as the name 'Northbridge'.

Objects to the inclusion of Greenhithe in the proposed Helensville electorate as its community of interest and location fall within the scope of North Shore.

Suggested solution Extend the North Shore boundary to include its immediate neighbour Greenhithe.

Objects to the inclusion of the Panmure commercial area in the proposed Tamaki electorate, as a large proportion of the community that uses it is based in the Maungakiekie electorate.

Suggested solution Follow Pleasant View Road, across Pilkington Road and Te Koa Road, through the reserve between Kahu and Ngarimu Roads. Then across Tripoli Road, through the Mauinaina Reserve, across Dunkirk Road and over the Mt Wellington War Memorial to the Tamaki River.

N18**Manukau East**

N18 001 *b, h* **Objection M Williams**

Objects to the splitting of Howick between three electorates.

Suggested solution Extend Manukau East to include all of the Howick and the Clevedon Wards of Manukau City. Move Otara, Papatoetoe and Manurewa to the Manurewa electorate. Move Golflands, Burswood, Greenmount, East Tamaki and possibly the area bounded by Chapel Road, Ti Rakau Drive and Te Irirangi Drive to the Pakuranga electorate. Change the name of Manukau East to Howick or Owairoa to reflect these changes.

Also suggests further adjustments to the boundaries of the proposed Pakuranga, Manukau East, Clevedon and Manurewa electorates.

Electoral District and Nature of Objection

N18 002 *b* **Objection C Y Feng and 6 others**

Objects to the inclusion of the area of Papatoetoe west of Great South Road (including Puhinui) being included in the proposed Manukau East electorate as their community of interest lies with the rest of Papatoetoe in the proposed Mangere electorate.

Suggested solution Move this area into the Mangere electorate. This would allow the suburbs of Shelly Park, Somerville, Shamrock Park, Dannemora and East Tamaki Heights to be included within Manukau East where their community of interest lies.

N18 003 *b* **Objection J T Liu and 11 others**

Objects to the inclusion of the area of Flat Bush and Chapel Downs in the proposed Manukau East electorate as its community of interest lies with the housing developments around Manukau Heights and the planned Flat Bush Centre.

Suggested solution Include this area in the proposed Clevedon electorate and shift the area of Howick comprising Shelly Park, Somerville, Shamrock Park, Dannemora and East Tamaki Heights into Manukau East where its community of interest lies.

N20**Manurewa**

N20 001 *b* **Objection C E Bethell**

Objects to the inclusion of Ryan Place in the proposed electorate on grounds of community of interest.

Suggested solution Include Ryan Place in the proposed Manukau East electorate – as are other residential areas south of Puhinui Road.

N21**Clevedon**

N21 001 *b* **Objection P F O'Brien**

Objects to the lack of clarity in definition between the map and the description in the Conifer Grove area.

Suggested solution Amend the description to reflect the map.

N21 002 *b* **Objection B P Mockridge**

Objects to the inclusion of The Gardens suburb in the proposed Clevedon electorate as it is accessible only from Manurewa.

Suggested solution Use the boundary between Tamaki Makaurau and Pare Hauraki-Pare Waikato, between Redoubt Road and the Southern motorway, as the boundary for the general electorate. This would transfer The Gardens from Clevedon to Manurewa, and Randwick Park from Manurewa to Clevedon. If more population is required, the area of Chapel Downs east of Chapel Road could be transferred from Clevedon to Manurewa.

 Objects to the inclusion of Raglan in the proposed Port Waikato electorate as its community of interest lies more with the proposed Piako electorate.
Suggested solution Put the northern part of Piako (Kaiarau, Maramarua, Te Kauwhata) into Port Waikato and the southern part of Port Waikato (Raglan) into Piako.

 Objects to the use of the name Port Waikato for the proposed electorate as it has become increasingly inappropriate with the inclusion of large areas of Franklin in the electorate and the removal of areas in the south.
Suggested solution Rename the electorate 'Franklin'.

 Objects to the inclusion of the area of Moumoukai in the proposed Port Waikato electorate as its community of interest lies with the Papakura district.

N23**Piako**

- N23 001 *b, h* **Objection A Millar**
 Objects to the inclusion of Horotiu, Ngaruawahia and Taupiri in the proposed Piako electorate as their community of interest and communication links are stronger with Huntly, Raglan, Waingaro and areas to the west than with Morrinsville, Te Aroha, Matamata and Cambridge. Also, projected population variances suggest that the current proposed Port Waikato electorate will be over the 5% by high growth in the north of the electorate (Hunua and Drury).
Suggested solution The boundary between Huntly and Ngaruawahia follow Transit New Zealand's proposed motorway option 1 – south from the point that it intersects with the southern boundary of the Huntly Ward until it meets the proposed boundary of the Hamilton East Electorate. Then north, west and south of the proposed boundaries of Hamilton East and West electorates until it joins the proposed boundary in line with Saulbery Road, then south to Raglan.

Move the Tai Tapu and St John of God areas of Rakaia to Banks Peninsula. Move the Sydenham area of Christchurch Central to Wigram.
 Or:
 Move the area of Woolston/Linwood bounded by Tilford Street and Ferry Road to Christchurch East.

 Objects to the inclusion of the Port Hills region in the proposed Rakaia electorate as its community of interest lies with Banks Peninsula.

 Similar to S10/001
 Objects to the inclusion of the inland hills of Banks Peninsula (Old Tai Tapu Road area) being included in the proposed Rakaia electorate as their community of interest lies with Banks Peninsula.
Suggested solution Similar to S10/001. Follow SH75 to Motukaraka.
- S10 003 *b* **Objection P C Rhodes**
 Objects to the inclusion of the Taitapu area in the proposed Rakaia electorate.
Suggested solution Place the Taitapu area in the Banks Peninsula electorate.

 Objects to the inclusion of parts of Manurewa in the proposed Pare Hauraki-Pare Waikato electorate on the grounds of community of interest.
Suggested solution Transfer the area of Manurewa south of Alfriston Road into the Tamaki Makaurau electorate.

 Objects to the name ‘Pare Hauraki-Pare Waikato’ for the proposed electorate, and to the proposed boundaries which split whanau and hapu communities of interest. Also notes inaccuracies in the Maori expressions used in the description of the boundaries.

Suggested solution Move the northern boundary of Te Tai Hauauru south – commencing in the west at Waipingaeo (near the White Cliffs south of Mokau), heading inland towards and along the Taringamotu River (immediately north of Taumarunui).
 Also, if this boundary adjustment can be achieved, it would make sense to change the name of the proposed Pare Hauraki-Pare Waikato electorate to 'Tainui'.

 Also objects to the geographical size disparity between the proposed Pare Hauraki-Pare Waikato and Te Tai Hauauru electorates.
Suggested solution The boundary of Pare Hauraki-Pare Waikato run from South Auckland to Mokau, and that of Te Tai Hauauru from Mokau down to Wellington.

 Objects to the proposed electorate being named 'Te Tai Rawhiti' on the grounds that the large area encompasses a number of Iwi.
Suggested solution Retain the name 'Ikaroa Rawhiti'.

M07 Te Tai Tonga

M07 001 *b* **Objection J H Lloyd**
 Objects to the inclusion of Manor Park, Haywards and Kelson in the Te Tai Tonga electorate on the grounds that the proposed Rimutaka general electorate has been extended to include these areas. Keeping of these two boundaries together would improve administrative simplicity.
Suggested solution Include the areas of Manor Park, Haywards and Kelson in Te Tai Rawhiti.

M07 002 *b, h* **Objection Mana Motuhake**
 Objects to the division of tribes and communities in the Wellington region between the proposed Te Tai Tonga, Te Tai Hauauru and Te Tai Rawhiti electorates on the grounds that urban and rural areas have different communities of interest.
Suggested solution The boundary of Te Tai Tonga should encompass all of Wellington.

M07 003 *b, h* **Objection Wellington Tenths Trust**
 Similar to M07/002
 The proposed boundary cuts right through the traditional border of the Te Ati Awa tribe. It excludes areas of utmost significance to Te Ati Awa (particularly areas of Lower Hutt), and includes other areas outside their borders (Tawa and parts of Porirua).
Suggested solution To follow the traditional border as far as possible. This would include a northward movement of the boundary between Te Tai Tonga and Te Tai Rawhiti and moving the whole of Tawa and Porirua into the Te Tai Hauauru electorate. A consequential change to the northern boundary of Te Tai Hauauru would be required. It is proposed this northern boundary exclude Te Awamutu.

- GGG 001 *b, h* **Objection H R Hoskin**
 Objects to the limit of variance in the population quota being +/-5% as this causes frequent changes and disruption to communities.
Suggested solution Change the variance limit to +/-20%.
- GGG 002 *b* **Objection J van Noorde**
 Objects to the boundary change process because of the huge costs incurred and the lack of understanding amongst the populace of the implications involved.
Suggested solution Develop a far more simple process.
- GGG 003 *b* **Objection B P Mockridge**
 Notes that all South Auckland and Waikato electorates are near the upper limit of their quota variance (Pakuranga, Manukau East, Mangere, Manurewa, Clevedon, Port Waikato, Piako, Hamilton West and Hamilton East).
 Based on the Representation Commission's projections, the electoral population of these nine electorates will exceed that of the ten electorates covering Auckland and North Auckland (Helensville, Waitakere, Te Atatu, New Lynn, Mt Albert, Mt Roskill, Auckland Central, Epsom, Tamaki, Maungakiekie).
 Also, because the electoral population of South Auckland and Waikato is close to the upper limit, awkward and unnatural boundaries are required to keep the electorates within their quota tolerance: e.g. Howick split between Pakuranga, Clevedon and Manukau East; the Manurewa-Clevedon boundary differing from the Maori electorate boundary.
Suggested solution Transfer about 12,000 population from Pakuranga to Maungakiekie.
 Distribute diminishing portions of this extra population westward, across Mt Roskill, New Lynn, Waitakere and Helensville so that each is closer to the quota.
 Compensate Pakuranga from Clevedon, and Clevedon from Port Waikato and Piako so that each is closer to the quota.
- GGG 004 *b, h* **Objection S Russell**
 Objects to the general pattern of boundaries proposed as the Commission appears to have placed more emphasis on existing boundaries than on population criteria. Little consideration appears to have been given to projected variance in population.
Suggested solution That the Commission should take steps to amend the process by which proposed boundaries are devised in the future, to achieve a better balance between criteria.
