Electricity Industry Reform Act 1998

- (e) URBUS does not generate electricity;
- (f) only administration costs directly relating to the provision of the lines service by URBUS may be passed on to tenants;
- (g) any administration costs must be clearly identified as such in tenants' invoices; and
- (h) URBUS provide to the commission on 30 June each year, all information necessary to demonstrate, to the commission's satisfaction, compliance by URBUS with (f) and (g) above.

The commission may vary or revoke this exemption in accordance with section 81 (5) of the Electricity Industry Reform Act 1998.

The exemption takes effect from the date of publication of this notice in the *New Zealand Gazette*.

- (c) Neither CPNZ nor CPW will enforce any obligation, in any lease or other agreement with their tenants, that requires a tenant to obtain electricity from or through CPNZ or CPW to enable any tenant to obtain electricity from or through any electricity supplier;
- (d) CPNZ and CPW will use their best endeavours to provide such reasonable information that any tenant being supplied electricity by either CPNZ or CPW may request, to enable that tenant to assess competitive options available to it for the supply of electricity; and
- (e) Neither CPNZ nor CPW generates, or is interested in the generation of, electricity.

In addition, the commission, pursuant to section 81 of the Electricity Industry Reform Act 1998, exempts from the applications of sections 17, 18 and 30 of the Electricity Industry Reform Act 1998 any business or involvement or interest in relation only to any future property investment and management activities that CPNZ and CPW might undertake, and in respect of which sections 17, 18 and/or 30 would apply.

The exemption to any business or involvement or interest in respect of any future property investment and management activities that CPNZ or CPW might undertake is given subject to the following terms and conditions being fully observed by the business or involvement or interest to which the exemption applies:

- (a) The terms and conditions as set out above in relation to the exemption given to the cross-involved entities;
- (b) That CPNZ and/or CPW informs the commission of the details of any future property investment and/or management activity, within 20 working days (as that term is defined in the Commerce Act 1986) from the day following the day it undertakes the activity, that is likely to breach the Electricity Industry Reform Act 1998 and for which CPNZ, CPW and/or any other persons are likely to rely on this exemption.

I confer on Luke Thomas Jon Haddleton, while he holds office as an officer of the Government of the Dependency,

all the powers exercisable in New Zealand by a Justice of the Peace, and also the powers exercisable in New Zealand by a Coroner.

Luke Thomas Jon Haddleton is to exercise his functions at such places within the Dependency as may be directed by an officer of the Government of the Dependency who has the general executive and administrative authority in preserving Her Majesty's rights and sovereignty and the laws in force in the Dependency.

Requirements for Operation of an Uncertified Vehicle on an Annex B Conditional Permit From 1 April 2002

This notice applies to a vehicle to which section 6 of Land Transport Rule: Vehicle Standards Compliance 2002 ("the rule") applies, that has not been certified for entry or re-entry into service ("an uncertified vehicle"), and is to be operated under the conditions in 10.3 (1) and for the purposes in 10.4 of the rule.

Pursuant to subclauses 5.2 (1) and 9.4 (1) of the rule, I, David Robert Wright, Director of Land Transport Safety:

- (a) impose those requirements specified respectively in Schedules 1 and 2 of this notice as requirements for the Vehicle Safety Check inspection of light and heavy uncertified vehicles for operation on Annex B conditional permits under the rule from 1 April 2002;
- (b) specify, in Schedule 3 of this notice, the form and information required for the Annex B conditional permit from 1 April 2002;
- (c) specify, in Schedule 4 of this notice, the form and information required for the Annex A form that must be included in the Annex B conditional permit from 1 April 2002.

Schedule 1

Vehicle Safety Check Inspection Requirements—Light Vehicles ($GVM \le 3500kg$)

Item to be Checked	Inspection Requirements	Checked	Passed
Overall condition	Check the general condition of the vehicle visually. Check that there are no obvious signs that may indicate that the vehicle is unsafe.		
Steering system	Rotate the steering wheel back and forth quickly by 30 degrees about its straight-ahead position. In addition, for power steering, with the engine running, turn the steering wheel from lock to lock. There should be no abnormal noise, stiffness or looseness.		
Power steering	Check the power steering for correct fluid level and for leaks.		
Tyre pressure	Check all tyre pressures and set to manufacturer's recommended pressures.		
Tyre condition	Check that all road tyres have at least the minimum legal tread depth and that there are no cuts or bulges on tyre treads or sidewalls.		
Wheels and rims	Check that there is no wheel or rim damage that could affect safe operation of the vehicle.		
Lighting system	Check that all lights function correctly and that there are no broken lamp lenses. Check headlight aim if the vehicle is to be driven at night.		
Master cylinder and reservoir	Check for correct brake fluid level and for leaks.		
Brake pedal	Check that there is no excessive brake pedal travel or softness		
Brake hydraulic system	Check the system integrity by putting full pressure on the brake pedal with the engine running and hold this for 20 seconds. There should be no creep of the pedal and there should be a minimum of 20% brake-pedal travel before it contacts the floor or any stop.		
Service brakes (foot brake)	In a suitable location, check by driving the vehicle in a straight line on a level surface and lightly applying the foot brake. There should be no abnormal noise or knocking from the brakes, and no discernible pull on the steering wheel from the straight-ahead position. The vehicle should then be driven and the foot brake fully applied. Both front wheels should lock at the same time (unless ABS is fitted) and there should be no discernible deviation from the straight-ahead position.		

Parking brake	Check the parking (hand) brake for excessive travel. Check that it will stop the vehicle.	
Seatbelt condition	Check for each seatbelt fitted that the buckle fastens correctly, the webbing is not frayed and the anchorage bolts are secure.

The steering wheel should then be rotated back and forth quickly about its straight-ahead position (by about 30 degrees) with the vehicle stationary. There should be no knocking or looseness.

Tyre pressure and condition	Check that the tyre inflation is suitable for the journey. Check all road tyres for damage. Check that the tread depth is within legal requirements.

Brake hydraulic system and master cylinder (as applicable)	Check the system integrity by putting full pressure on the brake pedal with the engine running and hold this for 20 seconds. There should be no creep of the pedal and there should be a minimum of 20% brake-pedal travel before it contacts the floor or any stop. Check the brake master cylinder for correct brake fluid level and for leaks.		
Brake air system (as applicable)	Check brake pipes and fittings for air leaks and for damage. Check that the air-brake reservoir is clear of fluids (drain). Charge the air system by running the engine. With the engine stopped, apply the service brake fully 5 times. The low air pressure warning must not come on. Apply the service brake repeatedly until the low air pressure warning comes on. Start the engine and check that the full system pressure is achieved within reasonable time.
