- (e) One member who is or who has been a student of the UNITEC Institute of Technology elected by the students of the UNITEC Institute of Technology.
- (f) One member appointed by the council, after consultation with the relevant organisation of employers, from nominations from those employer organisations listed in the First Schedule to this notice.
- (g) One member appointed by the council, after consultation with the relevant organisation of workers, from nominations from those employee organisations listed in the Second Schedule to this notice.
- (h) No more than five members appointed by the council, after consultation with the professional bodies which are listed in the Third Schedule to this notice and which reflect the principal areas of teaching and research within the UNITEC Institute of Technology.
- (i) One member appointed by the council after consultation with the Māori Runanga of the UNITEC Institute of Technology.
- (j) No more than four members co-opted by the council, each of whom shall be appointed for such term, being not less than one year nor more than four years, as may be determined by the council at the time of their appointment.

4. Unless the council is satisfied that one or more of the members appointed in accordance with clauses 3 (a) to 3 (h) inclusive can give appropriate expression to the perspectives

of the Māori community, the council shall take the earliest opportunity to appoint a person so qualified in accordance with clause 3 (j), after consultation with the organisations listed in the Fourth Schedule to this notice.

5. Unless the council is satisfied that one or more of the members appointed in accordance with clauses 3 (a) to 3 (h) inclusive can give appropriate expression to the perspectives of the Pasifika community, the council shall, subject only to clause 4, take the earliest opportunity to appoint a person so qualified in accordance with clause 3 (j), after consultation with the Fono Faufautua of the UNITEC Institute of Technology.

6. Other than those persons appointed or elected pursuant to paragraphs (b), (c), (d) and (e) of clause 3 of this notice, no person who is a permanent member of staff of UNITEC Institute of Technology or who is a student of UNITEC Institute of Technology shall be eligible for election, appointment or co-option as a member of council.

- (iii) otherwise than at call (not being a special deposit).

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

3. Rates of Common Fund interest—(1) The rate of Common Fund interest payable on a deposit (other than an investment deposit repayable at the end of a fixed term) shall be that specified in Schedule 1 for the appropriate type of deposit.

(2) The rate of Common Fund interest payable on an investment deposit repayable at the end of a fixed term shall be that specified in Schedule 2 for the appropriate term and dollar range.

(3) Despite subparagraph (1), the rate of Common Fund interest payable on a deposit made pursuant to an enactment shall be the rate (if any) specified in the enactment.

In the event of any dispute arising between the grantee and the owner ("the parties") in respect of or in connection with the easements hereby granted and without prejudice to any other right or entitlement they may have under this notice or otherwise, the parties shall explore whether the dispute can be resolved by use of alternative dispute resolution technique or mediation.

The rules governing such technique shall be agreed between the parties or as recommended by the New Zealand Law Society or as selected by the Chairman of the New Zealand Chapter of LEADR (Lawyers Engaged in Alternative Dispute Resolution).

In the event the dispute is not resolved within 28 days of written notice by one party to the other of the dispute (or such further period agreed in writing between the parties), either party may refer the dispute to arbitration under the provisions of the Arbitration Act 1996 or any amendment or re-enactment of it.

The arbitrator shall be agreed between the parties within 10 days of written notice of the referral by the referring party to the other or failing agreement appointed by the President of the New Zealand Law Society and in either case the arbitrator shall not be a person who has participated in any formal dispute resolution procedure in respect of the dispute.
