#### **Electronic Register of Companies**

Pursuant to section 360 (4) of the Companies Act 1993, I advise that from 1 May 2002, the New Zealand Register of Companies ("the Register") will be kept as an electronic register.

The move to an electronic register is due to the implementation of the Personal Property Securities Register ("PPSR") on 1 May 2002. The implementation of this register will mean that company charges will no longer be registered on the New Zealand Register of Companies. The balance of the Register has been available for searching by electronic means for some years. Very little paper filing and physical searching of the Register now occurs. With the implementation of the PPSR, the opportunity has been taken to create consistency in the ability to search electronically.

The Register will be available to anyone who has access to the Internet or other direct network connections – either from a desktop PC or by visiting a district Companies Office or their local library to use an Internet based PC.

Information required to be registered on the Register can, from 1 May 2002, be registered by one of the following methods:

- (i) Directly by clients by using a "company key" (secure password) issued by the Registrar of Companies;
- (ii) Electronic filing of documents (for example annual returns);
- (iii) Filing of paper documents. Such documents will be entered on the Register by:
  - Being directly keyed into the Register by Companies Office staff from paper documents; and
  - Scanning images of all paper documents received in the Companies Office.

All paper files remain accessible upon request for those clients who need to conduct a search of historical company documents, including company charge documents.

#### The Public Trust Common Fund Interest Rates Notice 26 April 2002

The following notice is given pursuant to sections 50(1) and 50(5) of the Public Trust Act 2001 ("the Act").

#### Notice

**1. Title and commencement**—This notice may be cited as the Public Trust Common Fund Interest Rates Notice 26 April 2002.

(2) The determinations and revocation notified in this notice take effect from and including 20 April 2002.

**2. Interpretation**—(1) Unless the context otherwise requires:

- "agency deposit" means a deposit (not being an investment deposit) held as agent or attorney;
- "call deposit" means a deposit (not being an agency deposit, an investment deposit, a special deposit or a trust deposit) held in the ordinary course of administration, and determined by Public Trust to be held at call;
- "deposit" means a sum of money held by Public Trust belonging to any estate, which money for the time being forms part of the Common Fund;
- "investment deposit" means a deposit held at call or otherwise as an investment under section 51 of the Act;
- "special deposit" means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;
- "trust deposit" means a deposit held on trust:
  - (i) for persons not of full age or capacity; or
  - (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call (not being a special deposit).

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

**3. Rates of Common Fund interest**—(1) The rate of Common Fund interest payable on a deposit (other than an investment deposit repayable at the end of a fixed term) shall be that specified in Schedule 1 for the appropriate type of deposit.

(2) The rate of Common Fund interest payable on an investment deposit repayable at the end of a fixed term shall be that specified in Schedule 2 for the appropriate term and dollar range.

(3) Despite subparagraph (1), the rate of Common Fund interest payable on a deposit made pursuant to an enactment shall be the rate (if any) specified in the enactment.

(4) Despite subparagraph (1), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on a special deposit that is different from the rate specified in Schedule 1 and the agreed rate then applies.

#### 4. Revocation of notice and transitional provisions-

(1) The Public Trust Common Fund Interest Rates Notice 18 April 2002 is revoked.

# Bylaw Regulating the Speed of Vehicles in Part Time School Speed Zones

Pursuant to section 61 (3) of the Transit New Zealand Act 1989 and section 72 (1) (j) of the Transport Act 1962, Transit New Zealand hereby makes the following bylaw.

#### Bylaw

**1. Title and commencement**—This bylaw may be cited as the Transit New Zealand (Part Time School Speed Zones Bylaw) Bylaw 2002/16 and shall come into force 28 days after its publication in the *New Zealand Gazette*.

#### 2. Interpretation—In this bylaw:

- (a) "Vehicle" has the same meaning as in the Transport Act 1962.
- (b) "Part time speed limit" means the speed limit of 40 kilometres per hour, as shown by the part time speed limit signs displayed on the sections of State highway in the schedule below on school days between the hours of 8.25 a.m. and 9.00 a.m., and 2.50 p.m. and 3.15 p.m.
- (c) "Part time speed limit sign" means the 40 kilometres per hour speed limit sign which has a light emitting diode (LED) display for the steady 40 kilometres per hour legend and flashing yellow warning lights in each corner of the display.
- (d) "School days" means the days on which the schools adjacent to the sections of State highway in the schedule below are open for instruction.

**3.** The part time speed limit shall be in force when the steady state 40 kilometres per hour legend in the part time speed limit sign is illuminated and when the yellow corner warning lights are flashing on the sections of State highway described in the following schedule.

#### Schedule

**4.** The section of State Highway No. 74 that is on Main North Road in Christchurch City, from a point (Route Position 0/0.07) 100 metres generally in a north-easterly direction from the intersection with Swift Street extending a point (Route Position 0/0.49) located 170 metres generally in a south-westerly direction from the intersection with Lagan Street; a distance of approximately 420 metres.

**5.** The section of State Highway No. 75 that is on Halswell Road in Christchurch City, from a point (Route Position 0/6.04) 240 metres generally north-east of Larsens Road to a point (Route Position 0/6.44) 90 metres generally in a south-westerly direction from the intersection with O'Halloran Drive; a distance of approximately 400 metres.

#### Bylaw Regulating the Speed of Vehicles on State Highway No. 1, Ngauranga Gorge

Pursuant to section 61 (3) of the Transit New Zealand Act 1989 and section 72 (1) (j) of the Transport Act 1962, Transit New Zealand hereby makes the following bylaw.

#### Bylaw

**1. Title and commencement**—This bylaw may be cited as the Transit New Zealand (Ngauranga Gorge Variable Speed Limit) Bylaw 2002/2 and shall come into force 28 days after the date of its publication in the *New Zealand Gazette*.

2. Interpretation—In this bylaw:

- (a) "Variable speed limit" means the speed limit imposed from time to time by Transit New Zealand in accordance with this bylaw.
- (b) "Variable speed limit sign" means a sign which meets the criteria set out in or under the Traffic Regulations 1976.

(c) "Vehicle" has the same meaning as in the Land Transport Act 1998.

**3.** Discretion to impose variable speed limit—(1) Transit New Zealand may, from time to time, impose a variable speed limit for the section of State highway described in the Schedule to this bylaw if, in the opinion of Transit New Zealand, it is expedient to do so having regard to:

- (a) actual or likely traffic congestion or weather conditions; or
- (b) other actual or likely traffic hazards.

(2) A variable speed limit may apply to vehicles travelling in one or both directions and different variable speed limits may apply in respect of different directions.

**4. Variable speed limit**—(1) The variable speed limit imposed under clause 3:

- (a) must be a speed limit of 30, 40, 50, 60, 70, 80, 90 or 100 kilometres per hour;
- (b) must be indicated on one or more activated variable speed limit signs; and
- (c) applies whenever the variable speed limit signs are activated.

(2) For the purposes of this bylaw, a variable speed limit sign is activated whenever the numerals indicated on the sign are illuminated.

(3) Where no variable speed limit sign is activated for vehicles travelling in a particular direction on the section of State highway described in the Schedule, the speed limit is 100 kilometres per hour.

**5.** Limiting speed of vehicles on Ngauranga Gorge— No person shall drive or permit to be driven any vehicle at a speed exceeding the speed limit indicated on the last activated variable speed limit sign passed by that vehicle in the direction of travel of that vehicle on the section of State highway described in the Schedule to this bylaw.

#### Schedule

*Southbound*—the section of State Highway No. 1 that is the Ngauranga Gorge at Wellington commencing at Helston Road Bridge (Route Position 979/4.58) extending in a generally southerly direction to a point (Route Position 979/8.16) 270 metres south of the northern abutment of the Ngauranga Southbound Overbridge structure including the ramps and connections to and from the State highway; a distance of 3.6 kilometres.

*Northbound*—the section of State Highway No. 1 that is the Ngauranga Gorge at Wellington commencing at the North Island Main Trunk Railway Bridge (Route Position 979/7.33) extending in a generally northerly direction to a point (Route Position 979/4.51) 70 metres north of Helston Road Bridge, including the ramps and connections to and from the State highway; a distance of 2.8 kilometres.

Pursuant to section 61 (3) of the Transit New Zealand Act 1989 and section 72 (1) (j) of the Transport Act 1962, Transit New Zealand hereby makes the following bylaw:

#### Bylaw

**1. Title and commencement**—This bylaw may be cited as the Transit New Zealand (Speed of Vehicles on State Highways) Bylaw 2002/15 and shall come into force 28 days after its publication in the *New Zealand Gazette*.
