#### The Public Trust Common Fund Interest Rates Notice 16 May 2002

The following notice is given pursuant to sections 50 (1) and 50 (5) of the Public Trust Act 2001 ("the Act").

##### Notice

**1. Title and commencement**—This notice may be cited as the Public Trust Common Fund Interest Rates Notice 16 May 2002.

(2) The determinations and revocation notified in this notice take effect from and including 11 May 2002.

**2. Interpretation**—(1) Unless the context otherwise requires:

"agency deposit" means a deposit (not being an investment deposit) held as agent or attorney;

"call deposit" means a deposit (not being an agency deposit, an investment deposit, a special deposit or a trust deposit) held in the ordinary course of administration, and determined by Public Trust to be held at call;

"deposit" means a sum of money held by Public Trust belonging to any estate, which money for the time being forms part of the Common Fund;

"investment deposit" means a deposit held at call or otherwise as an investment under section 51 of the Act;

"special deposit" means a deposit held other than at call on behalf of the Crown, or any local authority within the meaning of the Local Government Act 1974;

"trust deposit" means a deposit held on trust:

- (i) for persons not of full age or capacity; or
- (ii) for beneficiaries not entitled to payment at call; or
- (iii) otherwise than at call (not being a special deposit).

(2) Expressions defined in the Act have the same meaning in this notice as they do in the Act.

**3. Rates of Common Fund interest**—(1) The rate of Common Fund interest payable on a deposit (other than an investment deposit repayable at the end of a fixed term) shall be that specified in Schedule 1 for the appropriate type of deposit.

(2) The rate of Common Fund interest payable on an investment deposit repayable at the end of a fixed term shall be that specified in Schedule 2 for the appropriate term and dollar range.

(3) Despite subparagraph (1), the rate of Common Fund interest payable on a deposit made pursuant to an enactment shall be the rate (if any) specified in the enactment.

(4) Despite subparagraph (1), in particular cases or classes of case, Public Trust and the depositor may agree on a rate of interest payable on a special deposit that is different from the rate specified in Schedule 1 and the agreed rate then applies.

#### 4. Revocation of notice and transitional provisions

(1) The Public Trust Common Fund Interest Rates Notice 9 May 2002 is revoked.

(2) The rates of interest specified in Schedule 1 to this notice do not apply to any period that ends with 10 May 2002 but otherwise operate as from 11 May 2002.

(3) The rates of interest specified in Schedule 2 to this notice:

- (i) do not apply to investment deposits repayable at the end of a fixed term that commenced prior to 11 May 2002; but
- (ii) do apply to investment deposits repayable at the end of a fixed term that commenced on or after 11 May 2002.

## Traffic Regulations 1976

### Traffic Signs—ATMS Auckland

Pursuant to Regulation 129 (6) of the Traffic Regulations 1976, and an instrument of sub-delegation by the Director of Land Transport dated 3 May 1999, I, Lyndon Bryan Hammond, Acting Manager Safer Roads, approve the erection, installation and maintenance of signs described in the Schedule to this notice installed as a component of the Advanced Traffic Management System applying on sections of State highway at Auckland, and subject to the conditions detailed in this notice.

#### Schedule

##### Variable Lane Control Signs

**1. General purpose of signs**—The use of a lane may be controlled by means of variable lane control signs that are installed above the lane and that display:

- a red diagonal cross, generally in the form shown in Diagram 1, indicating that the lane is not available to traffic travelling in the direction facing the sign; or
- a yellow downward facing arrow facing to the bottom left or bottom right corner of the sign, generally in the form of Diagram 2 or 3 respectively, indicating that drivers must, as soon as practicable, move to the adjacent lane to the left or right; or
- a yellow upward facing arrow facing to the top left or top right corner of the sign, generally in the form of Diagram 4 or 5 respectively, indicating drivers must leave the motorway in the direction shown at the first available exit point; or
- a blank display indicating to drivers that the lane is available for use.

##### 2. Description of signs—

- Shape and Size:* Rectangular at least 450mm high and 700mm wide.
- Background Colour:* Black.
- Border:* Black.
- Symbols:* Must be red or yellow, as appropriate, formed by the illumination of light emitting diodes.
- Additional Legend:* Circular lights in each corner of the sign, being yellow light emitting diodes, may flash to draw attention to the sign.

**3. Operating conditions**—The symbols must be displayed in accordance with the Auckland ATMS Operating Procedures Manual approved from time to time by the Chief Executive, Transit New Zealand.

##### Warning Signs—Variable Advisory Speed Signs

**1. General purpose of signs**—The variable advisory speed signs, generally in the form shown in Diagram 6, when displayed in accordance with the said Auckland ATMS Operating Procedures Manual, warn drivers of the need to adjust their speed to no more than that displayed on the sign due to conditions applying on the highway at that time.

##### 2. Description of signs—

- Shape and Size:* Rectangular at least 450mm high and 700mm wide.
- Background Colour:* Black.
- Legend:* The advisory speed value, in kilometres per hour, with numerals at least 350mm high shall be depicted by yellow light emitting diodes.
- Additional Legend:* Circular lights in each corner of the sign, being yellow light emitting diodes, may flash to draw attention to the sign.

**3. Operating conditions**—The procedures for determining which advisory speed value will be displayed at any time will be determined by protocols and strategies defined in the Auckland ATMS Operating Procedures Manual approved from time to time by the Chief Executive, Transit New Zealand.

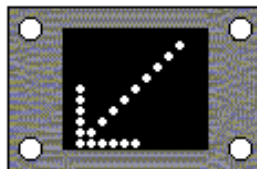

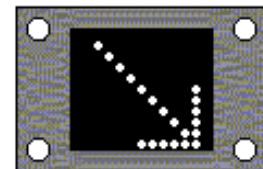
